Bill

Resumption of Second Reading debate, Committee stage and Third Reading

— Marriage (Amendment) Bill 2014 : Secretary for Security

The debate on the Second Reading of the above Bill, which was moved on 19 March 2014, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was negatived (details of division in the **Appendix**). As the motion for the Second Reading of the Bill was negatived, no further proceedings were taken on the Bill in accordance with Rule 54(8) of the Rules of Procedure.

Motion

Proposed resolution under section 54A of the Interpretation and General Clauses Ordinance

(During the debate on this motion, the meeting was suspended at 7:52 pm on 22 October and resumed at 9:00 am on 23 October 2014.)

The Secretary for Commerce and Economic Development moved the motion as set out on the Agenda. Hon CHAN Chi-chuen and Hon Albert CHAN had given separate notice to move 16 amendments to the motion respectively. The President proposed the question on the motion and ordered a joint debate on the motion and the amendments. The movers of the amendments and Members spoke in the debate.

When the meeting resumed at 9:00 am on 23 October 2014, Hon Gary FAN drew the attention of the President to the absence of a quorum. The President then directed the Members to be summoned.
