Bill

Resumption of Second Reading debate, Committee stage and Third Reading

 Competition (Amendment) Bill 2014 : Secretary for Commerce and Economic Development

The debate on the Second Reading of the above Bill, which was moved on 14 May 2014, resumed. After Members and the public officer had respectively spoken, the President's Deputy put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1, 2, 3, 6, 7, 9 to 14, 16 and 17 stand part of the Bill was proposed, put and agreed to.

The question that clauses 4, 5, 8 and 15 stand part of the Bill was proposed. The public officer moved amendments to clauses 4, 5, 8 and 15 and spoke on the amendments. The question on the amendments was put and agreed to. The question that clauses 4, 5, 8 and 15 as amended stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third

Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

Hon Dennis KWOK moved the motion as set out on the Agenda. The President's Deputy proposed and put the question on the motion. The motion was passed.
