Bills

First Reading and Second Reading

 Stamp Duty (Amendment) Bill 2014 : Secretary for Financial Services and the Treasury

After the above Bill was read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure, the public officer moved the Second Reading of the Bill. The President's Deputy proposed the question on the Second Reading of the Bill and referred the Bill to the House Committee in accordance with Rule 54(4) of the Rules of Procedure. The debate on the Bill was adjourned.

Resumption of Second Reading debate, Committee stage and Third Reading

 Administration of Justice (Miscellaneous : The Chief Secretary for Provisions) Bill 2014
Administration

The debate on the Second Reading of the above Bill, which was moved on 7 May 2014, resumed. After Members and the public officer had respectively spoken, the President's Deputy put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1, 2, 4 and 6 to 28 stand part of the Bill was proposed. After a Member had spoken, the Chairman's Deputy ordered a separate vote on clauses 6 to 9 upon Members' request.

The question that clauses 1, 2, 4 and 10 to 28 stand part of the Bill was put and agreed to. The question that clauses 6 to 9 stand part of the Bill was put and agreed to.

The question that clauses 3 and 5 stand part of the Bill was proposed. The public officer moved amendments to clauses 3 and 5 and spoke on the amendments. After a Member had spoken, the question on the amendments was put and agreed to. The question that clauses 3 and 5 as amended stand part of the Bill was proposed, put and agreed to.

New clause 3A was read the first time. The public officer moved the Second Reading of new clause 3A and spoke on the new clause. The Chairman's Deputy proposed and put the question on the Second Reading of new clause 3A. The question was agreed to. New clause 3A was read the second time. The public officer moved the addition of new clause 3A to the Bill. The question on the addition was proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to (details of division in **Appendix 1**). The Bill was read the third time and passed.

- Employment (Amendment) Bill 2014 : Secretary for Labour and Welfare

(During the Second Reading debate and Committee stage of the Bill, the meeting was suspended at 7:57 pm on 17 December and 2:43 pm on 18 December, and resumed at 9:00 am and 2:48 pm on 18 December 2014.)

The debate on the Second Reading of the above Bill, which was moved on 26 March 2014, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to (details of division in **Appendix 2**). The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1 to 5 and 7 to 18 stand part of the Bill was proposed, put and agreed to.

The question that clause 6 stand part of the Bill was proposed. The public officer moved amendments to clause 6 and spoke on the amendments. After Members had spoken, the question on the amendments was put and agreed to (details of division in **Appendix 3**).

Hon Andrew LEUNG moved a motion without notice to shorten the duration of the division bell for further divisions in respect of the clauses of or amendments to the Bill. The question was proposed, put and agreed to.

Hon Kenneth LEUNG moved his first amendment to clause 6. Hon LEE Cheuk-yan had also given notice to move his first amendment to clause 6. The Chairman ordered a joint debate on the relevant parts of the original clause and the amendments thereto. After Members and the pubic officer had respectively spoken, the following questions were put:

After Members and the public officer had respectively spoken, the question on Hon Kenneth LEUNG's second amendment was proposed, put and negatived (details of division in **Appendix 6**).

New clauses 6A, 6B and 7A were read the first time. Hon LEE Cheuk-yan moved his second amendment to clause 6. The Chairman ordered a joint debate on the relevant parts of the original clause and the amendment thereto, and the new clauses. After Members and the public officer had respectively spoken, the question on Hon LEE Cheuk-yan's second amendment was proposed, put and negatived (details of division in **Appendix 7**). As Hon LEE Cheuk-yan's second amendment was negatived, he could not move his third amendment to add new clauses 6A, 6B and 7A. The question that clause 6 as amended stand part of the Bill was put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The President proposed the question on the Third Reading of the Bill. After Members had spoken, the question on the Third Reading of the Bill was put and agreed to (details of division in **Appendix 8**). The Bill was read the third time and passed.

 Construction Workers Registration : Secretary for Development (Amendment) Bill 2014

The debate on the Second Reading of the above Bill, which was moved on 30 April 2014, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1 to 4, 9 to 22, 24, 25, 27 to 32, 34, 35 and 38 to 50 stand part of the Bill was proposed, put and agreed to.

The question that clauses 5 to 8, 23, 26, 33, 36 and 37 stand part of the Bill was proposed. The public officer moved amendments to clauses 5 to 8, 23, 26, 33, 36 and 37 and spoke on the amendments. The question on the amendments was put and agreed to. The question that clauses 5 to 8, 23, 26, 33, 36 and 37 as amended stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.
