Government Bills

First Reading and Second Reading

Inland Revenue (Amendment) (No. 3) : Secretary for Innovation and
 Bill 2018 : Technology

After the Bill was read the first time and ordered to be set down for Second Reading under RoP 53(3), the public officer moved the Second Reading of the Bill. The question on the Second Reading of the Bill was proposed and the debate was adjourned. The Bill was referred to the House Committee in accordance with RoP 54(4).

Second Reading (Debate to resume) and Consideration by Committee of the Whole Council

Appropriation Bill 2018 : Financial Secretary

(During the committee of the whole Council of the Bill, the meeting was suspended at 10:16 am on 3 May 2018 for holding the Chief Executive's Question and Answer Session. The meeting resumed at 12:01 pm on the same day.)

The debate on the Second Reading of the Bill, which was moved on 28 February 2018, resumed. After the Financial Secretary and other public officers had spoken, the question on the Second Reading of the Bill was put and agreed to (details of division in **Appendix 1**). The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. In accordance with RoP 68, the committee first considered the Schedule to the Bill. The question that the sums for the 38 heads as set out in the Official Record of Proceedings, to which no amendments were proposed stand part of the Schedule was proposed. The committee proceeded to the first session in which a joint debate on the 38 heads was held. After Members and a public officer had spoken, the question that the sums for the 38 heads stand part of the Schedule was put and agreed to (details of division in **Appendix 2**).

The committee proceeded to the second session in which a joint debate was held on the 67 amendments to the 46 heads as set out in the Official Record of Proceedings. The amendments included the Financial Secretary's two amendments seeking to increase the sums for two heads, and 65 amendments proposed by 14 Members seeking to reduce the various sums for 44 heads. Members and the Financial Secretary spoke on the amendments.

Next meeting

The Council resumed. The President declared that the next Council meeting would be held on 9 May 2018 at 11:00 am.

The Council was adjourned at 7:58 pm on 3 May 2018.
