Questions

Six oral questions as set out on the Agenda (i.e. Questions 1 to 6) were put by the Members and oral replies were given by the public officers.

Written replies to Questions 7 to 22 as set out on the Agenda were supplied to Members.

Request for moving a motion for the adjournment of the Council under RoP 16(2)

Hon AU Nok-hin rose to seek the President's permission for him to move a motion for the adjournment of the Council under RoP 16(2). After consideration, the President ruled that the motion might not be moved and explained to the Council the rationale for his decision.

Government Bills

First Reading and Second Reading

After the Bill was read the first time and ordered to be set down for Second Reading under RoP 53(3), the public officer moved the Second Reading of the Bill. Immediately after the question on the Second Reading of the Bill was proposed, Hon Gary FAN rose to seek the President's permission for him to move a motion under RoP 54(4) that the Second Reading debate on the Bill be not adjourned.

Request for moving a motion under RoP 54(4) that the Second Reading debate on the United Nations Sanctions (Amendment) Bill 2018 be not adjourned

After consideration, the President ruled that the motion might not be moved and explained to the Council the rationale for his decision.

The debate on the Second Reading of the Bill was then adjourned. The Bill was referred to the House Committee in accordance with RoP 54(4).

Second Reading (Debate to resume)

Guangzhou-Shenzhen-Hong Kong Express : Secretary for Transport and
 Rail Link (Co-location) Bill
 Housing

The debate on the Second Reading of the Bill, which was moved on 31 January 2018, resumed. After a Member had spoken, Hon Tanya CHAN moved a motion under RoP 40(1) that the debate on the Second Reading of the Bill be now adjourned.

Motion under RoP 40(1) that the Second Reading debate on the Guangzhou-Shenzhen-Hong Kong Express Rail Link (Co-location) Bill be now adjourned

The question on the motion was proposed. After Members had spoken, the question on the motion was put and not agreed to (details of division in the **Appendix**).

The Council continued the debate on the Second Reading of the Guangzhou-Shenzhen-Hong Kong Express Rail Link (Co-location) Bill. Members spoke in the debate. When the public officer was about to reply, some Members repeatedly raised points of order on the debate arrangement and disrupted the order of the meeting. Given that the order of the meeting was disrupted, the President suspended the meeting.

Upon the resumption of the meeting, the President announced that as the order of the meeting could not be restored, the Council be adjourned.

The President declared that the next Council meeting would be held on 13 June 2018 at 11:00 am.
