Administration's Responses to Points raised on 3 April 2001 by Members of the Bills Committee on the Chief Executive Election Bill

Election Committee (EC)

- Q1: The Administration should address the problem of overlapping membership of EC including making it a requirement that an ex-officio EC member who holds more than one EC seat has to relinquish the other seat, so that a subsector by-election can he held to return another candidate to fill that seat.
- A1: Overlapping membership in the EC may arise in any one of the following circumstances-
 - (a) a person who is concurrently a Member of the Legislative Council (LegCo) and a Hong Kong deputy to the National People's Congress (NPC); or
 - (b) a person who first acquires his EC membership through election by the relevant subsector or nomination by the religious subsector, and subsequently becomes an exofficio member by virtue of his election to the LegCo and/or NPC office.

Members accepted that since the two categories of membership under (a) are ex-officio in nature, little could be done about overlapping membership arising therefrom. Members, however, suggested that consideration should be given to instituting a mechanism to require EC members under (b) above to give up his elected or nominated membership, and to arrange a by-election or supplementary nomination to fill the vacancy arising therefrom.

Our proposal, as currently provided for in the Bill, is that members under (b) above may choose to give up their elected or nominated EC membership by tendering a resignation to the Electoral Registration Officer (ERO) under clause 3 of the Schedule to the Bill. Pursuant to clause 5 of the Schedule, the Electoral Affairs Commission will arrange for a subsector by-election or supplementary nomination to fill the vacancy. Under our proposed arrangement, the onus

is put on the EC member himself, leaving it to him to decide whether or not to relinquish his elected or nominated membership.

After careful examination, we agree that we should accept Members' suggestion because by requiring the relevant EC member to give up his elected or nominated membership and filling the vacancy arising therefrom by election or nomination, we will bring the number of EC members as close to 800 as possible. Indeed, this is in line with our proposed requirements under clause 17 of the Schedule that no candidate should be allowed to stand in the subsector ordinary election or by-election if he has other qualifying capacities to become an EC member (please refer to Q3 for more detailed explanation on clause 17 of the Schedule).

We, therefore, propose that once an elected or nominated EC member becomes an ex-officio member, he will be deemed to have resigned from his membership in the elected or nominated subsector. The vacancy will be filled, as provided for under clause 5 of the Schedule of the Bill, when the EC is called upon to elect a new CE or a LegCo Member in a by-election.

If the Bills Committee supports this proposal, the Administration will prepare the necessary legislative amendments and move an Administration CSA to give effect to the proposal during the resumption of the second reading of the Bill.

- Q2: Please advise on (a) the time required for constituting the EC under the Legislative Council (Amendment) Ordinance 1999; (b) the membership of the EC and whether there have been changes of membership since the EC was constituted; and (c) the number of EC members who voted in the 2000 LegCo election.
- A2: As regards (a), based on the experience of the EC formed last July, we estimate that it will take about 12 weeks to constitute a new EC, which involves a fresh round of subsector ordinary elections, including nominations, canvassing, polling, publication of the EC register and handling appeals.

As regards (b), a membership list of the EC when it was constituted in July 2000 is at Annex A. The Electoral Registration Officer (ERO) has since amended the register on two separate occasions to give effect to changes in the exofficio membership. The first such occasion took place shortly after the LegCo general elections held on 10 September 2000, as the ERO updated the EC register taking into account the membership of the second term LegCo. The gazette notice, setting out the changes made at the time, is at **Annex B**. The second occasion was after the LegCo Hong Kong Island by-election held on 10 December The EC register was updated to include the name of 2000. the newly elected LegCo Member. The relevant gazette notice is at **Annex C**.

As for (c), 748 EC members cast their ballots in the EC election held last September to return six Members to the second term LegCo.

Q3: Could the Administration explain the requirements in clause 17(3) of the Schedule to the Bill?

A3: Clause 17 of the Schedule seeks to set out the eligibility criteria for candidature at a subsector election.

Subclause (1) provides for the general eligibility criteria, such as the age requirement. This provision is a replica of section 13(1) of Schedule 2 to the Legislative Council Ordinance (Cap. 542).

Subclause (2), adapted from section 13(2) of Schedule 2 to the Legislative Council Ordinance, provides that a person is not eligible to be nominated as a candidate at a subsector ordinary election, if he is a nominee of the religious subsector, a Hong Kong deputy to the NPC or a Member of the LegCo. This is to debar a person who has other qualifying capacities to become a member of the EC from being nominated in the subsector ordinary election. In so doing, we can ensure that an elected candidate can claim no more than one seat on the EC at the time of its formation.

Subclause (3), drafted on the same principle as subclause 2, governs subsector by-elections. It provides that a person is not eligible to be nominated as a candidate in a subsector by-election if he is already an EC member or a nominee of the religious subsector (if the nomination for the religious subsector is to be held around the same time as the nomination for the subsector by-election).

Q4: Please respond to a Member's concern that since clause 8(1) which provides that a EC should be constituted for the purposes of this Bill is yet to be enacted, the legality of clause 8(3) might be in doubt.

A4: Clause 8(3) gives effect to the requirement in the Basic Law that the Election Committee to return six members to the second term Legislative Council under Annex II is the same Election Committee as that provided for in Annex I which is responsible for electing Chief Executive. The purposes for which the Election Committee is constituted are stipulated in clause 8(1). If enacted in its present form clause 8(3) will be consistent with the constitutional and legal requirements.

Polling Date

Q5: In relation to the determination of polling date for the CE election, please set out –

- (a) the pros and cons of the following options
 - (i) giving the CE a six-month flexible period as proposed by the CE Election Bill;
 - (ii) allowing limited discretion by adopting the formulation of "not later than certain days but not earlier than certain days from the date of expiry of the term of the serving CE"; and
 - (iii) fixing the polling date to a particular date before the date of expiry of the term of the serving CE;

- (b) whether the CE Election Bill should prescribe a minimum period before which the CE has to announce the polling date;
- (c) whether the CE Election Bill should set out the criteria which the CE should take into account when determining the polling date; and
- (d) whether clause 12 should be revised to provide certainty as to when a notice on polling date is published in the Gazette.
- A5: There are two broad options, namely, (i) stipulating a period within which the CE can appoint one day as the polling date or (ii) prescribing a fixed polling date or a formula for determining the polling date.

(I) A date within a period

The proposal embodied in the CE Election Bill is that the CE shall appoint a date within the six months before the expiry of his term as the polling date. This has the merit of giving more flexibility to the CE to choose a suitable polling date. However, some Members are concerned that this arrangement may give an incumbent CE seeking re-election an added advantage of appointing a polling date to his favour or to the disadvantage of his opponents.

It should be noted that the proposed approach is adopted by many overseas countries. France and Brazil are notable examples. In France, the presidential election must be held not less than 20 days and not more than 35 days before the expiry of term of the serving president. In Brazil this range is longer, extended to within 90 days before the expiry of term of the serving president.

In Hong Kong, this is also the case for Legislative Council (LegCo) and District Councils (DCs) elections. For LegCo general elections, the CE can appoint a polling date which is not earlier than 60 days and not later than 15 days before the new term of LegCo is to begin. The same formulation is also adopted for DCs

ordinary election (i.e. not earlier than 60 days and not later than 15 days before the new term of the DC members is to begin).

The key consideration here is the reasonableness of the period proposed. Our proposal in the CE Election Bill of providing a flexibility of six months to the CE is made on the basis of the BL 53 requirement that, in the event that the office of the CE falls vacant, a new CE shall be selected within six months.

(II) Fixed date or Formula

While agreeing that the above approach leaves room for flexibility, Members are concerned that this might be perceived as giving an unfair advantage to an incumbent CE seeking re-election. We acknowledge that Members' concern is legitimate and see merit in prescribing a formula for fixing the polling date as this arrangement will ensure certainty and eliminate any perceived possibility of unfairness.

A viable formulation is to fix the polling date on a date which can be calculated by counting backwards from the date when the term of a serving CE expires. Details of our proposal are set out below.

(a) Normal expiry of five-year term

We suggest that clause 10(1) of the CE Election Bill be amended so that the polling date –

"...shall be -

- (a) where the first day of the period of 90 days expiring at the beginning of the day on which the vacancy will arise is a Thursday, that Thursday; or
- (b) where the first day of the period of 90 days expiring at the beginning of the day on which the vacancy will arise is not a Thursday, the Thursday immediately preceding the commencement of that period.".

Using the 2002 CE election as an example, the result will be as follows –

The day on which vacancy arises	1 July 2002
The first day of the 90-day period expiring at the beginning of the day on which vacancy arises	2 April 2002
Is it a Thursday?	No
What is the immediately preceding Thursday?	28 March 2002

Our proposal is made having regard to the time that is reasonably required for settling election petition, for the Central People's Government (CPG) to make the appointment and for putting in place necessary transitional arrangements.

(b) Vacancy of the Office of the CE

In the event that the office of the CE falls vacant, we propose that clause 10(3) of the CE Election Bill be amended so that the polling date –

- "... shall be –
- (a) where the 120th day after the day on which the office becomes vacant is a Thursday, that Thursday; or
- (b) where the 120th day after the day on which the office becomes vacant is not a Thursday, the Thursday immediately following the first-mentioned day.".

The 120-day period is arrived at having regard to the following –

(a) around twelve weeks for updating the Election

Committee (EC) and organizing by-election or supplementary nomination, if necessary; and

(b) five weeks for nomination and canvassing of the CE election which are mandatory under the CE Election Bill (Clause 15).

This will leave about two months for settling election petition (if any), for the CPG to make the appointment and for putting in place necessary transitional arrangements. The whole process is in line with the requirement of Article 53 of the Basic Law which provides that a new CE must be selected within six months in the event of vacancy.

(III) Way forward

If the Bills Committee supports the proposal of adopting a fixed formula for determining the polling date of the CE election as explained above, the questions of announcing the polling date before a prescribed period and of stipulating a set of criteria for the CE to follow in the publication of polling date will become redundant.

If the Bills Committee supports our proposal, the Administration will prepare the necessary legislative amendments and move an Administration CSA to give effect to the proposal during the resumption of the second reading of the Bill.
