At 7:40 pm, while Hon IP Kwok-him was speaking, the President resumed the chair.

Another seven Members spoke on the Bill.

Hon Michael MAK declared his interest as an employee of the Hospital Authority and spoke on the Bill.

Six other Members spoke on the Bill.

Hon LEUNG Yiu-chung declared his interest as an employee of a Government-subvented organization and spoke on the Bill.

Another two Members spoke on the Bill.

The President suspended the meeting at 10:25 pm.

Question on the Second Reading put.

Hon LAU Chin-shek claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that 59 Members were present, 31 were in favour of the motion and 27 against it. (Voting record in Appendix 1.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Public** Officers Pay Adjustment Bill.

Question that clauses 1, 3 and 5 to 8 stand part of the Bill proposed, put and agreed to.

Question that clauses 2, 4 and 9 stand part of the Bill proposed.

The Secretary for the Civil Service moved amendments to the aforesaid clauses and addressed the Committee.

Three Members spoke on the amendments.

Question on the amendments put and agreed to.

Question that clauses 2, 4 and 9, as amended, stand part of the Bill proposed, put and agreed to.

Question that the heading before clause 10, clauses 10 and 11 stand part of the Bill proposed.

Council resumed by order of the Chairman. The President then granted leave for the Secretary for the Civil Service to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(5) and 58(7) of the Rules of Procedure in order that the Committee of the whole Council could consider new clause 2A and schedule 3 together with the heading before clause 10, clauses 10 and 11 of the Bill.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New clause 2A read the first time.

The Secretary for the Civil Service moved the Second Reading of new clause 2A and addressed the Committee.

Question on the Second Reading of new clause 2A proposed.

A Member and the Secretary for the Civil Service spoke on the motion.

Question on the Second Reading of new clause 2A put and agreed to.

New clause 2A read the second time.

Question that schedule 3 stand part of the Bill proposed.

The Secretary for the Civil Service moved the addition of new clause 2A to the Bill, and the deletion of the heading before clause 10, clauses 10 and 11 and schedule 3 from the bill and addressed the Committee.

Question on the amendments put and agreed to.

The Chairman stated that as the amendments to the heading before clause 10, clauses 10 and 11 and schedule 3, which dealt with deletions, had been agreed, the heading before clause 10, clauses 10 and 11 and schedule 3 were therefore deleted from the Bill.

Question that schedules 1 and 2 stand part of the Bill proposed, put and agreed to.

Question that the long title stand part of the Bill proposed.

The Secretary for the Civil Service moved amendments to the long title and addressed the Committee.

Question on the amendments put and agreed to.

The Council then resumed.

Third Reading

The Secretary for the Civil Service reported that

the Public Officers Pay Adjustment Bill

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed and put.

Hon LAU Chin-shek claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that 59 Members were present, 32 were in favour of the motion and 26 against it. (Voting record in Appendix 2.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Bill read the third time and passed.

Drug Trafficking and Organized Crimes (Amendment) Bill 2000

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 1 November 2000 resumed.

Hon James TO, Chairman of the Bills Committee on Drug Trafficking and Organized Crimes (Amendment) Bill 2000, addressed the Council on the Report of the Bills Committee on the Bill.

Four Members spoke on the Bill.

The Secretary for Security replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Drug Trafficking and Organized Crimes (Amendment) Bill 2000**.

Question that clauses 1 to 4 stand part of the Bill proposed, put and agreed to.

Council resumed by order of the Chairman. The President then granted leave for the Secretary for Security to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(5) and 58(7) of the Rules of Procedure in order that the Committee of the whole Council could consider schedules ahead of the new clause, and the new schedule together with the new clause.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

Question that schedules 1, 2 and 3 stand part of the Bill proposed.

The Secretary for Security moved amendments to schedules 1, 2 and 3 and addressed the Committee.

Question on the amendments put and agreed to.

Question that schedules 1, 2 and 3, as amended, stand part of the Bill proposed, put and agreed to.

New clause 5 and new schedule 4 read the first time.

The Secretary for Security moved the Second Reading of the aforesaid new clause and new schedule and addressed the Committee.

Question on the Second Reading of the aforesaid new clause and new schedule proposed.

A Member spoke on the motion.

Question on the Second Reading of the aforesaid new clause and new schedule put and agreed to.

New clause 5 and new schedule 4 read the second time.

The Secretary for Security moved the addition of the aforesaid new clause and new schedule to the Bill.

Question on the addition proposed, put and agreed to.

Question that the long title stand part of the Bill proposed.

The Secretary for Security moved an amendment to the long title and addressed the Committee.

A Member spoke on the amendment.

Question on the amendment put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Security reported that

the Drug Trafficking and Organized Crimes (Amendment) Bill 2000

had passed through the Committee with amendments. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

United Nations (Anti-Terrorism Measures) Bill

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 17 April 2002 resumed.

Hon LAU Kong-wah, Chairman of the Bills Committee on United Nations (Anti-Terrorism Measures) Bill, addressed the Council on the Report of the Bills Committee on the Bill.

Three Members and Hon Audrey EU spoke on the Bill.

While Hon Audrey EU was speaking, the President left the chair at 1:47 pm temporarily and the President's Deputy, Hon Mrs Selina CHOW, took the chair.

Another four Members and Dr Hon YEUNG Sum spoke on the Bill.

At 2:35 pm, while Dr Hon YEUNG Sum was speaking, the President resumed the chair.

Five further Members spoke on the Bill.

The Secretary for Security replied.

Question on the Second Reading put.

Hon Emily LAU claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that 50 Members were present, 31 were in favour of the motion and 18 against it. (Voting record in Appendix 3.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **United**Nations (Anti-Terrorism Measures) Bill.

Question that clauses 1 and 3 stand part of the Bill proposed, put and agreed to.

Question that clause 2 stand part of the Bill proposed.

The Chairman stated that the Secretary for Security, Hon Audrey EU and Hon Margaret NG had separately given notice to move amendments to the definition of "terrorist act" in clause 2 of the bill. She ordered that the proposed amendments be debated together in a joint debate.

The Chairman invited the Secretary for Security to move her amendment first.

The Secretary for Security moved an amendment to the definition of "terrorist act" in clause 2 and addressed the Committee.

Hon Audrey EU and Hon Margaret NG spoke on the Secretary for Security's amendment as well as their own proposed amendments.

Two Members spoke on the amendment and the proposed amendments.

The Secretary for Security spoke again.

A Member who had spoken and another Member spoke on the amendment and the proposed amendments.

Question on the amendment moved by the Secretary for Security put.

Hon Margaret NG claimed a division. The Chairman then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that 49 Members were present, 31 were in favour of the amendment and 17 against it. (Voting record in Appendix 4.) Since the question was agreed by a majority of the Members present, she declared that the amendment was agreed.

Hon Mrs Selina CHOW rose to move the following motion without notice:

That in the event of further divisions being claimed in respect of the remaining motions to be moved at the Committee Stage of the United Nations (Anti-Terrorism Measures) Bill at this meeting, Rule 47(1)(c) of the Rules of Procedure be suspended so that the Chairman may order that the Committee do proceed to each of such divisions immediately after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

The Chairman stated that as the Secretary for Security's amendment had been passed, Hon Audrey EU and Hon Margaret NG

might not move their respective amendments to the definition of "terrorist act" in clause 2 which were inconsistent with the decision already taken.

Hon Margaret NG moved an amendment to the definition of "terrorist property" in clause 2 and addressed the Committee.

The Secretary for Security spoke on the amendment.

Hon Margaret NG spoke again.

Question on the amendment put.

Hon Margaret NG claimed a division. The Chairman then ordered the Committee to divide under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 25 were present, five were in favour of the amendment and 20 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 22 were present, 12 were in favour of the amendment and nine against it. (Voting record in Appendix 5.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

The Secretary for Security moved the deletion of the definitions of "authorized officer" and "property" from; addition of the definitions of "Committee", "items subject to legal privilege" and "prescribed interest" and subclauses (4) and (5) to; and amendments to the definitions of "funds", "terrorist associate" and "weapons" in clause 2 and addressed the Committee.

Three Members spoke on the amendments.

Question on the amendments put and agreed to.

Question that clause 4 stand part of the Bill proposed.

The Chairman stated that the Secretary for Security and Hon Margaret NG had separately given notice to move amendments to clause 4 of the Bill. She ordered that the amendments be debated together in a joint debate.

The Chairman invited the Secretary for Security to move her amendment first.

The Secretary for Security moved an amendment to clause 4 and addressed the Committee.

Hon Margaret NG spoke on the Secretary for Security's amendment as well as her own proposed amendment.

Three Members spoke on the amendment and the proposed amendment.

The Secretary for Security spoke again.

Question on the amendment moved by the Secretary for Security put.

Question on the motion put and agreed to.

Proposed resolution under the Pharmacy and Poisons Ordinance

The Secretary for Health, Welfare and Food moved the following motion and addressed the Council:

Resolved that -

- (a) the Pharmacy and Poisons (Amendment)(No. 3) Regulation 2002; and
- (b) the Poisons List (Amendment) (No. 3) Regulation 2002,

made by the Pharmacy and Poisons Board on 17 June 2002, be approved.

Question on the motion proposed, put and agreed to.

Members' Bills

Second Reading

CITIC Ka Wah Bank Limited (Merger) Bill

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 29 May 2002 resumed.

A Member and the Secretary for Financial Services and the Treasury spoke on the Bill.

Dr Hon David LI replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the CITIC Ka Wah Bank Limited (Merger) Bill.

Question that clauses 1 to 19 stand part of the Bill proposed.

A Member spoke on the motion.

Question that clauses 1 to 19 stand part of the Bill put and agreed to.

Question about the preamble to the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

Dr Hon David LI reported that

the CITIC Ka Wah Bank Limited (Merger) Bill

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Members' Motions

Alleviating the hardship of negative-equity property owners

Hon Albert CHAN moved the following motion and addressed the Council:

That, whereas Hong Kong's economy has continued to be in the doldrums since the onset of the Asian financial turmoil, with

the unemployment rate rising continuously, suicide cases occurring repeatedly, and many negative-equity property owners under severe pressure, the Government has not been doing its best to assist such persons, this Council urges the Government to expeditiously formulate effective measures to help negative-equity property owners tide over their difficulties, and to call on the banking sector, real estate developers and social service organizations to actively assist these people in relieving their pressure; this Council also hopes that negative-equity property owners will bravely face up to the adversity and cherish their precious lives.

Question on Hon Albert CHAN's motion proposed.

The President stated that Hon CHAN Kam-lam and Hon Howard YOUNG would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the two amendments would be debated together in a joint debate.

Hon CHAN Kam-lam and Hon Howard YOUNG spoke respectively on the motion and their amendments.

Seven Members spoke on the motion and the amendments.

Hon Albert CHAN spoke on the amendments.

The Secretary for Financial Services and the Treasury spoke on the motion and the amendments.

Hon CHAN Kam-lam moved the following amendment to Hon Albert CHAN's motion:

To delete "whereas" after "That,", and substitute with "as"; to delete "the Government has not been doing its best to assist such persons," after "and many negative-equity property owners under severe pressure,"; to add "with the Hong Kong Housing Society" after "this Council urges the Government to expeditiously formulate"; to add "such as setting up a secondary market for the Sandwich Class Housing Scheme and deferring the repayment period of the second mortgage loan under the Scheme," after "effective measures to help negative-equity property owners tide over their difficulties,"; to add ", the Hong Kong Mortgage Corporation Limited" after "and to call on the banking sector, real estate developers"; and to delete "these people" after "and social service organizations to actively assist", and substitute with "negative-equity property owners".

Question on Hon CHAN Kam-lam's amendment to Hon Albert CHAN's motion proposed and put.

Hon Albert CHAN claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, 17 were in favour of the amendment and five against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 24 were present, eight were in favour of the amendment, 14 against it and one abstained. (Voting record in Appendix 24.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Howard YOUNG moved the following amendment to Hon Albert CHAN's motion:

To add "the Hong Kong Monetary Authority, the Hong Kong Mortgage Corporation Limited, the Hong Kong Housing Society," after "and to call on the banking sector,".

Question on Hon Howard YOUNG's amendment to Hon Albert CHAN's motion proposed and put.

Hon Howard YOUNG claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, 13 were in favour of the amendment and nine against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 24 were present, 22 were in favour of the amendment and one against it. (Voting record in Appendix 25.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was agreed.

Hon Albert CHAN replied.

Question on Hon Albert CHAN's motion as amended by Hon Howard YOUNG put and agreed to.

Giving priority to employment

Hon CHEUNG Man-kwong moved the following motion and addressed the Council:

That, with the implementation of the accountability system, this Council requests Tung Chee-hwa's Administration to accord priority, in the next five years, to tackling the serious problem of unemployment and lowering the unemployment rate, and to adopt "achieving full employment" as an important indicator for determining whether the implementation of his policies is successful or not.

While Hon CHEUNG Man-kwong was addressing the Council, the President left the chair at 4:02 pm temporarily and the President's Deputy, Hon Fred LI, took the chair.

Question on Hon CHEUNG Man-kwong's motion proposed.

The President's Deputy stated that Hon Tommy CHEUNG would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon Tommy CHEUNG moved the following amendment to Hon CHEUNG Man-kwong's motion and addressed the Council:

To delete "Tung Chee-hwa's Administration" after "That, with the implementation of the accountability system, this Council requests", and substitute with "the relevant policy bureaux of the Government"; to delete "indicator" after "and to adopt 'achieving full employment' as an important", and substitute with "objective"; to delete "determining whether" after "for"; to delete "his" after "the implementation of"; and to delete "is successful or not" after "policies".

Question on Hon Tommy CHEUNG's amendment to Hon CHEUNG Man-kwong's motion proposed.

12 Members and Hon Michael MAK spoke on the motion and the amendment.

At 5:45 pm, while Hon Michael MAK was speaking, the President resumed the chair.

Another nine Members spoke on the motion and the amendment.

Hon CHEUNG Man-kwong spoke on the amendment.

The Secretary for Economic Development and Labour spoke on the motion and the amendment.

Question on Hon Tommy CHEUNG's amendment to Hon CHEUNG Man-kwong's motion put.

Hon CHEUNG Man-kwong claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 24 were present, 20 were in favour of the amendment and four against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 23 were present, 11 were in favour of the amendment and 11 against it. (Voting record in Appendix 26.) Since the question was not agreed by a

majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon CHEUNG Man-kwong replied.

Question on Hon CHEUNG Man-kwong's motion put.

Hon CHEUNG Man-kwong claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 24 were present, four were in favour of the motion, 17 against it and three abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 23 were present, 12 were in favour of the motion and 10 against it. (Voting record in Appendix 27.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.

End of session

The President wished Members a happy and relaxing summer recess. She stated that subject to Chief Executive's publication in the gazette that the 2002/2003 session would commence in October 2002, the first meeting of the Council for that session would be held on 9 October 2002 at 2:30 pm.

The Council was adjourned at 7:11 pm.
