## **District Councils Review**

Thank you for your letter of 28 March 2002.

After the Executive Council approved recommendations arising from the District Councils Review (DC Review) to enhance the roles and functions of DCs in November 2001, actions have been taken by relevant government departments to implement these recommendations. On 4 January 2002, the Director of Leisure and Cultural Services (DLCS) wrote to all DC Chairmen setting out the measures to be taken in implementing the relevant recommendations made in the report of the DC Review, including the consultation with DCs on the usage and management of district leisure/cultural facilities performance of the Leisure and Cultural Services Department's (LCSD) service contractors. In fact, the respective DCs have each established a committee to advise on the usage and management of district-based cultural and leisure facilities such as indoor games halls, parks, swimming pools, beaches, local libraries. A list of the committees is attached at the Annex.

LCSD's District Leisure Manager of the respective district, and the Senior Manager (Cultural Services) of the respective regional office attend the meetings of DC and/or the relevant committees to answer members' enquiries about LCSD's services. To facilitate DC members' discussions, bi-monthly reports on the usage of district-based cultural and leisure facilities, and the participation/attendance rates of the district recreational and cultural activities organised are submitted to DCs and/or the relevant committees. LCSD will also gradually expand and incorporate the following information in the bi-monthly report for DC members' advice:

- (a) matters relating to district recreational facilities, such as contracting-out/management of carparks at leisure venues, cleansing of venues and improvement projects;
- (b) services and facilities provided in district-based civic centres and libraries, public opinion survey results and improvement projects;
- (c) applications of district arts organisations for free use of cultural venues for organising district cultural activities;
- (d) views of the Customer Liaison Groups of the district venues; and
- (e) the service and performance of LCSD's contractors.

Starting from 2002-03, LCSD will also consult the DCs on the proposed annual programme of district recreational and cultural activities before finalising the programme.

To enhance communication with the DCs, DLCS will hold meetings with Chairmen and Vice-chairmen of DCs and the relevant committees on a half-yearly basis to collect their views on the work of the department. The progress of implementation of the recommendations arising from DC Review will be discussed at the next meeting around May to collect DC members' feedback.

The Home Affairs Bureau and Home Affairs Department will closely monitor the progress to ensure all recommendations arising from the DC Review are properly implemented.
