- (v) by repealing everything opposite the reference to regulation 4(1)(e) and substituting---
- "Chapter 2.4.7 of Part 1, Chapter 7.9 of Part 2, Part 4, and Chapters 1.1 (paragraphs
- (d) to (j)), 1.2, 1.3, 1.6, 1.7, 1.8, 4.1.9.3, 4.3 and 4.4 of Part 5.";
