Second Reading

Juvenile Offenders (Amendment) Bill 2001

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 14 November 2001 resumed.

Hon Margaret NG, Chairman of the Bills Committee on Juvenile Offenders (Amendment) Bill 2001, addressed the Council on the Report of the Bills Committee on the Bill. After the address, she spoke on the Bill in her personal capacity as a Member.

Another seven Members spoke on the Bill.

The Secretary for Security replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the **Juvenile** Offenders (Amendment) Bill 2001.

Question that clause 1 stand part of the Bill proposed, put and agreed to.

Question that clauses 2, 3 and 4 stand part of the Bill proposed.

Hon Margaret NG moved amendments to the aforesaid clauses and addressed the Committee.

Five Members and the Secretary of Security spoke on the amendments.

Hon Margaret NG spoke again.

Question on the amendments put.

Hon Margaret NG claimed a division. The Chairman then ordered the Committee to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 21 were present, six were in favour of the amendments, 10 against them and five abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 22 were present, 14 were in favour of the amendments and seven against them. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendments were negatived.

Question that clauses 2, 3 and 4 stand part of the Bill put and agreed to.

New clauses 2A and 3A read the first time.

The Secretary for Security moved the Second Reading of the aforesaid clauses and addressed the Committee.

Question on the Second Reading of the aforesaid clauses proposed, put and agreed to.

New clauses 2A and 3A read the second time.

The Secretary for Security moved the addition of the aforesaid clauses to the Bill.

Question on the addition proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Security reported that

the Juvenile Offenders (Amendment) Bill 2001

had passed through the Committee with amendments. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Fire Services (Amendment) Bill 2001

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 4 July 2001 resumed.

Hon IP Kwok-him, Chairman of the Bills Committee on Fire Services (Amendment) Bill 2001, addressed the Council on the Report of the Bills Committee on the Bill. After the address, he spoke on the Bill in his personal capacity as a Member.

Another Member spoke on the Bill.

The Secretary for Security replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the Fire Services (Amendment) Bill 2001.

Question that clauses 1, 2, 6 to 9, 11 to 19 and 23 to 27 stand part of the Bill proposed, put and agreed to.

Question that clauses 3, 4, 5, 10, 20, 21 and 22 stand part of the Bill proposed.

The Secretary for Security moved amendments to the aforesaid clauses and addressed the Committee.

Question on the amendments put and agreed to.

Question that clauses 3, 4, 5, 10, 20, 21 and 22, as amended, stand part of the Bill proposed, put and agreed to.

New clause 3A, the new heading before new clause 22A and new clause 22A read the first time.

The Secretary for Security moved the Second Reading of the aforesaid heading and clauses and addressed the Committee.

Question on the Second Reading of the aforesaid heading and clauses proposed, put and agreed to.

New clause 3A, the new heading before new clause 22A and new clause 22A read the second time.

The Secretary for Security moved the addition of the aforesaid heading and clauses to the Bill.

Question on the addition proposed, put and agreed to.

Question that the schedule stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Security reported that

the Fire Services (Amendment) Bill 2001

had passed through the Committee with amendments. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Members' Bills

First Reading

The Bank of East Asia, Limited (Merger of Subsidiaries) Bill

The Bill was read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

The President stated that as The Bank of East Asia, Limited (Merger of Subsidiaries) Bill presented by Hon NG Leung-sing related to Government policies, in accordance with Rule 54(1) of the Rules of Procedure, the signification of the written consent of the Chief Executive by the Secretary for Financial Services and the Treasury was required before the Council entered upon consideration of the second reading of the Bill.

The Secretary for Financial Services and the Treasury confirmed that the Chief Executive had given his written consent for The Bank of East Asia, Limited (Merger of Subsidiaries) Bill to be introduced into this Council.

Second Reading

The Bank of East Asia, Limited (Merger of Subsidiaries) Bill

Hon NG Leung-sing moved the Second Reading and addressed the Council.

Question on the Second Reading proposed. The President stated that in accordance with Rule $54\,(4)$ of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Hon Margaret NG moved the following motion and addressed the Council:

Resolved that in relation to the -

- (b) Trade Marks Ordinance (Cap. 559) (Commencement) Notice 2003, published in the Gazette as Legal Notice No. 31 of 2003,

and laid on the table of the Legislative Council on 12 February 2003, the period for amending subsidiary legislation referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) be extended under section 34(4) of that Ordinance to the meeting of 2 April 2003.

Question on the motion proposed, put and agreed to.

<u>Proposed resolution under the Interpretation and General</u> <u>Clauses Ordinance</u>

Hon Kenneth TING moved the following motion and addressed the Council:

Resolved that in relation to the -

- (a) Import and Export (General) (Amendment) Regulation 2003, published in the Gazette as Legal Notice No. 32 of 2003;
- (b) Import and Export (Registration) (Amendment) Regulation 2003, published in the Gazette as Legal Notice No. 33 of 2003;
- (c) Import and Export (Removal of Articles) (Amendment)
 Regulation 2003, published in the Gazette as Legal
 Notice No. 34 of 2003;
- (d) Reserved Commodities (Control of Imports, Exports and Reserve Stocks) (Amendment) Regulation 2003, published in the Gazette as Legal Notice No. 35 of 2003;
- (e) Dutiable Commodities (Amendment) Ordinance 2001 (19 of 2001) (Commencement) Notice 2003, published in the Gazette as Legal Notice No. 39 of 2003; and

(f) Import and Export (Electronic Transactions) Ordinance 2002 (24 of 2002) (Commencement) Notice 2003, published in the Gazette as Legal Notice No. 40 of 2003,

and laid on the table of the Legislative Council on 19 February 2003, the period for amending subsidiary legislation referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) be extended under section 34(4) of that Ordinance to the meeting of 9 April 2003.

Question on the motion proposed, put and agreed to.

Medical fee waiver mechanism

Hon Frederick FUNG moved the following motion and addressed the Council:

That, as the Government will introduce very shortly a new charging scheme for public health care services and, in parallel, enhance the existing medical fee waiver mechanism, this Council urges the Government to relax the eligibility criteria under the mechanism so as to benefit more people from the socially disadvantaged groups, such as elderly persons, low-income earners and chronic patients.

While Hon Frederick FUNG was addressing the Council, the President left the chair at 7:15 pm temporarily and the President's Deputy, Hon Mrs Selina CHOW, took the chair.

Question on Hon Frederick FUNG's motion proposed.

The President's Deputy stated that Hon YEUNG Yiu-chung would move an amendment to the motion and that Dr Hon LAW Chi-kwong and Hon LEUNG Yiu-chung would each move an amendment to Hon YEUNG Yiu-chung's amendment. In accordance with the Rules of Procedure, the motion, the amendment and the amendments to the amendment would be debated together in a joint debate.

Hon YEUNG Yiu-chung moved the following amendment to Hon Frederick FUNG's motion and addressed the Council:

To add ", including relaxing the asset-assessment criteria for unsupported elderly persons, and to extend the maximum feewaiver period for chronic patients from six months to one year," after "this Council urges the Government to relax the eligibility criteria under the mechanism".

Question on Hon YEUNG Yiu-chung's amendment to Hon Frederick FUNG's motion proposed.

Dr Hon LAW Chi-kwong and Hon LEUNG Yiu-chung spoke on the motion and the amendments.

9 Members spoke on the motion and the amendments.

Hon WONG Sing-chi declared an interest that his wife was a chronic patient and spoke on the motion and the amendments.

Hon Ng Leung-sing spoke on the motion and the amendments.

At 8:35 pm, while Hon NG Leung-sing was speaking, the President resumed the chair.

Another two Members spoke on the motion and the amendments.

Hon Frederick FUNG spoke on the amendments.

The Secretary for Health, Welfare and Food spoke on the motion and the amendments.

Dr Hon LAW Chi-kwong moved the following amendment to Hon YEUNG Yiu-chung's amendment:

To add "providing half-fee concessions for all elderly persons, and" after "this Council urges the Government to relax the eligibility criteria under the mechanism, including"; to add "to apply for a higher fee waiver" after "relaxing the asset-assessment criteria for unsupported elderly persons"; to add "exempt patients on disability allowance from payment of medical fees and charges and" after ", and to"; and to add "other" after "extend the maximum feewaiver period for".

Question on Dr Hon LAW Chi-kwong's amendment to Hon YEUNG Yiu-chung's amendment proposed and put.

Hon YEUNG Yiu-chung claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 19 were present, eight were in favour of the amendment and 11 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 20 were present, 16 were in favour of the amendment and three against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that Dr Hon LAW Chi-kwong's amendment was negatived.

Hon Mrs Selina CHOW rose to move the following motion without notice:

That in the event of further divisions being claimed in respect of the remaining motions to be moved to the motion on Medical fee waiver mechanism at this meeting, Rule 47(1)(c) of the Rules of Procedure be suspended so that the President may order that the Council do proceed to each of such divisions immediately after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon LEUNG Yiu-chung moved the following amendment to Hon YEUNG Yiu-chung's amendment:

To delete "relaxing the asset-assessment criteria for unsupported elderly persons and to extend the maximum fee-waiver period for chronic patients from six months to one year" after "this Council urges the Government to relax the eligibility criteria under the mechanism, including" and substitute with "fully waiving the new and increased fees and charges in respect of elderly persons and chronic patients".

Question on Hon LEUNG Yiu-chung's amendment to Hon YEUNG Yiu-chung's amendment proposed and put.

Hon LEUNG Yiu-chung claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 19 were present, five were in favour of the amendment and 14 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 20 were present, 15 were in favour of the amendment and four against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that Hon LEUNG Yiu-chung's amendment was negatived.

Question on Hon YEUNG Yiu-chung's amendment to Hon Frederick FUNG's motion put.

Hon Frederick FUNG claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 19 were present, 15 were in favour of the amendment, one against it and three abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 21 were present, four were in favour of the amendment, two against it and 14 abstained. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the

two groups of Members present, she declared that Hon YEUNG Yiu-chung's amendment was negatived.

Hon Frederick FUNG replied.

Question on Hon Frederick FUNG's motion put.

Hon Frederick FUNG claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 19 were present, 11 were in favour of the motion and eight against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 21 were present and 20 were in favour of the motion. (Voting record in Appendix V.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the motion was carried.

Legislating against racial discrimination

Hon Audrey EU moved the following motion and addressed the Council:

That this Council urges the Government to adopt the recommendations of the relevant United Nations committees and expeditiously legislate against racial discrimination to ensure that new arrivals from the Mainland and ethnic minorities in Hong Kong can enjoy equal opportunities in such areas as education, employment and access to social services.

Question on Hon Audrey EU's motion proposed.

Hon YEUNG Yiu-chung said that he had decided to withdraw his amendment to the motion. He explained his decision and then spoke on the motion.

Another 21 Members and the Secretary for Home Affairs spoke on the motion.

Hon Audrey EU replied.

Question on the motion put and agreed to.

Next Meeting

The President declared that the next meeting of the Council would be held on 19 March 2003 at 2:30 pm.

The Council was adjourned at 12:17 am on 13 March 2003.
