Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA)

The CEPA provides for zero tariff from 1 January 2004 for exports from Hong Kong meeting the rules of origin requirement in 273 product codes. As a result of this concession and China's tariff commitments upon accession to the WTO, about 90% of the value of Hong Kong's domestic exports to the Mainland will enjoy zero tariff by 1 January 2004.

Many of the 273 products currently attract high tariffs. Some specific examples are: articles of jewellery (35%), micromotor for toys (24.5%) and clocks and watches (23%). Though China has committed to lowering tariff rates in her WTO accession protocol, the committed final bound tariff rates (i.e. after full implementation of its WTO commitments) for some products within the 273 codes will remain at high level. This can be illustrated in the table at Annex A. The tariff preference will enhance the competitiveness of products made in Hong Kong vis-à-vis those produced by other economies.

The Mainland is Hong Kong's largest trading partner. Our domestic exports to the Mainland amounted to HK\$54.2 billion, HK\$49.5 billion and HK\$41.4 billion in 2000, 2001 and 2002 respectively. The 273 codes include many product types in which Hong Kong traded substantively with the Mainland, such as textiles and clothing, electrical and electronic products, optical and photographic articles, plastic articles and paper articles. The relevant trade statistics of these items are at Annex B.
