## SARS Expert Committee Request for Submissions from Hospital Authority (HA)

The SARS Expert Committee has requested for information on Hospital Outbreak Control Plan:

"Please provide a copy of the contingency plan that has already been in existence for major incidents of non infectious disease nature for reference and an account of the drills that had been launched in the past year."

(Paragraph 3(b) in Annex to letter of 21 July 2003 from Secretary, SARS Expert Committee)

The HA hereby submit an HA Civil Disaster Contingency Plan (CDCP) to the Committee for reference CDCP is a general framework applicable to all types of civil disaster. HA also have specific contingency plans for certain incidents, eg aircraft crash, radiological, biological and chemical incidents, which serve as reference in conjunction with CDCP. Other plans like the help desk guidelines and clinical psychology service plan also serve to supplement CDCP. A list of HA contingency plans are in Appendix 1. The HA will be happy to submit the plans listed in Appendix 1 on request.

As to drills, hospitals conduct drills on an annual basis to test their contingency plans and as a quality standard under Section 3 of the HA annual plan. For large scale inter-departmental joint exercises involving multiple Accident & Emergency Departments and acute hospitals, a list of joint exercises conducted since 1 January 2002 is in Appendix 2.
