Background

- By late March 2003, daily number of newly confirmed SARS cases increased rapidly
- There was an urgent need to co-ordinate efforts and resources of various
 Government departments to control the spread of the disease

- Comprises representatives of 6 policy bureaux and about 20 departments
- Chaired by the Permanent Secretary for Health, Welfare & Food
- Regular meetings every morning
- Operated from 27 March to 20 May

Major Roles of the Committee:

- Co-ordinate and steer emergency actions across bureaux and departments
- Take proactive investigative and remedial actions
- Collate and disseminate information
- Conduct risk assessment
- Provide response measures in dealing with all other SARS-related emergencies

Evacuation of Amoy Gardens Block E



Evacuation of Amoy Gardens Block E

- Since 26 March, a large outbreak of SARS had occurred in Amoy Garden, a residential estate in Kwun Tong District
- By the end of March, over 100 Block E residents were confirmed to have SARS.

The Committee in Action Evacuation of Amoy Gardens Block E (cont)

- In view of the alarming trend, the Government ordered Amoy Gardens Block E to be isolated for a period of 10 days from 31 March. Residents were moved to 3 holiday camps for temporary accommodation until 9 April
- Before the residents moved back, a comprehensive operation to disinfect the building was conducted.

Health Welforn and Food Buscares were also stepped up.

Hong Kong Special Administrative Region

Home Confinement Scheme

- All household contacts of confirmed SARS patient are required to undergo home confinement for a maximum of 10 days
- So far, 1,264 persons (from 494 households)
 had been affected by this requirement, of
 whom 34 persons were confined to have
 SARS

Temporary Quarters for Health Care Staff

- Two housing blocks, with over 1,000 units, have been turned into temporary quarters for health care staff.
- These units are fitted with basic facilities including beds, television and airconditioning.

Port Health Measures

- Health declaration for all incoming travellers
- Temperature screening at the airport, ports and border points were introduced
- Through these measures, 2 passengers were confirmed to have contracted SARS



Tourist Group in Taiwan

- In late April, a Hong Kong tourist group was required to undergo confinement in Taipei after one of its members, a 6-year-old girl, developed fever
- On 29 April, a chartered flight was arranged to fly this tourist group home for further examination and treatment
- Subsequent medical examination during and after the chartered flight confirmed that none of these tourists had contracted SARS

Malaysian Freighter with Sick Crews

- On 2 May, a Malaysian freighter called the Government for assistance after 10 of its crews had developed symptoms suggestive of SARS.
- The freighter entered Hong Kong waters on 4 May. Clinical examination was immediately conducted both on crews and the vessel.
- Fortunately, none of the crews was subsequently confirmed to have SARS.
