Public Health Functions of Food, Environmental Hygiene Department

Public Health Functions of Government Laboratory

Public Health Functions of Agricultural, Fisheries and Conservation Department

Prevention and control of rabies, provision of quarantine services, issue food health certificates, control of pesticides for protection of public health
