The Work of Expert Groups under Hong Kong Guangdong Cooperation Joint Conference

PURPOSE

At the meeting of LegCo Panel on Commerce and Industry held on 10 November 2003, the Administration undertook to provide information on the work and the ongoing projects and activities of the 15 expert groups under the Hong Kong Guangdong Cooperation Joint Conference (Joint Conference). This paper briefs Members on their work.

SCOPE OF WORK OF EXPERT GROUPS

2. Starting from the Sixth Plenary of the Joint Conference, the meeting is to be chaired by the heads of the two administrations, i.e. the Chief Executive and the Governor of Guangdong. The Executive Vice-Governor of Guangdong and the Chief Secretary for Administration (CS) will be responsible for steering and taking forward the agreed cooperation initiatives. To achieve Hong Kong Guangdong cooperation, both sides agreed that 15 expert groups should be set up under the Joint Conference to oversee cooperation programmes. The major responsibilities of the 15 expert groups are as follows:

(I) Expert Group on Tourism

3. The group is responsible for capitalizing on the strengths of the tourism industry in the Greater Pearl River Delta (GPRD) region by promoting the idea of multi-destination itineraries to overseas travellers. Both sides will be committed to ensure the smooth implementation of Individual Visit Scheme and the introduction of measures to cope with the surge of mainland tourists during the National Day holidays. They will also actively participate in the Hong Kong International Travel Expo and jointly

promote the Pearl River Delta (PRD) as a tourist destination in Japan, Korea, Britain and Germany. Moreover, they will make continuous efforts in developing the Guangdong, Hong Kong and Macao tourism information platform and stepping up cooperation.

- (II) Expert Group on Co-operation in Control Points
- 4. The group is responsible for further strengthening the cooperation between the control points on both sides with a view to enhancing their operational efficiency, capability and standard of service. It is tasked to streamline clearance procedures, employ new technology where appropriate, shorten clearance time and expedite the development of various control point-related infrastructure. In the short term, both sides will seek to increase the frequency of the Hong Kong-Guangzhou through train services and expand the coverage of the passenger ferry services between the PRD and Hong Kong International Airport as early as possible (the first ferry routes to Guangdong Province, including Fuyong and Shekou in Shenzhen as well as Dongguan, have been operational since 29 September 2003). In the medium and longer term, efforts will be made to improve the infrastructure in control points. We will strive to complete soonest possible the installation of air-conditioning system at the Lo Wu cross-boundary footbridge, the Hong Kong-Shenzhen Western Corridor, the new cross-boundary bridges at Lok Ma Chau (LMC) and Sha Tau Kok Control Points, and the Huanggang-LMC passenger footbridge. Completion of these projects will enhance the handling capacity of our control points.
- (III) Expert Group on Coordinating Hong Kong Guangdong Cross Boundary Major Infrastructural Projects
- 5. The group will coordinate and promote cooperation in the development of major cross boundary infrastructural projects in Hong Kong and Guangdong. Both sides will take active step to conduct feasibility studies on major projects such as the Hong Kong-Zhuhai-Macao Bridge and the Guangzhou-Shenzhen-Hong Kong Express Rail Link, and endeavour to complete them as early as possible.
- (IV) Expert Group on Exchange and Notification Mechanism on Infectious Diseases
- 6. The group seeks to improve the exchange and notification

mechanism between Hong Kong and Guangdong in order to provide an effective communication and exchange channel for the notification of existing and other infectious diseases. One focal point in this cooperation is to safeguard public health and forestall any economic losses inflicted by possible outbreak of infectious diseases. Both sides have strengthened the notification mechanism in early September and will work closely to follow up on the matter.

(V) Expert Group on Implementation of CEPA

7. The expert group is set up to exploit opportunities made available by CEPA to enhance cooperation with the Guangdong Province, in particular the The expert group will facilitate Hong Kong companies and individuals to set up businesses in Guangdong by disseminating business information on all or specific sectors through channels such as hyperlinks on web pages, exchanges between corresponding government departments and seminars. It will also provide mainland enterprises with information on the general investment environment in Hong Kong and specific sectors through seminars co-organized with relevant mainland government departments and agencies as well as trade associations. The expert group will take the initiative to visit enterprises in key mainland cities to find out if they are interested in "going out" and the difficulties they encountered in the process, and to provide assistance where appropriate. It will also receive mainland private enterprises on familiarisation trips to Hong Kong and give them a better understanding of the local business environment and opportunities available.

(VI) Expert Group on the Protection of Intellectual Property Rights

8. Hong Kong and Guangdong share the common goals of promoting economic development through protection of intellectual property rights (IPR); enhancing exchanges and cooperation in matters related to IPR on all fronts to safeguard economic benefits; and coordinating the efforts of Hong Kong/Mainland institutions in terms of the promotion, training, exchanges and cooperation regarding IPR. Cooperation programmes on this front include co-hosting of the Seminar on Intellectual Property and Development for Small and Medium Enterprises, holding regular meetings between the two Customs authorities to coordinate enforcement issues, etc. The prospects of developing IPR management as a new service industry in Guangdong and Hong Kong will also be examined.

- (VII) Expert Group on Cooperation in Innovation and Technology
- 9. The group is responsible for promoting closer cooperation between Hong Kong and Guangdong in supporting the development and upgrading of industries in both places. It also seeks to facilitate the application of creativity, design and technology to their industries; and plays an active role in the development of knowledge-based, high value-added industries in both places. Cooperation in research and development (R&D) will be strengthened through activities like study missions, seminars and regular forums to promote the commercialisation of R&D and the further development of relevant industries.
- (VIII) Expert Group on Promoting "Greater Pearl River Delta"
- 10. The group is responsible for promoting the GPRD region to foreign enterprises, with the combined strengths of Hong Kong and the PRD, as an ideal destination of foreign investment. Specific programmes include stepping up efforts in overseas promotion through holding annual joint overseas seminars to promote the investment environment of GPRD, for example, the joint investment promotion held in Japan and Korea in October 2003, to publicize the advantages of Hong Kong and Guangdong in attracting foreign investment, and the opportunities under CEPA.
- (IX) Expert Group on the Hong Kong Guangdong Economic Cooperation Seminar
- 11. The expert group successfully held the Hong Kong Guangdong Economic Cooperation Seminar on 25 September 2003 for the purpose of beefing up communication between the governments and business communities in Hong Kong and Guangdong, and further expanding the scope of mutual cooperation. The departments concerned are following up on matters concerning investment in Guangdong raised in the seminar.
- (X) Expert Group on Expanding the Hong Kong Guangdong Economic Cooperation Hinterland
- 12. The group is formed to encourage Hong Kong businessmen to invest in the mountain region as well as the eastern and western regions in Guangdong by jointly formulating the promotional strategies in indentifying the priority cities and industries to be promoted, enhancing exchange of information, and organizing study missions to visit the hinterland.

- (XI) Joint Working Group on Sustainable Development and Environmental Protection
- 13. The group is tasked to protect the overall environment of the GPRD region through enhanced cooperation in cross-boundary environmental issues. Cooperation initiatives include endeavouring to reduce emissions of major air pollutants in the PRD to an agreed level by 2010, explore the feasibility of introducing a pilot emissions trading scheme among power plants in Hong Kong and Guangdong, engage in exchanges and cooperation in marine resources, afforestation and ecological conservation, monitor the water quality of Dongjiang, protect the environment of Mirs Bay and Deep Bay as well as hold regular discussion sessions to exchange views on town planning and other related infrastructural developments in Hong Kong and Guangdong.

(XII) Expert Group on Co-operation in Education

14. The group aims at enhancing educational co-operation in various aspects, with a view to facilitating exchange of information and the professional development of education workers in both places. To this end, communication will be strengthened to allow better exchanges of information and experience. Expert meetings will be held in future to draw on, and share experience from the latest development in curriculum reform and the work on opening up more learning opportunities. The University Grants Committee will also organize a delegation to Guangzhou to study the planning and operation of the University Town. Local universities will be left to make their own decisions as to whether they should set up new campus there.

(XIII) Expert Group on Co-operation in Culture and Sports

15. The group is responsible for promoting cooperation in culture and sports. On the cultural front, Hong Kong, Guangdong and Macao will cooperate to help achieve complementary development, share resources, improve efficiency, reduce cost, create new brand names, groom more talents, exchange information and promote art and cultural activities. This will help elevate the cultural level of the GPRD, thereby boosting the cultural and economic developments of the whole region. An Agreement on Greater Pearl River Delta Cultural Cooperation, which sets out the common goals and areas in cultural cooperation, was already signed by Hong Kong, Guangdong

and Macao. The three cities will hold meetings from time to time to discuss matters concerning cultural cooperation. They have also set up working groups to follow up on issues such as exchange of performing artists and cultural information; joint organization of international events; development of museum network; excavation, preservation and promotion of cultural relics; networking of digital library services and promotion of Cantonese opera.

16. As for sports cooperation, Hong Kong and Guangdong have set the sights on enhanced training for athletes and higher sporting level through sharing of information on sports and resources and complementary development. The ultimate aim is to hold sports events on a grand scale and achieve excellent sports management in order to expedite exchanges and boost economic development of the two places. Specific cooperation programmes encompass sharing sports data; training promising young athletes and promoting sports culture; drawing on Mainland expertise to help elevate the general sporting level of Hong Kong; and working actively with Guangdong in the development and study of quality management for leisure, yacht and fitness clubs.

(XIV) Expert Group on Tonggu Waterway

17. The group will lend full support to the relevant institutions in Shenzhen to facilitate an early completion of the related statutory procedures and compliance with the relevant requirements.

(XV) Expert Group on Information Exchange

- 18. The group is responsible for collecting and exchanging information for initial planning of major infrastructural projects and long-term regional developments in both places, and keeping each other informed of any relevant seminars in order to facilitate arrangements for participation.
