Design and format of the Second Report

Tabling of the Second Report

- 66. <u>Members</u> agreed that the Second Report be presented to the Council on 19 May 2004 and the Chairman would make a statement in the Council on the Second Report. A press conference would be held on the same day at 4:00 pm to answer media enquiries.
- 67. <u>Members</u> also decided that there was no need to move a motion on the Second Report as the institutional and policy issues of public housing had been debated when the Select Committee presented its First Report.

Provision of advance copies of the Second Report

68. <u>Members</u> agreed that as in the case of the First report, advance copies could be made available to the Chief Executive, the Department of Justice, all witnesses and related parties, subject to their undertaking not to divulge any part of the Second Report until the start of the Council meeting on 19 May 2004. The Second Report would also be made available to the media for perusal at 2:00 pm on that day.

Public access to unclassified documents

69. <u>Members</u> decided that with the exception of restricted and confidential documents, all written evidence in relation to the Tin Chung Court incident provided to the Select Committee should be made available for public inspection in the Legislative Council Library after the Second Report had been tabled in the Council.

IV Any other business

70. The Chairman thanked members and staff for their contribution to the work of the Select Committee. The meeting ended at 6:10 pm.
