Members' Motions

Motion of Thanks

Hon Miriam LAU moved the following motion and addressed the Council:

That this Council thanks the Chief Executive for his address.

While Hon Miriam LAU was speaking, Hon LAU Kong-wah said that the placards displayed by other Members blocked his view. He requested the Members to put down the placards.

The President said that the convention regarding display of placards or other objects by Members in the Chamber during Council meetings was that such placards or objects should be relevant to the subject being debated and they should not obstruct the conduct of meetings or other Members. The President then requested Members to place the placards at a suitable position so as not to block the view of other Members.

Hon CHEUNG Man-kwong said that the placards were so small that they could not block the view of other Members.

The President reiterated that the display of placards in the Chamber should follow the convention that they should not obstruct other Members.

Hon Miriam LAU spoke again.

While Hon Miriam LAU was speaking, Hon LAU Kong-wah repeated his request that the placard which was blocking his view should be removed.

The President pointed out that Hon LAU Kong-wah's request was not a point of order, and the Rules of Procedure did not specify how placards should be displayed. The President hoped that Members would cooperate so that the meeting could be conducted smoothly.

Hon Miriam LAU continued to speak.

Question on the motion proposed.

The President said that the motion and the amendments thereto, to be moved by Hon Frederick FUNG, Hon Emily LAU, Hon WONG Sing-chi and Hon Alan LEONG, would be debated together in a joint debate.

The President announced the commencement of the first debate session on the theme of "Developing the Infrastructure for Economic Growth". The session covered the policy areas of commerce and industry, development (planning, lands and works), economic development (other than energy), financial affairs, housing, information technology and broadcasting (other than creative industry) and transport.

Six Members and Hon Mrs Regina IP spoke.

While Hon Mrs Regina IP was speaking, the President left the chair at 1:03 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Two more Members and Hon LEE Wing-tat spoke.

At 1:41 pm, while Hon LEE Wing-tat was speaking, the President resumed the chair.

Twenty-one other Members and Hon WONG Ting-kwong spoke.

While Hon WONG Ting-kwong was speaking, the President left the chair at 6:30 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Two more Members and Hon Cyd HO spoke.

At 7:33 pm, while Hon Cyd HO was speaking, the President resumed the chair.

Three other Members spoke.

Hon Abraham SHEK spoke and declared that he was an Independent Non-executive Director of the MTR Corporation Limited.

One more Member spoke.

The President suspended the meeting at 9:01 pm.

The Council resumed at 9:00 am on 29 October 2009 to continue the first debate session of the Motion of Thanks.

Three Members spoke.

The Financial Secretary, the Secretary for Transport and Housing, the Secretary for Commerce and Economic Development, the Secretary for Constitutional and Mainland Affairs and the Secretary for Financial Services and the Treasury spoke.

The President announced the end of the first debate session and the commencement of the second debate session on the theme of "Quality City and Quality Life". The session covered the policy areas of development (heritage conservation), economic development (energy), environmental affairs, food safety and environmental hygiene, home affairs (other than district administration and civic education), information technology and broadcasting (creative industry).

Eleven Members and Hon WONG Yung-kan spoke.

While Hon WONG Yung-kan was speaking, the President left the chair at 1:02 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Three other Members and Prof Hon Patrick LAU spoke.

At 1:59 pm, while Prof Hon Patrick LAU was speaking, the President resumed the chair.

Ten more Members spoke.

With the President's permission, Hon WONG Yung-kan elucidated a point made in his earlier speech, which had been misunderstood by Hon WONG Sing-chi.

Three other Members spoke.

The Secretary for the Environment, the Secretary for Commerce and Economic Development, the Secretary for Food and Health and the Secretary for Home Affairs spoke.

The President announced the end of the second debate session and the commencement of the third debate session on the theme of "Investing for a Caring Society". The session covered the policy areas of manpower, welfare services (including social enterprise and family matters) and security (anti-drug policy).

Six Members and Hon Ronny TONG spoke.

While Hon Ronny TONG was speaking, the President left the chair at 6:30 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Six more Members and Hon WONG Sing-chi spoke.

At 7:20 pm, while Hon WONG Sing-chi was speaking, the President resumed the chair.

Five other Members spoke.

The Secretary for Labour and Welfare spoke.

The President suspended the meeting at 9:20 pm.

The Council resumed at 9:00 am on 30 October 2009 to continue the third debate session of the Motion of Thanks.

The Secretary for Home Affairs, the Secretary for Security and the Secretary for Education spoke.

The President announced the end of the third debate session and the commencement of the fourth debate session on the theme of "Optimising Our Demographic Structure and Attracting Talent". The session covered the policy areas of education, health services and security (immigration policies).

Eighteen Members spoke.

The Secretary for Education, the Secretary for Food and Health and the Secretary for Security spoke.

The President announced the end of the fourth debate session and the commencement of the fifth debate session on the theme of "Developing Democracy and Enhancing Governance". The session covered the policy areas of administration of justice and legal services, constitutional affairs, home affairs (district administration and civic education), public service and security (other than immigration and anti-drug policies).

Dr Hon Margaret NG spoke.

While Dr Hon Margaret NG was speaking, the President left the chair at 12:56 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Eight other Members and Hon James TO spoke.

At 2:00 pm, while Hon James TO was speaking, the President resumed the chair.

Thirteen more Members spoke.

The Chief Secretary for Administration, the Secretary for Justice, the Secretary for Constitutional and Mainland Affairs, the Secretary for the Civil Service, the Secretary for Security and the Secretary for Home Affairs spoke.

The President announced the end of the fifth debate session.

Hon Miriam LAU spoke on the amendments.

Hon Fredrick FUNG moved the following amendment to Hon Miriam LAU's motion:

To add ", but expresses deep regret at the Policy Address's failure to put forward any specific alleviation measures to respond to the difficulties currently faced by the grassroots, as well as its lack of any medium and long-term strategies to solve the problem of the disparity between the rich and the poor" immediately before the full stop.

Question on Hon Fredrick FUNG's amendment to Hon Miriam LAU's motion proposed and put.

Hon Fredrick FUNG claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, four were in favour of the amendment, 18 against it and five abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, 17 were in favour of the amendment, six against it and six abstained. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Motion of Thanks" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon Emily LAU moved the following amendment to Hon Miriam LAU's motion:

To add ", but expresses regret at the Chief Executive's failure to perform his duty to approach the Central Government to strive for the implementation of the election of the Chief Executive and all Legislative Council Members by universal suffrage in 2012" immediately before the full stop.

Question on Hon Emily LAU's amendment to Hon Miriam LAU's motion proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 28 were present, four were in favour of the amendment, 23 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, 16 were in favour of the amendment, 10 against it and three abstained. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon WONG Sing-chi moved the following amendment to Hon Miriam LAU's motion:

To add ", but expresses regret that the Chief Executive completely ignores the problems of worsening disparity between the rich and the poor and the drastic increase in the poverty population" immediately before the full stop.

Question on Hon WONG Sing-chi's amendment to Hon Miriam LAU's motion proposed and put.

Hon WONG Sing-chi claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 28 were present, nine were in favour of the amendment, 15 against it and four abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, 17 were in favour of the amendment, six against it and six abstained. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Alan LEONG moved the following amendment to Hon Miriam LAU's motion:

To add ", but expresses deep regret at the Chief Executive's failure to provide a roadmap for universal suffrage in the Policy Address, as well as his failure to honour his election promise of 'settling the issue of universal suffrage once and for all' " immediately before the full stop.

Question on Hon Alan LEONG's amendment to Hon Miriam LAU's motion proposed and put.

Hon Ronny TONG claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 28 were present, four were in favour of the amendment, 22 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, 16 were in favour of the amendment, nine against it and four abstained. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU replied.

Question on the motion put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 29 were present, 24 were in favour of the motion, three against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, 10 were in favour of the motion and 19 against it. (Voting record in Appendix V.) Since the question was agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Next meeting

The President declared that the next meeting of the Council would be held on 4 November 2009 at 11:00 am.
