Bills

First Reading

Toys and Children's Products Safety (Amendment) Bill 2009

The Bill was read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

Second Reading

Toys and Children's Products Safety (Amendment) Bill 2009

The Secretary for Commerce and Economic Development moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Import and Export (Amendment) Bill 2009

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 18 November 2009 resumed.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into Committee and considered the Import and Export (Amendment) Bill 2009.

Question that clauses 1, 2 and 3 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Security reported that

the Import and Export (Amendment) Bill 2009

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Public Officers Pay Adjustment Bill

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 8 July 2009 resumed.

Hon IP Kwok-him, Chairman of the Bills Committee on Public Officers Pay Adjustment Bill, addressed the Council on the Committee's Report.

At 1:20 pm, while Hon IP Kwok-him was addressing, the President resumed the chair.

After the address, Hon IP Kwok-him spoke on the Bill in his personal capacity as a Member.

Four Members spoke on the Bill.

Dr Hon PAN Pey-chyou declared that he was working as a consultant in the Hospital Authority. He then spoke on the Bill.

Two other Members spoke on the Bill.

Dr Hon Priscilla LEUNG spoke on the Bill and declared that she was working in a university.

Four more Members spoke on the Bill.

With the President's permission, Dr Hon Margaret NG elucidated a point she had made earlier which she considered to be misunderstood by Hon Paul CHAN.

Three more Members spoke on the Bill.

The Secretary for the Civil Service replied.

Question on the Second Reading put.

Dr Hon Margaret NG claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that there were 54 Members present, 29 were in favour of the motion, 23 against it and one abstained (voting record in **Appendix I**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into Committee and considered the Public Officers Pay Adjustment Bill.

Question that clauses 1, 2, 4 and 8 to 13 stand part of the Bill proposed, put and agreed to.

Question that clauses 3, 5, 6 and 7 stand part of the Bill proposed.

The Chairman stated that Dr Hon Margaret NG, Hon Mrs Regina IP and Ir Dr Hon Raymond HO had separately given notice to move amendments to clauses 5, 6 and 7 to the Bill. Ir Dr Hon Raymond HO would also propose a consequential amendment to clause 3. The Chairman ordered that clauses 3, 5, 6 and 7 and the amendments thereto be debated together in a joint debate.

Dr Hon Margaret NG, Hon Mrs Regina IP and Ir Dr Hon Raymond HO spoke on the clauses and their amendments respectively.

One Member spoke on the clauses and the amendments.

Dr Hon LEUNG Ka-lau declared that he was an employee of the Hospital Authority and would be affected by the pay adjustment. He then spoke on the clauses and the amendments.

Two other Members spoke on the clauses and the amendments.

The Secretary for the Civil Service spoke on the clauses and the amendments.

Dr Hon Margaret NG spoke again, and moved amendments to clauses 5, 6 and 7.

Question on the amendments put.

Hon Mrs Regina IP claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 26 were present, eight were in favour of the amendments, 17 against them and one abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, nine were in favour of the amendments, 14 against them and three abstained (voting record in **Appendix II**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

The Chairman stated that the amendments of Dr Hon Margaret NG and Hon Mrs Regina IP were substantially the same. As the Committee had already made its decision on Dr Hon Margaret NG's amendments, Hon Mrs Regina IP might not move her amendments.

Ir Dr Hon Raymond HO moved amendments to clauses 3, 5, 6 and 7.

Question on the amendments put.

Ir Dr Hon Raymond HO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 25 were present, eight were in favour of the amendments, 16 against them and one abstained; while among the Members returned by geographical constituencies through direct elections, 27 were present, nine were in favour of the amendments, 14 against them and three abstained (voting record in **Appendix III**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clauses 3, 5, 6 and 7 stand part of the Bill put and agreed to.

Question that the schedule stand part of the Bill proposed.

The Secretary for the Civil Service moved amendments to the schedule and spoke on the amendments.

Question on the amendments put and agreed to.

Question that the schedule as amended stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for the Civil Service reported that

the Public Officers Pay Adjustment Bill

had passed through the Committee with amendments. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed.

A Member spoke on the motion.

Question on the Third Reading put.

Dr Hon Margaret NG claimed a division. The President then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that there were 52 Members present, 29 were in favour of the motion, 21 against it and one abstained (voting record in **Appendix IV**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the third time and passed.

Domestic Violence (Amendment) Bill 2009

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 17 June 2009 resumed.

Hon LEE Cheuk-yan, Chairman of the Bills Committee on Domestic Violence (Amendment) Bill 2009, addressed the Council on the Committee's Report. After the address, he spoke on the Bill in his personal capacity as a Member.

Four Members and Hon Cyd HO spoke on the Bill.

While Hon Cyd HO was speaking, the President left the chair at 6:28 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Two other Members and Hon Ronny TONG spoke on the Bill.

At 6:55 pm, while Hon Ronny TONG was speaking, the President resumed the chair.

One more Member spoke on the Bill.

The Secretary for Labour and Welfare replied.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into Committee and considered the Domestic Violence (Amendment) Bill 2009.

Question that clauses 1, 2, 4, 6 and 8 to 19 stand part of the Bill proposed, put and agreed to.

Question that clauses 3 and 7 stand part of the Bill proposed.

The Secretary for Labour and Welfare moved amendments to clauses 3 and 7 and spoke on the amendments.

Question on the amendments put and agreed to.

Question that clauses 3 and 7 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 5 stand part of the Bill proposed.

The Chairman stated that Dr Hon Margaret NG and the Secretary for Labour and Welfare had separately given notice to move amendments to the proposed definition of 'cohabitation relationship' in subclause (2) of clause 5. The Chairman ordered that clause 5 and the amendments thereto be debated together in a joint debate.

Dr Hon Margaret NG and the Secretary for Labour and Welfare spoke on the clause and their amendments respectively.

Three Members spoke on the clause and the amendments.

A Member spoke again.

The Secretary for Labour and Welfare spoke again.

Dr Hon Margaret NG spoke again, and move an amendment to the proposed definition of 'cohabitation relationship' in subclause (2) of clause 5.

Question on Dr Hon Margaret NG's amendment put.

Dr Hon Margaret NG claimed a division. The Chairman then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 19 were present, one was in favour of the amendment, 17 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, nine were in favour of the amendment and 14 against it (voting record in **Appendix V**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

The Chairman stated that as Dr Hon Margaret NG's amendment had been negatived, she might not move her consequential amendment to the long title.

The Secretary for Labour and Welfare moved his amendment to the proposed definition of 'cohabitation relationship' in subclause (2) of clause 5.

Question on the amendment put and agreed to.

The Secretary for Labour and Welfare moved a further amendment to subclause (2) of clause 5 to add the definition of 'applicant' and spoke on the amendment.

Question on the amendment put and agreed to.

Question that clause 5 as amended stand part of the Bill proposed, put and agreed to.

New clause 6A read the first time.

The Secretary for Labour and Welfare moved the Second Reading of new clause 6A and spoke on the new clause.

Question on the Second Reading of new clause 6A proposed, put and agreed to.

New clause 6A read the second time.

The Secretary for Labour and Welfare moved the addition of new clause 6A to the Bill.

Question on the addition proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Labour and Welfare reported that

the Domestic Violence (Amendment) Bill 2009

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Motions

Proposed resolution under the Pharmacy and Poisons Ordinance

The Secretary for Food and Health moved the following motion and spoke on the motion:

RESOLVED that the following Regulations, made by the Pharmacy and Poisons Board on 24 November 2009, be approved –

- (a) the Pharmacy and Poisons (Amendment) (No. 4) Regulation 2009; and
- (b) the Poisons List (Amendment) (No. 4) Regulation 2009.

Question on the motion proposed, put and agreed to.

Members' Motions

Formulating operational standards for public organizations

Hon Mrs Regina IP moved the following motion and spoke on the motion:

That dozens of public organizations in Hong Kong, some being statutory bodies, provide important public services in areas including housing, transportation, commerce and trade as well as financial services, etc; the funding for such organizations is mostly provided by the Government in full or in part, and some of them are authorized by legislation to impose levies or develop other businesses to enhance their profitability; it is learnt that in determining the pay and bonus for the management of these public organizations, their profitability is one of the important criteria for measuring performance, causing some public organizations to fully strive to expand and compete with the private sector for profits, hence disregarding the purposes of their establishment, development of market economy and public interests; as such, this Council urges the Government to formulate operational standards for public organizations, which include ensuring that their operation:

- (a) shall meet the purposes laid down upon the establishment of the organization;
- (b) shall meet the overall interests of the community;
- (c) shall comply with stringent indicators for corporate social responsibility;
- (d) shall be subject to the regulation of the fair competition law;
- (e) shall have a highly transparent mechanism for declaration of interests, including proper confidentiality and exit arrangements, so as to prevent real or potential conflicts of interests or transfer of interests;
- (f) shall be subject to value for money audits by the Director of Audit on a regular basis; and
- (g) shall not jeopardize the principles of 'big market, small government' and free market economy;

and peg the pay/bonus for the remunerated directors and senior executives of public organizations to the above criteria.

Question on Hon Mrs Regina IP's motion proposed.

The President stated that three Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the three amendments would be debated together in a joint debate.

Hon Frederick FUNG, Hon Miriam LAU and Dr Hon PAN Pey-chyou, who intended to move amendments to the motion, spoke on the motion and the amendments.

The Secretary for Financial Services and the Treasury spoke on the motion and the amendments.

Four Members spoke on the motion and the amendments.

The President suspended the meeting at 10:02 pm.

To add ", owing to historical, social and economic factors, the Government has in the past established" after "That"; to delete "in Hong Kong" after "dozens of public organizations"; to add "to" after "statutory bodies,"; to delete "be subject to" after "(d) shall" and substitute with "take into account the social functions of the relevant public organizations and bring them under"; to add "as the situation may require" after "the regulation of competition law"; to add "and" after "transfer of interests;"; and to delete "and (g) shall not jeopardize the principles of 'big market, small government' and free market economy;" after "regular basis;".

Question on Hon Frederick FUNG's amendment to Hon Mrs Regina IP's motion proposed and put.

Hon Frederick FUNG claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 23 were present, nine were in favour of the amendment, four against it and 10 abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 18 were in favour of the amendment, one against it and four abstained (voting record in **Appendix VI**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Formulating operational standards for public organizations" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon Miriam LAU moved the following amendment to Hon Mrs Regina IP's motion:

To add ", owing to different policy objectives, the Government has in the past set up" after "That"; to delete "in Hong Kong" after "dozens of public organizations"; to add "to" after "statutory bodies,"; to delete "formulate operational standards for public organizations, which include ensuring that their operation" after "this Council urges the Government to" and substitute with "strengthen the monitoring of the operation and finances of various public organizations, which include ensuring that they exercise prudence in financial management, make effective use of public funds, put in place a highly transparent mechanism for declaration of interests and are subject to audits by the Director of Audit on a regular basis; and public organizations having an objective to make profits have to strike a balance between pursuing profits and public interests, should be subject to the regulation of competition law and uphold the principles of 'big market, small government' and free market economy in their operations; in addition, different public organizations should evaluate their performance based on their respective nature and the following five criteria"; to delete "be subject to the regulation of competition law" after "(d) shall" and substitute with "attain public service standards which are updated from time to time and are measurable; and (e) for public organizations having an objective to make profits, shall adhere to the principle of prudent business operation"; to delete "(e) shall have a highly transparent mechanism for declaration of interests, including proper confidentiality and exit arrangements, so as to prevent real or potential conflicts of interests or transfer of interests; (f) shall be subject to value for money audits by the Director of Audit on a regular basis; and (g) shall not jeopardize the principles of 'big market, small government' and free market economy;" before "and peg the pay/bonus"; to add "as well as the appointment and removal of the chairmen of public organizations and members of their management boards or management committees" after "senior executives of public organizations"; and to delete "criteria" immediately before the full stop and substitute with "evaluation results".

Question on Hon Miriam LAU's amendment to Hon Mrs Regina IP's motion proposed and put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 23 were present, 12 were in favour of the amendment, one against it and 10 abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present, 13 were in favour of the amendment, five against it and four abstained (voting record in **Appendix VII**). Since the question was agreed by a majority of each of the two groups of Members present, he declared that the amendment was passed.

As Hon Miriam LAU's amendment had been passed, the President granted leave for Dr Hon PAN Pey-chyou to revise the terms of his amendment.

Dr Hon PAN Pey-chyou moved the following further amendment to Hon Mrs Regina IP's motion as amended by Hon Miriam LAU:

To add "; in formulating operational standards for public organizations, the Government should also ensure that public organizations shall implement a good staff management culture, which provides staff with reasonable salary, job stability and reasonable workload, and enables them to have fair treatment in employment relationship; in addition, the Government should enhance public participation in the board of directors of various public organizations, include staff representatives who have recognition to sit on the board and, at the same time, strengthen the board's ability in monitoring the operation, governance and financial operations of the organizations" immediately before the full stop.

Question on Dr Hon PAN Pey-chyou's amendment to Hon Mrs Regina IP's motion as amended by Hon Miriam LAU proposed and put.

Hon Andrew LEUNG claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 23 were present, 15 were in favour of the amendment, one against it and seven abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present, 13 were in favour of the amendment, five against it and four abstained (voting record in **Appendix VIII**). Since the question was agreed by a majority of each of the two groups of Members present, he declared that the amendment was passed.

Question on Hon Mrs Regina IP's motion as amended by Hon Miriam LAU and Dr Hon PAN Pey-chyou put and agreed to.

<u>Urging the Government to promote a new occupational culture campaign for work-life balance</u>

Hon CHAN Kin-por moved the following motion and spoke on the motion:

That, as Hong Kong has developed into a society with a mature economy where the opportunities for upward social mobility continue to reduce, the promotion opportunities for many employees, especially the younger generation, are drastically reduced, coupled with heavy work pressure, they easily develop a sense of failure in work and life, which has a negative impact on the long-term development of the Hong Kong society; in this connection, this Council urges the Government to promote a new occupational culture campaign for work-life balance to alleviate pressure in life brought by various problems at work, educate the public to establish proper values towards life that, in addition to work, there are still many things worth pursuing in a healthy life, and encourage the public to develop a diversified life, including building harmonious families and a public-spirited society, as well as pursuing knowledge, etc; the Government should at the same time make employers understand that the mode of work-life balance may mitigate work pressure on employees and increase their passion for work, thereby achieving the goals of enhancing productivity and work quality, as well as reduce labour disputes, ultimately enabling both the employees and employers to benefit at the same time; the relevant government measures should include:

- (a) to set up a special task force, and adopt new thinking to tailor-make a new occupational culture policy on work-life balance for Hong Kong, and disseminate the message of a diversified and healthy life to various social strata so as to enable the public to understand that achievements in life do not come solely from work, and that building harmonious families and a public-spirited society, etc are also important achievements in life;
- (b) the Government to take the lead in promoting a new occupational culture of work-life balance and set up a special fund to subsidize companies in various industries and trades according to their needs to actively promote a more flexible work culture and other measures for work-life balance, thereby enabling Hong Kong to become a more vibrant and competitive city;
- (c) to encourage enterprises to implement policies to meet the needs of employees regarding work-life balance, including providing support for the employees and their families, assisting in solving their emotional problems such as those stemming from work pressure and encouraging enterprises to organize publicspirited and spare-time recreational activities for the employees, so as to enable the employees to enjoy a fruitful life, consolidate their morale and increase their passion for work; and
- (d) to encourage enterprises to implement a flexible leave policy, and give them special holidays such as paternal leave, study leave, compassionate leave, etc, when employees encounter major events in life.

Question on Hon CHAN Kin-por's motion proposed.

The President stated that three Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the three amendments would be debated together in a joint debate.

Hon WONG Kwok-hing, Hon WONG Sing-chi and Hon LEE Cheuk-yan, who intended to move amendments to the motion, spoke on the motion and the amendments.

The Secretary for Labour and Welfare spoke on the motion and the amendments.

Ten Members and Hon Paul CHAN spoke on the motion and the amendments.

While Hon Paul CHAN was speaking, the President left the chair at 1:06 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Four other Members spoke on the motion and the amendments.

Hon CHAN Kin-por spoke on the amendments.

The Secretary for Labour and Welfare spoke again.

At 1:40 pm, while the Secretary for Labour and Welfare was speaking, the President resumed the chair.

Hon WONG Kwok-hing moved the following amendment to Hon CHAN Kin-por's motion:

To delete "Hong Kong has developed into a society with a mature economy where the" after "That, as" and substitute with "the SAR Government attaches too much importance to a few industries, such as the financial and real estate industries, coupled with the fact that some employers have adopted different de-employment means to avoid giving various employment entitlements,"; to delete "coupled with" after "drastically reduced," and substitute with "and employers in general, in order to cut costs, deploy tight manpower to cope with work, giving rise to"; to delete "the Government to" after "this Council urges" and substitute with "that besides developing more industries and creating diversified employment opportunities, the Government should"; to add "including examining ways to reverse the undesirable trend of 'de-employment', and using government departments, public organizations and those organizations with the Government as the major shareholder as an example to encourage employers to recruit employees in proper modes of employment so as to enhance the employees' sense of identity with and belonging to their companies," after "work-life balance for Hong Kong,"; to add "(b) to promote a new occupational health and safety culture, including regulating working hours, providing rest breaks and employing additional staff, with a view to easing the intensity of labour as well as reducing industrial accidents and occupational diseases caused by long working hours;" after "important achievements in life;"; to delete the original "(b)" and substitute with "(c)"; to add "take diversified measures to encourage and subsidize their employees to pursue further studies, and" after "their needs to"; to delete the original "(c)" and substitute with "(d)"; to add "such as child care service during working hours," after "their families,"; to delete the original "(d)" and substitute with "(e)"; to add "standardize the number of statutory holidays and public holidays to 17 days," before "encourage enterprises to implement a flexible leave"; to add "paid" after "give them special"; and to add "wedding leave," after "holidays such as".

Question on Hon WONG Kwok-hing's amendment to Hon CHAN Kin-por's motion proposed and put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 11 were present, four were in favour of the amendment, three against it and four abstained; while among the Members returned by geographical constituencies through direct elections, 19 were present, 13 were in favour of the amendment and five abstained (voting record in **Appendix IX**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Urging the Government to promote a new occupational culture campaign for work-life balance" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon WONG Sing-chi moved the following amendment to Hon CHAN Kin-por's motion:

To add "a study indicates that the index on family solidarity in Hong Kong has continued to drop and amid the financial tsunami, families at various strata are bearing heavy pressure in their finances and other aspects of daily life; at the same time," after "That,"; to add "and actively implement family-friendly policies" after "campaign for work-life balance"; to add "and through these measures," after "problems at work,"; to add "(b) to introduce 'family impact assessment' to review the impact of public policies and administrative measures on different types of families; (c) to actively promote 'family day' and call on the community to cherish the value of family; " after "important achievements in life;"; to delete the original "(b)" and substitute with

"(d)"; to add "(e) to introduce paternity leave and standard working hours as well as encourage employers to implement family-friendly employment policies so that employees can take care of both their families and work at the same time;" after "competitive city;"; to delete the original "(c)" and substitute with "(f)"; and to delete the original "(d)" and substitute with "(g)".

Question on Hon WONG Sing-chi's amendment to Hon CHAN Kin-por's motion proposed and put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 11 were present, five were in favour of the amendment, one against it and five abstained; while among the Members returned by geographical constituencies through direct elections, 19 were present, 17 were in favour of the amendment and one abstained (voting record in **Appendix X**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon LEE Cheuk-yan moved the following amendment to Hon CHAN Kin-por's motion:

To delete "and" after "consolidate their morale and increase their passion for work;"; and to add "; and (e) to legislate for the regulation of working hours so as to reduce the situation of employees frequently working overtime" immediately before the full stop.

Question on Hon LEE Cheuk-yan's amendment to Hon CHAN Kin-por's motion proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 11 were present, four were in favour of the amendment, four against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 19 were present, 14 were in favour of the amendment, three against it and one abstained (voting record in **Appendix XI**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon CHAN Kin-por replied.

Question on Hon CHAN Kin-por's motion put and agreed to.

Next meeting
