#### 5. Hon Frederick FUNG asked Question 5.

Six Members asked supplementary questions and the Secretary for the Environment replied.

#### 6. Hon LAU Wong-fat asked Question 6.

The Secretary for Education replied.

At 12:51 pm, while the Secretary for Education was speaking, the President resumed the chair.

Seven Members asked supplementary questions and the Secretary for Education replied.

Written replies to Questions 7 to 20 were tabled for Members' information.

#### **Personal Explanations**

The President stated that he had given leave for Hon WONG Yuk-man, Hon LEUNG Kwok-hung, Hon Albert CHAN, Hon Tanya CHAN and Hon Alan LEONG to make personal explanations respectively concerning their resignation from office as Legislative Council Members.

The President pointed out that in accordance with Rule 28A(2) of the Rules of Procedure, no debate might arise on such explanations but he might in his discretion allow short questions to be put to the Members making the explanations for the purpose of elucidating the contents of their explanations. The President further stated that after a Member had made his/her personal explanation, any Member who wished to seek elucidation of the contents of such explanation should do so before another Member made his/her personal explanation.

When Hon WONG Yuk-man was called upon to make his personal explanation, Hon CHAN Kam-lam raised a point of order requesting that copies of the intended explanations be provided to Members for reference before the Members concerned made their explanations.

The President said that the five Members had submitted copies of their intended explanations for his perusal before the meeting. As the contents of their intended explanations were in compliance with the Rules of Procedure, he had therefore given leave for them to make the explanations. Since the five Members had no objection to distributing copies of their intended explanations for Members' reference, the President directed the Secretariat staff to distribute the copies to all Members.

Hon TAM Yiu-chung stood up to speak. He expressed dissatisfaction with the five Members using the Legislative Council meeting as a forum for promoting their resignation as a referendum and uprising. Mr TAM and some other Members, including Hon WONG Kwok-hing, then walked out of the meeting in protest of the action of the five Members.

While leaving the Chamber, Hon WONG Kwok-hing spoke aloud criticizing the act of the five Members. The President asked him to observe the Rules of Procedure.

When Hon WONG Yuk-man was called upon again to make his personal explanation, Hon CHAN Kam-lam drew the attention of the President to the absence of a quorum. The President directed the Clerk to summon Members to the meeting.

# **Next meeting**

As a quorum was not present 15 minutes after Members had been summoned, the President adjourned the Council in accordance with Rule 17(2) of the Rules of Procedure, until 11:00 am on 3 February 2010.

The Council was adjourned at 1:31 pm.
