Motions

Proposed resolution under the Pharmacy and Poisons Ordinance

The Secretary for Food and Health moved the following motion and spoke on the motion:

RESOLVED that the following Regulations, made by the Pharmacy and Poisons Board on 22 February 2010, be approved –

- (a) the Pharmacy and Poisons (Amendment) Regulation 2010; and
- (b) the Poisons List (Amendment) Regulation 2010.

Question on the motion proposed, put and agreed to.

Members' Motions

Proposed resolution under the Interpretation and General Clauses Ordinance

Hon Miriam LAU moved the following motion and spoke on the motion:

RESOLVED that in relation to the Designation of Libraries Order 2010, published in the Gazette as Legal Notice No. 22 of 2010 and laid on the table of the Legislative Council on 3 March 2010, the period for amending subsidiary legislation referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) be extended under section 34(4) of that Ordinance to the meeting of 21 April 2010.

Question on the motion proposed, put and agreed to.

Proposed resolutions under the Interpretation and General Clauses Ordinance

The President stated that six Members proposed to move a total of 14 motions under the Interpretation and General Clauses Ordinance to amend the Land (Compulsory Sale for Redevelopment) (Specification of Lower Percentage) Notice. Hon Cyd HO, Hon Mrs Regina IP and Hon Audrey EU each proposed to move a motion to amend the Notice; Hon Albert HO proposed to move three separate motions to amend the Notice; while Hon James TO and Hon LEE Wing-tat each proposed to move four separate motions to amend the Notice.

The President pointed out that both Hon Cyd HO's motion and Hon Albert HO's first motion proposed to repeal the Notice. As the two motions were substantially the same, he would only invite Hon Cyd HO to move her motion. Irrespective of whether Hon Cyd HO's motion was passed or not, Hon Albert HO might not move his respective motion. Moreover, if Hon Cyd HO's motion was passed, other Members might not move their motions.

The President further stated that Hon Mrs Regina IP's motion and Hon James TO's second motion were also substantially the same. If Hon Cyd HO's motion was negatived, he would only invite Hon Mrs Regina IP to move her motion. Irrespective of whether Hon Mrs Regina IP's motion was passed or not, Hon James TO might not move his respective motion. Furthermore, as the proposals in Hon Mrs Regina IP's motion included repealing section 4(1)(a) and (b), and other motions proposed to be moved after her motion also sought to repeal section 4(1)(a) and/or (b) and substitute it with new proposals, hence if Hon Mrs Regina IP's motion was passed, the relevant Members might not move their motions. Similarly, if any one of the motions moved after Hon Mrs Regina IP's motion was passed, the relevant Members thereafter might not move their motions.

The President then ordered a joint debate on the 14 motions.

Hon Cyd HO moved the motion in **Appendix 1** and spoke on the motion.

While Hon Cyd HO was speaking, the President left the chair at 1:25 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on the motion proposed.

Hon Albert HO and Hon James TO, who proposed to move three and four motions respectively to amend the Notice, spoke on their motions.

After Hon James TO had spoken, some people in the Public Gallery clapped their hands. The President's Deputy asked them to keep quiet.

Hon Mrs Regina IP, who proposed to move a motion to amend the Notice, spoke on her motion.

After Hon Mrs Regina IP had spoken, some people in the Public Gallery clapped their hands. The President's Deputy again asked them to keep quiet.

Hon LEE Wing-tat and Hon Audrey EU, who proposed to move four and one motion(s) respectively to amend the Notice, spoke on their motions.

While Hon Audrey EU was speaking, Hon Frederick FUNG sought elucidation of a point raised by Hon Audrey EU in her speech. Hon Audrey EU elucidated and continued to speak.

The Secretary for Development spoke on the motions.

Hon CHAN Kam-lam, Chairman of the Subcommittee on Land (Compulsory Sale for Redevelopment) (Specification of Lower Percentage) Notice, spoke on the motions in his personal capacity as a Member.

While Hon CHAN Kam-lam was speaking, some people in the Public Gallery yelled noisily. The President's Deputy asked them to keep quiet.

Hon CHIM Pui-chung spoke on the motions.

While Hon CHIM Pui-chung was speaking, some people in the Public Gallery clapped their hands.

At 3:45 pm, the President resumed the chair.

The President ordered the people in the Public Gallery to observe the rules of the Council. The President stated that if they disturbed the proceedings of the meeting, he would order them to leave the Chamber.

While Hon CHIM Pui-chung continued to speak, some people in the Public Gallery clapped their hands again. The President ordered them to keep quiet and reiterated that if they disturbed the order of the Council again, he would request them to leave the Chamber immediately without further warning.

Hon CHIM Pui-chung continued to speak.

Eleven other Members and Dr Hon Priscilla LEUNG spoke on the motions.

With the President's permission, Hon Ronny TONG elucidated a point he had made earlier which he considered to be misunderstood by Dr Hon Priscilla LEUNG.

Hon Abraham SHEK spoke on the motions.

Hon Paul CHAN declared that his family members owned old properties in Tai Kok Tsui, which were purchased for investment before 1997. They were not developers and had no intention of acquiring them for redevelopment. In addition, Hon Paul CHAN declared that he was an independent non-executive director of Wharf (Holdings) Limited. He said that the company did not engage in the business of acquisition of old properties for redevelopment. He then spoke on the motions.

Hon Starry LEE spoke on the motions.

While Hon Starry LEE was speaking, the President left the chair at 7:01 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Four other Members spoke on the motions.

The Secretary for Development spoke again.

At 8:05 pm, while the Secretary for Development was speaking, the President resumed the chair.

Hon Albert HO, Hon James TO, Hon Mrs Regina IP, Hon LEE Wing-tat and Hon Audrey EU spoke again.

Hon Cyd HO replied.

Question on Hon Cyd HO's motion put.

Hon Cyd HO claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, three were in favour of the motion, 23 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 15 were in favour of the motion and nine against it (voting record in **Appendix 2**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Land (Compulsory Sale for Redevelopment) (Specification of Lower Percentage) Notice" thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon James TO moved his first motion in **Appendix 3**.

Question on the motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, 11 were in favour of the motion and 16 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 18 were in favour of the motion and six against it (voting record in **Appendix 4**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon Mrs Regina IP moved the motion in **Appendix 5**.

Question on the motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, four were in favour of the motion, 22 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the motion and 10 against it (voting record in **Appendix 6**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon James TO moved his third motion in **Appendix 7**.

Question on the motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion and 25 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the motion and 10 against it (voting record in **Appendix 8**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon James TO moved his fourth motion in **Appendix 9**.

Question on the motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion and 25 against it; while among the Members returned by geographical constituencies through direct elections, 24 were present, 13 were in favour of the motion and 10 against it (voting record in **Appendix 10**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon LEE Wing-tat moved his first motion in **Appendix 11**.

Question on the motion proposed and put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion and 25 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the motion and 10 against it (voting record in **Appendix 12**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon LEE Wing-tat moved his second motion in **Appendix 13**.

Question on the motion proposed and put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion and 25 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 15 were in favour of the motion and nine against it (voting record in **Appendix 14**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon LEE Wing-tat moved his third motion in **Appendix 15**.

Question on the motion proposed and put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion and 25 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 15 were in favour of the motion and nine against it (voting record in **Appendix 16**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon LEE Wing-tat moved his fourth motion in **Appendix 17**.

Question on the motion proposed and put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion and 25 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the motion and 10 against it (voting record in **Appendix 18**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon Albert HO moved his second motion in **Appendix 19**.

Question on the motion proposed and put.

Hon Albert HO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion and 25 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the motion and 10 against it (voting record in **Appendix 20**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon Albert HO moved his third motion in **Appendix 21**.

Question on the motion proposed and put.

Hon James TO claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion and 25 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the motion and 10 against it (voting record in **Appendix 22**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Hon Audrey EU moved the motion in **Appendix 23**.

Question on the motion proposed and put.

Hon Audrey EU claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 27 were present, two were in favour of the motion, 24 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 15 were in favour of the motion and nine against it (voting record in **Appendix 24**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

The President suspended the meeting at 10:30 pm.

Supporting the market for traders running small businesses

Hon Tommy CHEUNG moved the following motion and spoke on the motion:

That, as the Hong Kong economy has yet to see a strong recovery, and the rents and operating costs in the private sector have remained high in recent years, together with ever increasing prices, the market for small businesses has suffered a severe blow, and this has not only increased the life stress of the grassroots, but has also reduced their chances of achieving self-reliance, making it difficult to improve the unemployment situation; as such, this Council urges the Government to support the market for traders running small businesses, so as to preserve their characteristic of providing quality goods at low prices and serve the grassroots, thereby increasing job opportunities; the relevant measures should include:

- (a) to revitalize hawker stalls by expeditiously allocating no less than 70% of the vacant on-street fixed hawker pitches to the existing registered assistants at fixed hawker pitches for running businesses through priority balloting, so as to enable the registered assistants who are familiar with the hawking trade and the stall environment to start businesses on the same streets or in the same districts, so as to bring vitality to the hawker market;
- (b) to increase the room for survival for licensed itinerant hawkers, reasonably reduce the number of illegal hawking blackspots, and study the designation of proposed hawking locations with time limits or conditions, and publish the list of locations concerned through various means, including facsimiles or telephone-recorded messages, for access by itinerant hawkers;
- (c) to strive to preserve the culture of 'dai pai dong' open-air bazaars, to tie in with the promotion focus of the tourism industry and, apart from improving the sanitary facilities of the existing 'dai pai dongs' and planning and developing them afresh, to expeditiously study subsidizing the development of 'dai pai dongs' or open-air markets in remote areas, so as to stimulate the economic activities of the neighbouring communities and create job opportunities for residents in remote areas;
- (d) to affirm the position and function of public markets as facilities serving the grassroots and determine future rent adjustments by using the affordability of the grassroots as one of the principles, so as to ensure that small traders can continue to capitalize on their selling point of providing quality goods at low prices to counter rent increase by The Link and monopolization by supermarkets; and
- (e) to immediately implement a public market enhancement policy and proactively allocate resources to improve the design and business environment of the public markets, including bearing the installation and maintenance costs for air-conditioning facilities in public markets, so as to enhance the competitiveness of small traders.

Question on Hon Tommy CHEUNG's motion proposed.

The President stated that five Members would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the five amendments would be debated together in a joint debate.

Hon Frederick FUNG, Hon Fred LI, Hon WONG Yung-kan, Hon Paul TSE and Dr Hon Priscilla LEUNG, who would move amendments to the motion, spoke on the motion and the amendments.

The Secretary for Food and Health spoke on the motion and the amendments.

Ten Members spoke on the motion and amendments.

Hon Tommy CHEUNG spoke on the amendments.

The Secretary for Food and Health spoke again.

Hon Frederick FUNG moved the following amendment to Hon Tommy CHEUNG's motion:

To delete "as the Hong Kong economy has yet to see a strong recovery" after "That," and substitute with "although the impact of the financial tsunami is gradually subsiding, the Hong Kong economic outlook remains uncertain"; to add "(c) to implement the voluntary surrender scheme for itinerant hawker licences on a long-term basis, including arrangements such as allowing itinerant hawkers who have voluntarily surrendered their licences to select a vacant fixed pitch;" after "access by itinerant hawkers;"; to delete the original "(c)" and substitute with "(d)"; to delete the original "(d)" and substitute with "(e)"; and to delete the original "(e)" and substitute with "(f)".

Question on Hon Frederick FUNG's amendment to Hon Tommy CHEUNG's motion proposed, put and agreed to.

As Hon Frederick FUNG's amendment had been passed, the President granted leave for Hon Fred LI to revise the terms of his amendment.

Hon Fred LI moved the following further amendment to Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG, and explained the revised terms of his amendment to the Council:

To add "the costs of" after "including bearing"; to add "works" after "the installation"; to delete "costs" after "maintenance"; and to add "provided that 65% of the tenants in the markets concerned give consent" after "facilities in public markets".

Question on Hon Fred LI's amendment to Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG proposed, put and agreed to.

As Hon Frederick FUNG's and Hon Fred LI's amendments had been passed, the President granted leave for Hon WONG Yung-kan to revise the terms of his amendment.

Hon WONG Yung-kan moved the following further amendment to Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG and Hon Fred LI:

To add "; (g) to improve the business environment for the hawker stalls and waive the hawker licence fee for one year; and (h) to extend the rent freeze period for public markets for one year" immediately before the full stop.

Question on Hon WONG Yung-kan's amendment to Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG and Hon Fred LI proposed, put and agreed to.

As the amendments of Hon Frederick FUNG, Hon Fred LI and Hon WONG Yungkan had been passed, the President granted leave for Hon Paul TSE to revise the terms of his amendment.

Hon Paul TSE moved the following further amendment to Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG, Hon Fred LI and Hon WONG Yung-kan:

To add "; and (i) to appropriately relax the restrictions on on-street busking and hawking in various districts (particularly in places with tourism value or features)" immediately before the full stop.

Question on Hon Paul TSE's amendment to Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG, Hon Fred LI and Hon WONG Yung-kan proposed, put and agreed to.

As the amendments of Hon Frederick FUNG, Hon Fred LI, Hon WONG Yung-kan and Hon Paul TSE had been passed, the President granted leave for Dr Hon Priscilla LEUNG to revise the terms of her amendment.

Dr Hon Priscilla LEUNG moved the following further amendment to Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG, Hon Fred LI, Hon WONG Yung-kan and Hon Paul TSE, and explained the revised terms of her amendment to the Council:

To add "; (j) to improve the sanitary conditions of the markets, step up advertising and promotion, and enhance the ancillary facilities for business operation in the markets; (k) if rent reduction or waiver are proposed in the Budget of a certain financial year, to consider also including commercial tenants of public markets as the target beneficiaries; and (l) to use the economic condition of the current year and employment market situation as reference indicators when adjusting the levels of rent of public markets" immediately before the full stop.

Question on Dr Hon Priscilla LEUNG's amendment to Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG, Hon Fred LI, Hon WONG Yung-kan and Hon Paul TSE proposed and put.

Hon Ronny TONG claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, 12 were in favour of the amendment and nine abstained; while among the Members returned by geographical constituencies through direct elections, 22 were present, 19 were in favour of the amendment and two abstained (voting record in **Appendix 25**). Since the question was agreed by a majority of each of the two groups of Members present, he declared that the amendment was passed.

Hon Tommy CHEUNG replied.

Question on Hon Tommy CHEUNG's motion as amended by Hon Frederick FUNG, Hon Fred LI, Hon WONG Yung-kan, Hon Paul TSE and Dr Hon Priscilla LEUNG put and agreed to.

Adding impetus for promoting upward social mobility

Hon Mrs Sophie LEUNG moved the following motion and spoke on the motion:

That, the subject of 'upward social mobility' has recently become the concern of various sectors of the community; upward social mobility involves factors such as personal ability and attitude, etc., and government support is also indispensible; in this connection, this Council urges the Government:

- (a) to promote education which is steered by 'inspiration' in place of 'impartation' mode of teaching, to develop creativity and independent analytical ability among students, with a view to establishing proper attitudes towards life;
- (b) to expand the types of existing education programmes, promote diversified development, increase the opportunities for young people to study abroad and participate in summer exchange programmes and on-the-job training, etc., and provide further support to young people from poor families, so as to enhance the quality of education for the whole community;
- (c) to encourage the public to fulfil their personal potentials and avoid introducing policies which impede the fulfilment of potentials;

- (d) to promote in the Government and various sectors of the community the development of a 'from the heart' attitude of doing things, consolidate Hong Kong's core values of 'being proactive and progressive', and encourage young people to strive harder for improvement and self-reliance, so as to prevent the development of a mentality of dependency;
- (e) to promote upward social mobility through developing the economy and new industries;
- (f) to assist the younger generation in purchasing their homes through measures such as revitalizing the secondary market of Home Ownership Scheme flats and re-launching the Home Starter Loan Scheme, etc.; and
- (g) to establish communication channels such as new media for young people to express views and actively participate in social affairs.

Question on Mrs Sophie LEUNG's motion proposed.

The President stated that eight Members intended to move amendments to the motion. In accordance with the Rules of Procedure, the motion and the eight amendments would be debated together in a joint debate.

Hon Frederick FUNG and Hon LEE Wing-tat, who intended to move amendments to the motion, spoke on the motion and the amendments.

With the President's permission, Hon Frederick FUNG elucidated a point he had made earlier which he considered to be misunderstood by Hon LEE Wing-tat.

Hon CHEUNG Kwok-che, Hon WONG Sing-chi, Hon Miriam LAU and Hon Ronny TONG, who intended to move amendments to the motion, spoke on the motion and the amendments.

While Hon Ronny TONG was speaking, the President left the chair at 1:00 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Hon CHAN Kin-por and Hon Starry LEE, who intended to move amendments to the motion, spoke on the motion and the amendments.

The Secretary for Education and the Secretary for Labour and Welfare spoke on the motion and the amendments.

Thirteen Members spoke on the motion and the amendments.

Hon Mrs Sophie LEUNG spoke on the amendments.

At 3:12 pm, while Hon Mrs Sophie LEUNG was speaking, the President resumed the chair.

The Secretary for Education and the Secretary for Labour and Welfare spoke again.

Hon Frederick FUNG moved the following amendment to Hon Mrs Sophie LEUNG's motion:

To delete "recently become" after "has" and substitute with "been"; to add "for a long time" after "the concern of various sectors of the community"; to add "(c) to break the vicious cycle of inter-generational poverty and provide support for poor families on all fronts;" after "the whole community;"; to delete the original "(c)" and substitute with "(d)"; to add "create a fair social environment," before "encourage the public"; to delete the original "(d)" and substitute with "(e)"; to delete the original "(e)" and substitute with "(f)"; to delete the original "(f)" and substitute with "(g)"; to add "resume the construction of Home Ownership Scheme ('HOS') flats and" before "assist the younger generation"; to delete "Home Ownership Scheme" after "market of" and substitute with "HOS"; to delete "and" after "the Home Starter Loan Scheme, etc.;"; to delete the original "(g)" and substitute with "(h)"; to add "enhance the level of participation of young people in various statutory and advisory bodies, and" before "establish"; to delete "for young people to express views and" after "new media" and substitute with "to listen sincerely to young people's views and let them"; and to add "; and (i) to vigorously develop social enterprises so as to provide alternative development opportunities for those workers who have not been absorbed by the free market" immediately before the full stop.

Question on Hon Frederick FUNG's amendment to Hon Mrs Sophie LEUNG's motion proposed and put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 17 were present, 14 were in favour of the amendment, one against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, 19 were in favour of the amendment and one abstained (voting record in **Appendix 26**). Since the question was agreed by a majority of each of the two groups of Members present, he declared that the amendment was passed.

The President stated that Hon LEE Wing-tat and Hon Miriam LAU had indicated that they would withdraw their amendments to Hon Mrs Sophie LEUNG's motion, if Hon Frederick FUNG's amendment was passed. Hon LEE Wing-tat and Hon Miriam LAU had therefore withdrawn their amendments.

As Hon Frederick FUNG's amendment had been passed, the President granted leave for Hon CHEUNG Kwok-che to revise the terms of his amendment.

Hon CHEUNG Kwok-che moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG:

To add "; (j) to respect the right of young people to achieve self-development; and (k) to re-establish the Commission on Poverty to actively study and formulate long-term policies to solve the problem of inter-generational poverty" immediately before the full stop.

Question on Hon CHEUNG Kwok-che's amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG proposed and put.

Hon Miriam LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 17 were present, nine were in favour of the amendment, one against it and seven abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, 15 were in favour of the amendment and four abstained (voting record in **Appendix 27**). Since the question was agreed by a majority of each of the two groups of Members present, he declared that the amendment was passed.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Adding impetus for promoting upward social mobility" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

As Hon Frederick FUNG's and Hon CHEUNG Kwok-che's amendments had been passed, the President granted leave for Hon WONG Sing-che to revise the terms of his amendment.

Hon WONG Sing-che moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG and Hon CHEUNG Kwok-che, and explained the revised term of his amendment to the Council:

To add "; (1) to develop critical thinking personality among students to distinguish between right and wrong; (m) to consolidate Hong Kong's core values of 'caring about the underprivileged, striving for justice, equality, democracy and rule of law'; (n) to help small and medium enterprises through developing the economy and new industries, so as to prevent large consortiums and real estate developers from monopolizing opportunities for development; (o) to reduce housing expenses through increasing the supply of land; (p) when appointing advisory committee members, the Government should consider the person's ability and not adopt family status and wealth as factors of consideration so that the youth and the grassroots will have equal opportunities to participate; to implement general and fair elections, abolish functional constituencies, so that young people will have more opportunities to participate in political affairs, and the underprivileged will have more edge and opportunities for upward mobility; (q) to transfer the income of a Comprehensive Social Security Assistance ('CSSA') recipient that exceeds the limit of disregarded earning to a savings accounts, and return the total sum to the recipient when the cumulative sum exceeds twice the ceiling of household income, so that such recipients can leave the CSSA net and have more opportunities for upward mobility; (r) to formulate singleparent family policies and through catering for the needs of single-parent families in different policy areas such as housing and taxation, etc. to increase their opportunities for upward social mobility; and (s) to continuously and vigorously deploy resources for education and various training and re-training programmes, and ensure that people in need are given the opportunities to receive education and training" immediately before the full stop.

Question on Hon WONG Sing-che's amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG and Hon CHEUNG Kwok-che proposed and put.

Hon IP Kwok-him claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 17 were present, two were in favour of the amendment, 13 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, 13 were in favour of the amendment and six against it (voting record in **Appendix 28**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

As Hon Frederick FUNG's and Hon CHEUNG Kwok-che's amendments had been passed, the President granted leave for Hon Ronny TONG to revise the terms of his amendment.

Hon Ronny TONG moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG and Hon CHEUNG Kwok-che:

To add "; and (l) to increase the number of subsidized university places to train local talents" immediately before the full stop.

Question on Hon Ronny TONG's amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG and Hon CHEUNG Kwok-che proposed, put and agreed to.

As the amendments of Hon Frederick FUNG, Hon CHEUNG Kwok-che and Hon Ronny TONG had been passed, the President granted leave for Hon CHAN Kinpor to revise the terms of his amendment.

Hon CHAN Kin-por moved the following further amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG, Hon CHEUNG Kwok-che and Hon Ronny TONG:

To add "; and (m) to introduce tax concessions and other appealing measures for running businesses, so as to strive for business organizations around the world to establish their regional business headquarters in Hong Kong, thereby creating more employment opportunities, providing diversified posts, developing room for upward mobility for young people and their international outlook" immediately before the full stop.

Question on Hon CHAN Kin-por's amendment to Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG, Hon CHEUNG Kwok-che and Hon Ronny TONG proposed and put.

Hon WONG Sing-che claimed a division. The President then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 17 were present, 15 in favour of the amendment and two abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, six were in favour of the amendment and 13 abstained (voting record in **Appendix 29**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

The President stated that Hon Starry LEE had withdrawn her amendment.

Hon Mrs Sophie LEUNG replied.

Question on Hon Mrs Sophie LEUNG's motion as amended by Hon Frederick FUNG, Hon CHEUNG Kwok-che and Hon Ronny TONG put and agreed to.

Next meeting
