#### First Reading

Deposit Protection Scheme (Amendment) Bill 2010

The Bill was read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

## Second Reading

Deposit Protection Scheme (Amendment) Bill 2010

The Secretary for Financial Services and the Treasury moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Appropriation Bill 2010

#### Resumption of Second Reading debate

The debate on the motion for the Second Reading which was moved on 24 February 2010 resumed.

The Chief Secretary for Administration, the Secretary for Transport and Housing and the Secretary for Labour and Welfare spoke on the motion.

The Financial Secretary replied.

Question on the Second Reading put.

Hon Emily LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 49 Members were present, 32 were in favour of the motion and 16 against it (voting record in **Appendix I**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the second time and committed to a committee of the whole Council.

#### Committee stage

The Council went into Committee and considered the Appropriation Bill 2010.

In accordance with Rule 68 of the Rules of Procedure, the Committee first considered the schedule to the Bill.

Question that the sums for heads 21 to 28, 30, 31, 33, 37, 39, 42, 44 to 49, 51, 53, 55, 59, 60, 62, 63, 72, 74, 76, 78, 79, 80, 82, 90, 91, 92, 94, 95, 96, 100, 106, 112, 114, 116, 118, 120, 121, 136 to 140, 142, 143, 147, 148, 151, 152, 155, 159, 160, 162, 166, 168, 169, 170, 173, 174, 180, 181, 184, 186, 188, 190 and 194 stand part of the schedule proposed, put and agreed to.

Question that the sum for head 70 stand part of the schedule proposed.

Hon Audrey EU moved that head 70 be reduced by \$5,940,000 in respect of subhead 000 and spoke on the amendment.

While Hon Audrey EU was speaking, the Chairman left the chair at 12:29 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Three Members and Dr Hon Priscilla LEUNG spoke on the amendment.

At 1:27 pm, while Dr Hon Priscilla LEUNG was speaking, the Chairman resumed the chair.

Six more Members spoke on the amendment.

The Secretary for Security spoke on the amendment.

Hon Audrey EU spoke again.

Question on the amendment put.

Hon Audrey EU claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

While the division bell was ringing, Hon Paul TSE declared that he had provided legal service relating to the business of investment immigrant consultants.

Hon Paul CHAN declared that the company in which his wife worked provided investment immigrant-related services.

Hon Miriam LAU declared that she had assisted some investment immigrants in the legal formalities for purchasing properties.

Hon Mrs Regina IP declared that during her tenure of office as the Secretary for Security, she was responsible for promoting the Capital Investment Entrant Scheme.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, two were in favour of the amendment, 19 against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, five were in favour of the amendment and 18 against it (voting record in **Appendix II**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the other provisions of the Appropriation Bill 2010 or amendments thereto, the Committee do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Question that the sum for head 70 stand part of the schedule put and agreed to.

The Chairman stated that as Hon James TO was unable to attend the meeting due to indisposition, Mr TO had therefore withdrawn the notices of his amendments. The Chairman added that he had waived the notice required for Hon Albert HO to move three amendments during the Committee stage. Hon Albert HO's three amendments were the same as the three amendments originally proposed by Hon James TO.

Question that the sum for head 122 stand part of the schedule proposed.

Hon Albert HO moved that head 122 be reduced by \$44,920,000 in respect of subhead 000 and spoke on the amendment.

Dr Hon Joseph LEE declared that he was a Vice-Chairman of the Independent Police Complaints Council. He then spoke on the amendment.

Two other Members spoke on the amendment.

The Secretary for Security spoke on the amendment.

Hon Albert HO spoke again.

Question on the amendment put.

Hon Albert HO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 20 were present, two were in favour of the amendment and 18 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, 11 were in favour of the amendment and 11 against it (voting record in **Appendix III**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Albert HO moved that head 122 be reduced by \$14,798,400 in respect of subhead 000 and spoke on the amendment.

Two Members spoke on the amendment.

The Secretary for Security spoke on the amendment.

Hon Albert HO spoke again.

Question on the amendment put.

Hon Albert HO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, two were in favour of the amendment, 20 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 23 were present, 11 were in favour of the amendment and 11 against it (voting record in **Appendix IV**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Albert HO moved that head 122 be reduced by \$80,000,000 in respect of subhead 103 and spoke on the amendment.

Two Members spoke on the amendment.

The Secretary for Security spoke on the amendment.

Hon Albert HO spoke again.

Question on the amendment put.

Hon Albert HO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, two were in favour of the amendment and 21 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, 12 were in favour of the amendment and 10 against it (voting record in **Appendix V**). While Hon Frederick FUNG was speaking, the Chairman left the chair at 6:10 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Seven more Members spoke on the amendment.

The Secretary for Financial Services and Treasury spoke on the amendment.

Hon LEE Cheuk-yan spoke again.

At 7:14 pm, while Hon LEE Cheuk-yan was speaking, the Chairman resumed the chair.

Question on the amendment put.

Hon Cyd HO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 22 were present, four were in favour of the amendment and 18 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, 12 were in favour of the amendment and 10 against it (voting record in **Appendix VI**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Audrey EU spoke again.

Question on the amendment put.

Hon Audrey EU claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

Question on the amendment put.

Hon Cyd HO claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 22 were present, four were in favour of the amendment and 18 against it; while among the Members returned by geographical constituencies through direct elections, 21 were present, 10 were in favour of the amendment and 10 against it (voting record in **Appendix VIII**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that the sum for head 156 stand part of the schedule put and agreed to.

Question that the sum for head 158 stand part of the schedule proposed.

Hon LEE Wing-tat moved that the head 158 be reduced by \$281,666 in respect of subhead 000 and spoke on the amendment.

Three Members spoke on the amendment.

The Secretary for Financial Services and Treasury spoke on the amendment.

Hon LEE Wing-tat spoke again.

Question on the amendment put.

Hon LEE Wing-tat claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, four were in favour of the amendment and 20 against it; while among the Members returned by geographical constituencies through direct elections, 20 were present, nine were in favour of the amendment and 10 against it (voting record in **Appendix IX**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that the sum for head 158 stand part of the schedule put and agreed to.

The Chairman suspended the meeting at 10:00 pm.

The Committee resumed at 9:00 am on 22 April 2010.

Question that the sum for head 163 stand part of the schedule proposed.

Hon WONG Kwok-hing moved that the head 163 be reduced by \$147,000,000 in respect of subhead 000 and spoke on the amendment.

Four Members spoke on the amendment.

Dr Hon Priscilla LEUNG spoke for the second time.

Nine more Members spoke on the amendment.

Hon Ronny TONG spoke for the second time.

Another Member spoke on the amendment.

Hon Paul TSE spoke for the second time.

While Hon Paul TSE was speaking, Hon Audrey EU sought elucidation of a point raised by Hon Paul TSE in his speech. Hon Paul TSE elucidated and continued to speak.

The Chairman reminded Members that their speeches should not deviate from the question under debate, and Members should not repeat what they had already covered in their earlier speeches.

Dr Hon Priscilla LEUNG spoke for the third time.

While Dr Hon Priscilla LEUNG was speaking, Hon Abraham SHEK raised a point of order that the speeches of Dr LEUNG and many other Members had deviated from the question under debate.

The Chairman stated that he had again reminded Members not to deviate from the question under debate. The Chairman asked Dr Hon Priscilla LEUNG to continue to speak.

Dr Hon Priscilla LEUNG then continued to speak.

Another Member spoke on the amendment.

Dr Hon Margaret NG spoke for the second time.

While Dr Hon Margaret NG was speaking, Hon Abraham SHEK raised a point of order that Dr NG's speech had deviated from the question under debate. The Chairman considered that Dr Hon Margaret NG's speech did not contravene the Rules of Procedure.

Dr Hon Margaret NG then continued to speak.

Hon Ronny TONG elucidated a point he had made earlier which he considered to be misunderstood by Dr Hon Margaret NG.

Another Member spoke on the amendment.

Hon Paul TSE spoke for the third time.

The Chairman stated that while Members might speak more than once during the Committee stage of the bill, Members should make good use of their speaking time and should not seek to respond whenever different views were expressed by other Members. If they did so and repeated what they had already covered in their earlier speeches each time they made a response, the debate would unnecessarily be prolonged.

Two more Members spoke on the amendment.

The Secretary for Constitutional and Mainland Affairs spoke on the amendment.

Hon WONG Kwok-hing spoke again.

Question on the amendment put.

Hon WONG Kwok-hing claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 49(5) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 29 were present, six were in favour of the amendment and 23 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, eight were in favour of the amendment and 14 against it (voting record in **Appendix X**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that the sum for head 163 stand part of the schedule put and agreed to.

Question that the schedule stand part of the Bill put and agreed to.

Question that clauses 1 and 2 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

### **Third Reading**

The Financial Secretary reported that

the Appropriation Bill 2010

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed and put.

Hon WONG Kwok-hing claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that 52 Members were present, 35 were in favour of the motion and 16 against it (voting record in **Appendix XI**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the third time and passed.
