2. Hon Albert CHAN asked Question 2.

The Secretary for Security replied.

Six Members asked supplementary questions and the Secretary for Security replied.

3. Dr Hon Joseph LEE asked Question 3.

The Secretary for Labour and Welfare replied.

Five Members asked supplementary questions and the Secretary for Labour and Welfare replied.

4. Hon Tanya CHAN asked Question 4.

The Secretary for Home Affairs replied.

Five Members asked supplementary questions and the Secretary for Home Affairs replied.

5. Hon LEUNG Kwok-hung asked Question 5.

While Hon LEUNG Kwok-hung was asking his question, the President left the chair at 12:38 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

The Secretary for Labour and Welfare replied.

Four Members asked supplementary questions and the Secretary for Labour and Welfare replied.

#### **Bills**

#### First Reading

Supplementary Appropriation (2009-2010) Bill

The Bill was read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

## **Second Reading**

Supplementary Appropriation (2009-2010) Bill

The Secretary for Financial Services and the Treasury moved the Second Reading and spoke on the Bill.

At 1:22 pm, while the Secretary for Financial Services and the Treasury was speaking, the President resumed the chair.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

## **Motions**

When the Secretary for Constitutional and Mainland Affairs was called upon to move the Motion concerning the Amendment to the Method for the Selection of the Chief Executive, Hon Audrey EU raised a point of order requesting the President to direct that the Motion concerning the Amendment to the Method for the Selection of the Chief Executive and the Motion concerning the Amendment to the Method for the Formation of the Legislative Council and its Voting Procedures, which were to be moved at the Council meeting, should be referred to the Subcommittee on Package of Proposals for the Methods for Selecting the Chief Executive and for Forming the Legislative Council in 2012 under the House Committee for further deliberation and consideration, in the light of the recent significant development. Ms EU added that Rule 29 of the Rules of Procedure should be observed and since the contents of the two motions to be moved at the Council meeting were different from the versions considered and discussed by the public and the Subcommittee of this Council, she was of the view that the Government should be required to give this Council 12 clear days of notice under Rule 29 of the Rules of Procedure.

Dr Hon Margaret NG also raised a point of order that the Chairman of the House Committee should be consulted given the significant changes made to the contents of the motion.

The President said that he would suspend the meeting and consider the points of order.

The President suspended the meeting at 1:35 pm.

The Council resumed at 1:43 pm.

In respect of the points of order raised by Hon Audrey EU and Dr Hon Margaret NG, the President stated that in accordance with Rule 54(5) of the Rules of Procedure, for a bill to resume the second reading debate, one of the requirements was that the Member concerned or the public officer who was in charge of the bill should, after consultation with the Chairman of the House Committee, give notice to the Clerk to the Legislative Council.

The President added that Rule 54 of the Rules of Procedure stipulated the arrangements for resumption of the Second Reading of bills, while those for the giving of notice for motions were set out in Rule 29, not Rule 54. The President stated that under Rule 29(1), the notice requirement for a motion was not less than 12 clear days before the day on which the motion was to be moved. The President said that the Administration had given notice of the aforesaid motions 12 clear days before the Council meeting. As regards the development which had taken place, it did not affect the contents of the motions presented before the Council and to be moved by the Secretary for Constitutional and Mainland Affairs. The contents were the same as those in the motions for which notice was given by the Administration 12 clear days ago; hence there was no breach of Rule 29 of the Rules of Procedure.

Hon Albert CHAN and Dr Hon Margaret NG sought clarification from the President on his ruling regarding the contents of the motions and the application of Rule 29 of the Rules of Procedure. The President reiterated that unless a consensus had been reached by Members that specific amendments should be made to the Rules of Procedure to stipulate what else should be considered other than the wording of the motions to deem that notice had been given, notifications given in compliance with the Rules of Procedure were deemed to be notice given.

# Motion concerning the Amendment to the Method for the Selection of the Chief Executive

The Secretary for Constitutional and Mainland Affairs moved the following motion and spoke on the motion:

Pursuant to Article 7 of Annex I to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China, the Interpretation by the Standing Committee of the National People's Congress of Article 7 of Annex I and Article III of Annex II to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China of 6 April 2004, and the Decision of the Standing Committee of the National People's Congress on Issues relating to the Methods for Selecting the Chief Executive of the Hong Kong Special Administrative Region and for Forming the Legislative Council of the Hong Kong Special Administrative Region in the year 2012 and on Issues relating to Universal Suffrage of 29 December 2007, the "(Draft) Amendment to Annex I to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China Concerning the Method for the Selection of the Chief Executive of the Hong Kong Special Administrative Region" appended to this Motion is hereby endorsed by this Council by a two-thirds majority of all Members.

**Annex** 

(Draft) Amendment to Annex I to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China Concerning the Method for the Selection of the Chief Executive of the Hong Kong Special Administrative Region

1. The Election Committee to elect the fourth term Chief Executive in 2012 shall be composed of 1200 members from the following sectors:

Industrial, commercial and financial sectors	300
The professions	300
Labour, social services, religious and other sectors	300
Members of the Legislative Council, representatives of members of the District Councils, representatives of the Heung Yee Kuk, Hong Kong deputies to the National People's Congress, and representatives of Hong Kong members of the National Committee of the Chinese People's Political Consultative Conference	300

The term of office of the Election Committee shall be five years.

2. Candidates for the office of Chief Executive may be nominated jointly by not less than 150 members of the Election Committee. Each member may nominate only one candidate.

Question on the motion proposed.

The Chief Secretary for Administration spoke on the motion.

While the Chief Secretary for Administration was speaking, Hon LEUNG Kwok-hung sought elucidation of a point raised by the Chief Secretary for Administration in his speech. The Chief Secretary for Administration did not accede to the request and continued to speak.

Hon Cyd HO spoke on the motion and moved the following motion under Rule 40(1) of the Rules of Procedure:

That the debate on the Motion concerning the Amendment to the Method for the Selection of the Chief Executive be now adjourned.

The President stated that according Rule 40(1) of the Rules of Procedure, he should deal with Hon Cyd HO's motion first.

Question on Hon Cyd HO's motion proposed.

The Secretary for Constitutional and Mainland Affairs spoke on the motion.

Ten Members and Hon LEUNG Kwok-hung spoke on the motion.

While Hon LEUNG Kwok-hung was speaking, the President had repeatedly reminded him that his speech should not deviate from the question under debate.

Another Member and Dr Hon Priscilla LEUNG speak on the motion.

While Dr Hon Priscilla LEUNG was speaking, the President reminded her that her speech should not deviate from the question under debate. While Dr LEUNG was continuing her speech, some people in the Public Gallery yelled noisily. The President asked them to keep quiet. As they ignored the President's direction, the President ordered them to leave the Chamber immediately. Pursuant to the President's order, the people concerned were escorted out of the Public Gallery by security staff.

Another Member and Hon WONG Yuk-man spoke on the motion.

While Hon WONG Yuk-man was speaking, the President reminded him that his speech should not deviate from the question under debate.

Another Member and Hon LEE Wing-tat spoke on the motion.

With the President's permission, Hon Paul TSE elucidated a point he had made earlier which he considered to be misunderstood by Hon LEE Wing-tat.

The Secretary for Constitutional and Mainland Affairs spoke again.

The Secretary for Justice spoke on the motion.

Hon Cyd HO replied.

The President stated that in accordance with the Rule 40(2) of Rules of Procedure, when a motion that the debate be now adjourned was agreed to, the debate on the question then before the Council should stand adjourned and the Council should proceed to the next item of business. If the motion that the debate be now adjourned was negatived, the Council would continue to debate the Motion concerning the Amendment to the Method for the Selection of the Chief Executive.

Question on Hon Cyd HO's motion put.

Hon Cyd HO claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 30 were present, six were in favour of the motion and 24 against it; while among the Members returned by geographical constituencies through direct elections, 29 were present, 18 were in favour of the motion and 10 against it (voting record in **Appendix I**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

The President stated that the Council continued to debate the Motion concerning the Amendment to the Method for the Selection of the Chief Executive.

Hon Albert HO spoke on the motion.

While Hon Albert HO was speaking, the President left the chair at 6:26 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Hon Ronny TONG spoke on the motion.

While Hon Ronny TONG was speaking, Hon LEUNG Kwok-hung and Hon Albert CHAN sought elucidation of some points raised by Hon Ronny TONG in his speech respectively. Hon Ronny TONG elucidated and continued to speak.

A Member and Hon Albert CHAN spoke on the motion.

While Hon Albert CHAN was speaking, Hon Albert HO sought elucidation of a point raised by Hon Albert CHAN in his speech. Hon Albert CHAN elucidated and continued to speak.

Another Member and Hon Andrew CHENG spoke on the motion.

At 7:35 pm, while Hon Andrew CHENG was speaking, the President resumed the chair.

Three more Members and Hon CHEUNG Man-kwong spoke on the motion.

While Hon CHEUNG Man-kwong was speaking, Hon LEUNG Kwok-hung sought elucidation of a point raised by Hon CHEUNG Man-kwong in his speech. Hon CHEUNG Man-kwong did not accede to the request and continued to speak.

Seven other Members spoke on the motion.

The President suspended the meeting at 10:10 pm.

\* \* \* \* \* \*

The Council resumed at 9:00 am on 24 June 2010.

Thirteen Members and Hon Starry LEE spoke on the motion.

While Hon Starry LEE was speaking, the President left the chair at 12:15 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Hon Fred LI spoke on the motion.

While Hon Fred LI was speaking, the President's Deputy reminded him that his speech should not deviate from the question under debate.

Four other Members and Hon KAM Nai-wai spoke on the motion.

At 1:35 pm, while Hon KAM Nai-wai was speaking, the President resumed the chair.

The Secretary for Justice spoke on the motion.

The Secretary for Constitutional and Mainland Affairs replied.

The President reminded Members that, under Article 7 of Annex I to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China, the motion required the endorsement of a two-thirds majority of all the Members of the Council.

Question on the motion put.

Hon Albert CHAN claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that there were 60 Members present, 46 were in favour of the motion and 13 against it (Voting record in **Appendix II**). Since the question was agreed by a two-thirds majority of all the Members of the Council, he declared that the motion was endorsed by a two-thirds majority of all the Members of the Council.

Motion concerning the Amendment to the Method for the Formation of the Legislative Council and its Voting Procedures

Secretary for Constitutional and Mainland Affairs moved the following motion and spoke on the motion:

Pursuant to Article III of Annex II to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China, the Interpretation by the Standing Committee of the National People's Congress of Article 7 of Annex I and Article III of Annex II to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China of 6 April 2004, and the Decision of the Standing Committee of the National People's Congress on Issues relating to the Methods for Selecting the Chief Executive of the Hong Kong Special Administrative Region and for Forming the Legislative Council of the Hong Kong Special Administrative Region in the year 2012 and on Issues relating to Universal Suffrage of 29 December 2007, the "(Draft) Amendment to Annex II to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China Concerning the Method for the Formation of the Legislative Council of the Hong Kong Special Administrative Region and its Voting Procedures" appended to this Motion is hereby endorsed by this Council by a two-thirds majority of all Members.

#### **Annex**

(Draft) Amendment to Annex II to the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China Concerning the Method for the Formation of the Legislative Council of the Hong Kong Special Administrative Region and its Voting Procedures

The fifth term Legislative Council in the year 2012 shall be composed of 70 members, and the composition shall be as follows:

Members returned by functional constituencies 35

Members returned by geographical constituencies 35

through direct elections

Question on the motion proposed.

The Chief Secretary for Administration spoke on the motion.

Seventeen Members and Hon Jeffrey LAM spoke on the motion.

While Hon Jeffrey LAM was speaking, the President left the chair at 6:12 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Six other Members and Hon Cyd HO spoke on the motion.

At 7:37 pm, while Hon Cyd HO was speaking, the President resumed the chair.

Nine more Members and Hon WONG Yung-kan spoke on the motion.

While Hon WONG Yung-kan was speaking, a man in the Public Gallery yelled noisily. The President ordered him to keep quiet.

The President suspended the meeting at 9:50 pm.

\* \* \* \* \* \*

The Council resumed at 9:00 am on 25 June 2010.

Hon WONG Yung-kan continued to speak on the motion.

Two Members and Hon CHIM Pui-chung spoke on the motion.

While Hon CHIM Pui-chung was speaking, Dr Hon Margaret NG raised a point of order that under the Rules of Procedure, Members were not allowed to impute improper motives to another Member. Dr NG was concerned that Mr CHIM had implied in his speech that some Members had some sort of motives or purposes.

Dr Hon Margaret NG further requested the President to rule whether Hon CHIM Puichung had imputed improper motives to her in his speech.

The President ruled that Hon CHIM Pui-chung had imputed improper motive to another Member of this Council in his speech and requested Mr CHIM to withdraw the remark concerned.

Hon CHIM Pui-chung had refused to withdraw the remark concerned.

Hon Paul TSE sought clarification from the President on the interpretation of Members imputing improper motives to another Member during Council meetings.

The President suspended the meeting at 9:50 am.

The Council resumed at 10:00 am.

The President said that under the Rules of Procedure, Members should not use offensive or insulting language about other Members and government officials, and should not impute improper motives to another Member. The President further said that when there were breaches of the Rules of Procedures or when Members stated that the Rules of Procedures had been breached, he would have to deal with the situation.

Hon CHIM Pui-chung indicated that he did not intend to impute any improper motives to Hon LEE Cheuk-yan and continued to speak.

Three other Members and Hon LAU Kong-wah spoke on the motion.

With the President's permission, Hon Alan LEONG elucidated a point he had made earlier which he considered to be misunderstood by Hon LAU Kong-wah.

Hon LEUNG Kwok-hung spoke on the motion.

While Hon LEUNG Kwok-hung was speaking, Hon CHIM Pui-chung requested the President to rule whether the remark made by Hon LEUNG Kwok-hung in his speech had imputed improper motives to Hon CHEUNG Man-kwong.

The President ruled that Hon LEUNG Kwok-hung did not impute improper motives to Hon CHEUNG Man-kwong.

While Hon LEUNG Kwok-hung was continuing his speech, Hon TAM Yiu-chung raised a point of order on whether Hon LEUNG Kwok-hung had used insulting language about Hon LAU Kong-wah.

The President said that he did not consider that Hon LEUNG Kwok-hung had breached the Rules of Procedure when making his speech. However, he reminded Hon LEUNG Kwok-hung that he should not use offensive or insulting language about other Members in his speech.

Hon LEUNG Kwok-hung continued to speak.

A Member and Hon Audrey EU spoke on the motion.

While Hon Audrey EU was speaking, the President left the chair at 11:50 am temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

With the President's Deputy's permission, Dr Hon PAN Pey-chyou elucidated a point he had made earlier which he considered to be misunderstood by Hon Audrey EU.

Three Members and Hon Mrs Sophie LEUNG spoke on the motion.

At 12:45 pm, while Hon Mrs Sophie LEUNG was speaking, the President resumed the chair.

The Secretary for Justice spoke on the motion.

The Secretary for Constitutional and Mainland Affairs replied.

While the Secretary for Constitutional and Mainland Affairs was speaking, Hon WONG Yuk-man and Hon LEUNG Kwok-hung interrupted him. The President ordered them to sit down and stop speaking. Hon LEUNG Kwok-hung ignored the President's warning, and held a placard in his hand and walked towards the President. The President ordered him to withdraw from the Chamber immediately. Pursuant to the President's order, Hon LEUNG Kwok-hung was escorted out of the Chamber by the Clerk and security staff.

The Secretary for Constitutional and Mainland Affairs continued to speak.

Question on the motion put.

Hon Andrew CHENG claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that there were 59 Members present, 46 were in favour of the motion and 12 against it (Voting record in **Appendix III**). Since the question was agreed by a two-thirds majority of all the Members of the Council, he declared that the motion was endorsed by a two-thirds majority of all the Members of the Council.

Hon Albert CHAN stood up to speak. He expressed strong dissatisfaction with the voting result, and then walked out of the meeting in protest of the passage of the motion.

## **Members' Motions**

Proposed resolution under the Interpretation and General Clauses Ordinance

Hon Miriam LAU moved the following motion and spoke on the motion:

RESOLVED that in relation to the Tate's Cairn Tunnel Ordinance (Amendment of Schedule) Notice 2010, published in the Gazette as Legal Notice No. 67 of 2010 and laid on the table of the Legislative Council on 26 May 2010, the period for amending subsidiary legislation referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) be extended under section 34(4) of that Ordinance to the meeting of 14 July 2010.

Question on the motion proposed, put and agreed to.

## Motion under Rule 49E(2) of the Rules of Procedure

Hon Miriam LAU moved the following motion and spoke on the motion:

That this Council takes note of Report No. 14/09-10 of the House Committee laid on the Table of the Council on 23 June 2010 in relation to the subsidiary legislation and instrument(s) as listed below:

## Item Number Title of Subsidiary Legislation or Instrument

(1) Fugitive Offenders (South Africa) Order (L.N. 43/2010).

Question on the motion proposed.

Hon James TO spoke on the motion as the Chairman of the Subcommittee on Fugitive Offenders (South Africa) Order and Mutual Legal Assistance in Criminal Matters (South Africa) Order.

The Secretary for Security spoke on the motion.

The President stated that in accordance with Rule 49E(9) of the Rules of Procedure, he would not put any question on the motion.

## Legislating for 'standard working hours'

Dr Hon LEUNG Ka-lau moved the following motion and spoke on the motion:

That, as Hong Kong is in general an affluent and civilized society, yet some employees still need to work long hours, adversely affecting their personal health and family life and giving rise to many social problems, this Council urges the Government to legislate for 'standard working hours' according to the principles of fairness, flexibility, and having regard to the business environment and competitiveness of Hong Kong.

Question on Dr Hon LEUNG Ka-lau's motion proposed.

The President stated that five Members intended to move amendments to the motion. Since Hon LEUNG Kwok-hung could not attend the meeting and move his amendment, four Members would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the amendments would be debated together in a joint debate.

Hon WONG Sing-chi, who would move an amendment, spoke on the motion and the amendments.

While Hon WONG Sing-chi was speaking, the President left the chair at 2:00 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Hon IP Wai-ming, Hon LI Fung-ying and Hon LEE Cheuk-yan, who intended to move amendments, spoke on the motion and the amendments.

The Secretary for Labour and Welfare spoke on the motion and the amendments.

Fifteen Members spoke on the motion and the amendments.

Dr Hon LEUNG Ka-lau spoke on the amendments.

The Secretary for Labour and Welfare spoke again.

Hon WONG Sing-chi moved the following amendment to Dr Hon LEUNG Ka-lau's motion:

To delete "as Hong Kong" after "That," and substitute with "an ideal life pattern should allow an even distribution of time for work, rest and activities to facilitate a balanced development of the various aspects of a person; however, while Hong Kong nowadays"; to delete "yet" after "society,"; to add "; in this connection" after "social problems"; and to add ", stipulating that the 'standard working hours' be 44 hours per week with overtime pay at a rate of not less than 1.25 times of the normal pay, and that exemption may be granted to employees of certain industries in the light of the specificity of their work, so as to protect the employees' rights; at the same time, the Government should also proactively implement family-friendly policies, which are closely related to the objectives of stipulating 'standard working hours', to promote work-life balance" immediately before the full stop.

Question on Hon WONG Sing-chi's amendment to Dr Hon LEUNG Ka-lau's motion proposed and put.

Hon IP Kwok-him claimed a division. The President's Deputy then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President's Deputy announced that among the Members returned by functional constituencies, 22 were present, eight were in favour of the amendment, seven against it and six abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, 15 were in favour of the amendment, one against it and four abstained (voting record in **Appendix IV**). Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Fred LI rose to move the following motion without notice:

That in the event of further divisions in relation to the motion on "Legislating for 'standard working hours'" or amendments thereto, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon IP Wai-ming moved the following amendment to Dr Hon LEUNG Ka-lau's motion:

To delete "as" after "That," and substitute with "although"; to delete "yet some" after "society," and substitute with "many"; to delete "adversely affecting" after "long hours," and substitute with "or even work overtime without compensation, which is not only unfair to them but also adversely affects"; to delete "and" after "family life" and substitute with ","; to add "; in this connection" after "social problems"; and to delete "and having regard to the business environment and competitiveness of Hong Kong" immediately before the full stop and substitute with "protection of the employees' rights and facilitation of Hong Kong's economic development, which should include: (a) to set the standard working hours at eight hours per day or 44 hours per week; (b) to provide employees with a 30-minute break for every six hours of continuous work; (c) to give financial compensation to employees for overtime work; (d) to strictly enforce the regulations on rest days, statutory holidays and paid annual leave to prevent employers from requiring employees to take such holidays as compensation for overtime work; and (e) to amend the Employment Ordinance to include all general holidays other than Sundays as statutory holidays, so as to standardize the basis for calculating working hours".

Question on Hon IP Wai-ming's amendment to Dr Hon LEUNG Ka-lau's motion proposed and put.

Hon Tommy CHEUNG claimed a division. The President's Deputy then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President's Deputy announced that among the Members returned by functional constituencies, 22 were present, seven were in favour of the amendment, nine against it and five abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, 15 were in favour of the amendment, one against it and four abstained (voting record in **Appendix V**). Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon LI Fung-ying moved the following amendment to Dr Hon LEUNG Ka-lau's motion:

To delete "in general an affluent and civilized society, yet some" after "Hong Kong is" and substitute with "an economically developed city, yet most"; and to delete "principles of fairness, flexibility, and having regard to the business environment and competitiveness of Hong Kong" immediately before the full stop and substitute with "people-oriented principle to ensure a work-rest balance for employees".

Question on Hon LI Fung-ying's amendment to Dr Hon LEUNG Ka-lau's motion proposed and put.

Hon Tommy CHEUNG claimed a division. The President's Deputy then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President's Deputy announced that among the Members returned by functional constituencies, 23 were present, 13 were in favour of the amendment, four against it and five abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, 18 were in favour of the amendment, one against it and one abstained (voting record in **Appendix VI**). Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was passed.

As Hon LI Fung-ying's amendment had been passed, the President's Deputy granted leave for Hon LEE Cheuk-yan to revise the terms of his amendment.

Hon LEE Cheuk-yan moved the following further amendment to Dr Hon LEUNG Ka-lau's motion as amended by Hon LI Fung-ying, and explained the revised terms of his amendment to the Council:

To add "; in addition, 'standard working hours' should include 'overtime premium' and 'a minimum daily rest period' "immediately before the full stop.

Question on Hon LEE Cheuk-yan's amendment to Dr Hon LEUNG Ka-lau's motion as amended by Hon LI Fung-ying proposed and put.

Hon LEE Cheuk-yan claimed a division. The President's Deputy then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President's Deputy announced that among the Members returned by functional constituencies, 21 were present, eight were in favour of the amendment, six against it and six abstained; while among the Members returned by geographical constituencies through direct elections, 20 were present, 15 were in favour of the amendment, one against it and four abstained (voting record in **Appendix VII**). Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Dr Hon LEUNG Ka-lau replied.

Question on Dr Hon LEUNG Ka-lau's motion as amended by Hon LI Fung-ying put.

Hon Vincent FANG claimed a division. The President's Deputy then ordered the Council to proceed to a division under Rule 49(5) of the Rules of Procedure.

The President's Deputy announced that among the Members returned by functional constituencies, 22 were present, 13 were in favour of the motion as amended, four against it and four abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, 19 were in favour of the motion as amended, one against it and one abstained (voting record in **Appendix VIII**). Since the question was agreed by a majority of each of the two groups of Members present, she declared that the motion as amended was passed.

## Assisting the sustainable development of small and medium enterprises

Dr Hon LAM Tai-fai moved the following motion and spoke on the motion:

That, given the weak economies and high unemployment rates of Europe and the United States, as well as the various concerns and uncertainties in the external economic environment and the failure of Hong Kong's economy to make a full recovery, coupled with factors such as fierce market competition and soaring costs, etc., the small and medium enterprises ('SMEs') in Hong Kong are facing an operating environment which is becoming increasingly difficult when they operate their businesses in the local, Mainland or overseas markets; in this connection, this Council urges the Government to formulate strategies and measures to comprehensively improve the business environment, and assist SMEs in various aspects such as reducing expenses on operating costs, financing, continuously developing the local, export and China's domestic sales markets, upgrading and transformation, product exploration, brand development and manpower training, etc., with a view to fostering the sustainable development of Hong Kong's economy and increasing employment opportunities for the community.

Question on Dr Hon LAM Tai-fai's motion proposed.

The President's Deputy stated that since Hon Albert CHAN had withdrawn his amendment, two Members would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the two amendments would be debated together in a joint debate.

Hon Jeffrey LAM, who would move an amendment, spoke on the motion and the amendments.

At 5:12 pm, while Hon Jeffrey LAM was speaking, the President resumed the chair.

Hon Vincent FANG, who would move an amendment, spoke on the motion and the amendments.

The Secretary for Commerce and Economic Development spoke on the motion and the amendments.

Three Members spoke on the motion and the amendments.

Dr Hon LAM Tai-fai spoke on the amendments.

The Secretary for Commerce and Economic Development spoke again.

Hon Jeffrey LAM moved the following amendment to Dr Hon LAM Tai-fai's motion:

To delete "given" after "That,"; to add "financial tsunami has resulted in" before "weak economies"; to add "promoting green production, deploying resources to develop emerging markets," after "financing,"; to add "and research and development" after "product exploration"; and to add "as well as make use of the Mainland and Hong Kong Closer Economic Partnership Arrangement and the Framework Agreement on Hong Kong/Guangdong Co-operation," after "manpower training, etc.,".

Question on Hon Jeffrey LAM's amendment to Dr Hon LAM Tai-fai's motion proposed, put and agreed to.

As Hon Jeffrey LAM's amendment had been passed, the President granted leave for Hon Vincent FANG to revise the terms of his amendment.

Hon Vincent FANG moved the following further amendment to Dr Hon LAM Taifai's motion as amended by Hon Jeffrey LAM, and explained the revised terms of his amendment to the Council:

To add "implement a simple and accommodative taxation policy, adopt effective measures to boost the domestic consumption market, and in respect of the investments and inputs made by SMEs which are conducive to their sustainable development, such as scientific research, innovation and design, new market development, creation of additional employment opportunities due to business expansion, etc., provide SMEs with initiative-enhancing incentives such as tax concessions or rebates, etc., as well as when formulating new policies, comprehensively consult SMEs and minimize the impact on them as far as possible, or provide resources to assist the affected enterprises," before "with a view".

Question on Hon Vincent FANG's amendment to Dr Hon LAM Tai-fai's motion as amended by Hon Jeffrey LAM proposed, put and agreed to.

Question on Dr Hon LAM Tai-fai's motion as amended by Hon Jeffrey LAM and Hon Vincent FANG put and agreed to.

## **Next meeting**

The President declared that the next meeting of the Council would be held on 30 June 2010 at 11:00 am.

The Council was adjourned at 6:29 pm.
