The Chief Executive's Question and Answer Session

The Chief Executive addressed the Council.

A Member and Hon LEUNG Kwok-hung asked questions and the Chief Executive replied.

While the Chief Executive was replying to his question, Hon LEUNG Kwok-hung interrupted the Chief Executive by speaking aloud. The President asked him to keep quiet.

The Chief Executive continued to reply to Hon LEUNG Kwok-hung's question.

While the Chief Executive was replying to his question, Hon LEUNG Kwok-hung interrupted the Chief Executive again. He then walked towards the Chief Executive and threw some pieces of paper at the Chief Executive. The President ordered Hon LEUNG Kwok-hung to withdraw from the Chamber immediately. Pursuant to the President's order, Hon LEUNG Kwok-hung was escorted out of the Chamber by the Clerk and security staff.

Four other Members and Hon WONG Yuk-man asked questions and the Chief Executive replied.

After the Chief Executive had replied to Hon WONG Yuk-man's question, Hon WONG Yuk-man and Hon Albert CHAN stood up and spoke aloud. The President stated that if they continued to behave in a disorderly manner, he would request them to leave the Chamber. Ignoring the President's advice, the two Members continued to speak aloud. The President then ordered them to withdraw from the Chamber immediately. With the assistance of the Clerk and security staff, the two Members left the Chamber.

Twelve more Members asked questions and the Chief Executive replied.

Next meeting

The President declared that the next meeting of the Council would be held on 14 July 2010 at 11:00 am.

The Council was adjourned at 4:34 pm.
