<u>Bills</u>

First Reading

Adaptation of Laws (Military References) Bill 2010 Securities and Futures and Companies Legislation (Structured Products Amendment) Bill 2010 Competition Bill

The Bills were read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

Second Reading

Adaptation of Laws (Military References) Bill 2010

The Secretary for Security moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Securities and Futures and Companies Legislation (Structured Products Amendment) Bill 2010

The Secretary for Financial Services and the Treasury moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Competition Bill

The Secretary for Commerce and Economic Development moved the Second Reading and spoke on the Bill.

Question on the Second Reading proposed. The President's Deputy stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Supplementary Appropriation (2009-2010) Bill

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 23 June 2010 resumed.

Question on the Second Reading put and agreed to.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into Committee and considered the Supplementary Appropriation (2009-2010) Bill.

Question that clauses 1 and 2 stand part of the Bill proposed, put and agreed to.

Question that the Schedule stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Financial Services and the Treasury reported that

the Supplementary Appropriation (2009-2010) Bill

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

Minimum Wage Bill

Resumption of Second Reading debate

The debate on the Second Reading which was moved on 8 July 2009 resumed.

Hon TAM Yiu-chung, Chairman of the Bills Committee on Minimum Wage Bill, addressed the Council on the Committee's Report.

At 2:50 pm, while Hon TAM Yiu-chung was addressing, the President resumed the chair.

After the address, Hon TAM Yiu-chung spoke on the Bill in his personal capacity as a Member.

12 Members and Dr Hon Priscilla LEUNG spoke on the Bill.

While Dr Hon Priscilla LEUNG was speaking, the President left the chair at 6:29 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Five others Members and Hon Cyd HO spoke on the Bill.

At 7:43 pm, while Hon Cyd HO was speaking, the President resumed the chair.

Nine more Members spoke on the Bill.

The President suspended the meeting at 9:50 pm.

* * * * * *

The Council resumed at 9:00 am on 15 July 2010.

Four Members and Hon CHAN Kin-por spoke on the Bill.

While Hon CHAN Kin-por was speaking, Hon LEUNG Kwok-hung sought elucidation of a point raised by Hon CHAN Kin-por in his speech. Hon CHAN Kinpor elucidated and continued to speak.

Another Member and Hon Mrs Sophie LEUNG spoke on the Bill.

While Hon Mrs Sophie LEUNG was speaking, Hon Audrey EU sought elucidation of a point raised by Hon Mrs Sophie LEUNG in her speech. Hon Mrs Sophie LEUNG did not accede to the request and continued to speak.

Hon Audrey EU raised a point of order on whether Hon Mrs Sophie LEUNG had used offensive language about Members of the Civic Party and requested Hon Mrs Sophie LEUNG to withdraw her remarks. The President stated that in the course of the debate, a number of Members had laid stern criticism on the performance of other political parties, which might not be considered to be fair by those political parties. If every time a Member's request for the withdrawal of remarks by another Member was acceded to, it would be difficult for the debate to continue. Given that a Member of the Civic Party would be called upon to speak, he believed that the Member would have sufficient time to respond to the criticism. The President considered that Hon Mrs Sophie LEUNG did not need to withdraw her remarks. Hon Mrs Sophie LEUNG then continued to speak.

Four other Members spoke on the Bill.

The Secretary for Labour and Welfare replied.

Question on the Second Reading put.

Hon Emily LAU claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that there were 55 Members present, 53 were in favour of the motion and one against it (voting record in **Appendix 1**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the second time and committed to a committee of the whole Council.

Committee stage

The Council went into Committee and considered the Minimum Wage Bill.

Question that clauses 1, 4, 9, 12, 14, 19 and 22 stand part of the Bill proposed.

Two Members spoke on the motion.

A Member spoke again.

Question that clauses 1, 4, 9, 12, 14, 19 and 22 stand part of the Bill put and agreed to.

Question that clauses 2 and 3 stand part of the Bill proposed.

The Chairman stated that Dr Hon LEUNG Ka-lau had given notice to move an amendment to clause 2 to amend the definition of "place of employment". Besides, Hon LEE Cheuk-yan and the Secretary for Labour and Welfare had separately given notice to move amendments to clause 3. Irrespective of whether Dr Hon LEUNG Ka-lau's amendment to clause 2 was passed or not, both Hon LEE Cheuk-yan and the Secretary for Labour and Welfare might move their amendments to clause 3. If Hon LEE Cheuk-yan's amendment was passed, the Secretary for Labour and Welfare might not move his amendments.

The Chairman ordered that the clauses 2 and 3 and the amendments thereto be debated together in a joint debate.

Dr Hon LEUNG Ka-lau moved an amendment to clause 2 to amend the definition of "place of employment", and spoke on the clauses and the amendments.

While Dr Hon LEUNG Ka-lau was speaking, the Chairman left the chair at 12:08 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Hon LEE Cheuk-yan and the Secretary for Labour and Welfare spoke on the clauses and their amendments respectively.

Four Members and Hon LEUNG Yiu-chung spoke on the clauses and the amendments.

At 1:08 pm, while Hon LEUNG Yiu-chung was speaking, the Chairman resumed the chair.

Hon Ronny TONG and one more Member spoke on the clauses and the amendments. Hon Ronny TONG declared that he had employed employees and foreign domestic helpers.

Hon Paul TSE and another Member spoke on the clauses and the amendments.

Hon LEE Cheuk-yan spoke again.

Hon Paul TSE spoke again. While Hon Paul TSE was speaking, the Chairman stated that during the Committee stage, a Member might speak more than once on a question and the speaking time limit was 15 minutes each. Such an arrangement was to facilitate Members to respond to the views expressed by other Members. However, if Members continued to put forward new perspective on the question under debate when they were allowed to speak again, the 15-minute speaking time limit would be futile. The Chairman reminded Members that they should make good use of the speaking time in order for the Committee stage to be conducted in a smooth manner. The Chairman then asked Hon Paul TSE to continue to speak.

Hon Paul TSE continued to speak.

Dr Hon LEUNG Ka-lau spoke again.

Another Member spoke again.

Question on the amendment moved by Dr Hon LEUNG Ka-lau put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, seven were in favour of the amendment and 16 against it; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the amendment and 10 against it (voting record in **Appendix 2**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the other provisions of the Minimum Wage Bill or amendments thereto, the Committee do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed.

Four Members spoke on the motion.

Hon Miriam LAU said that having taken into account Members' view that it would not be appropriate to shorten the duration of the division bell to one minute in the event of further divisions in relation to other provisions of the Bill or amendments thereon, she wished to withdraw the motion. As there was no dissenting voice, the motion was withdrawn.

Hon LEE Cheuk-yan moved an amendment to clause 3 to delete the clause and substitute it by a new one.

The Chairman stated that if Hon LEE Cheuk-yan's amendment was passed, the Secretary for Labour and Welfare might not move his amendments.

Question on the amendment moved by Hon LEE Cheuk-yan put.

Hon IP Kwok-him claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, six were in favour of the amendment and 18 against it; while among the Members returned by geographical constituencies through direct elections, 27 were present, 18 were in favour of the amendment and eight against it (voting record in **Appendix 3**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

The Secretary for Labour and Welfare moved amendments to clause 3(1) and the deletion of clause 3(2).

Question on the amendments moved by the Secretary for Labour and Welfare put and agreed to.

Question that clause 3 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 5 stand part of the Bill proposed.

The Chairman stated that the Secretary for Labour and Welfare and Hon LEE Cheukyan had separately given notice to move amendments to clause 5. Irrespective of whether the Secretary for Labour and Welfare's amendments were passed or not, Hon LEE Cheuk-yan might move his relevant amendment.

The Chairman ordered that the clause 5 and the amendments thereto be debated together in a joint debate.

The Secretary for Labour and Welfare moved amendments to clause 5(2) and 5(5), and spoke on the clause and the amendments.

Hon LEE Cheuk-yan spoke on the clause and the amendments.

Four Members spoke on the clause and the amendments.

Hon LEE Cheuk-yan spoke again.

The Secretary for Labour and Welfare spoke again.

Question on the amendments moved by the Secretary for Labour and Welfare put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that there were 46 Members present and 45 were in favour of the amendments (voting record in **Appendix 4**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Hon LEE Cheuk-yan moved the addition of subclause (2B) to clause 5.

Question on the amendment moved by Hon LEE Cheuk-yan put.

Hon Andrew LEUNG claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, five were in favour of the amendment and 19 against it; while among the Members returned by geographical constituencies through direct elections, 23 were present, 17 were in favour of the amendment and five against it (voting record in **Appendix 5**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that clauses 6, 7, 11, 15, 16 and 17, the heading of Part 5, the cross-heading immediately before clause 18, and clauses 18, 20 and 21 stand part of the Bill proposed.

The Secretary for Labour and Welfare moved an amendment to clause 6(2), and spoke on the amendment.

Question on the amendment put and agreed to.

The Chairman stated that as Rule 91 of the Rules of Procedure provided that only the President might give consent for a motion to be moved to suspend the Rules of Procedure, he requested the Committee on Rules of Procedure to examine in future whether this procedure could be dispensed with.

Council resumed by order of the Chairman. The President then granted leave for Hon LEUNG Yiu-chung to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(5) of the Rules of Procedure in order that the committee of the whole Council could consider the new heading before new clause 21B and new clause 21B together with clauses 2 and 6, the heading of Part 5, the cross-heading immediately before clause 18 and clause 18.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New heading before new clause 21B and new clause 21B read the first time.

The Chairman stated that Hon LEUNG Yiu-chung had given notice to move amendments to clause 2 to make a consequential amendment to the definition of "employee", and amendments to clause 6 to add subclause (2A) and the heading of Part 5, the deletion of clause 18 and the cross-heading immediately before that clause, as well as the addition of the new heading before new clause 21B and new clause 21B. If Hon LEUNG Yiu-chung's amendments to clauses 2 and 6, the heading of Part 5 and clause 18 and the cross-heading immediately before that clause were passed, he might later move the addition of the new heading before new clause 21B and new clause 21B. Besides, he might move a consequential amendment to the long title later on. Hon LEUNG Yiu-chung moved amendments to clauses 2 and 6 and the heading of Part 5, and the deletion of clause 18 and the cross-heading immediately before the clause, and spoke on the clauses and the amendments.

Seven Members spoke on the clauses and the amendments and one of them spoke again.

With the Chairman's permission, Dr Hon Margaret NG elucidated the name of the ordinance she had mentioned earlier in her speech.

Two other Members spoke on the clauses and the amendments.

Three Members spoke again and then two of them spoke for the third time.

One more Member spoke on the clauses and the amendments.

Another Member spoke for the third time.

One more Member spoke on the clauses and the amendments.

The Secretary for Labour and Welfare spoke on the clauses and the amendments.

Hon LEUNG Yiu-chung spoke again.

Question on the amendments moved by Hon LEUNG Yiu-chung put.

Hon LEUNG Yiu-chung claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 28 were present, seven were in favour of the amendments and 21 against them; while among the Members returned by geographical constituencies through direct elections, 28 were present, 20 were in favour of the amendments and seven against them (voting record in **Appendix 6**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that the heading of Part 5, the cross-heading immediately before clause 18 and clause 18 stand part of the Bill put.

Hon LEUNG Yiu-chung claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that there were 56 Members present, 26 were in favour of the motion, 28 against it and one abstained (voting record in **Appendix 7**). Since the question was not agreed by a majority of the Members present, he declared that the motion was negatived.

Council resumed by order of the Chairman. The President then granted leave for Hon LEE Cheuk-yan to move a motion under Rule 91 of the Rules of Procedure to suspend Rules 58(5) and (7) of the Rules of Procedure in order that the committee of the whole Council could consider new clause 3A and new Schedule 3A together with clauses 2, 5, 6, 7, 11, 15, 17, 20 and 21.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New clause 3A and new Schedule 3A read the first time.

The Chairman stated that Hon LEE Cheuk-yan had given notice to move amendments to clause 2 to make a consequential amendment to the definition of "employee", to amend the definition of "minimum wage", as well as to add the definitions of "days worked", "minimum daily wage rate", "live-in domestic worker" and "conversion mulitiplier" and amend a punctuation mark. He also intended to move the addition of subclause (2A) to clause 5, an amendment to clause 6(3), the addition of subclause (2A) to clause 7, the addition of subclause (1A) to clause 11, an amendment to the heading before clause 15 and the addition of subclause (1A) thereto as well as consequential amendments to subclause (2), the addition of subclauses (2A), (2B) and (2C) to clause 17, amendment to clause 20(1) and the addition of new clause 3A and new Schedule 3A. If Hon LEE Cheuk-yan's amendments to clause 2, 5, 6, 7, 11, 15, 17, 20 and 21 were passed, he might later move the addition of new clause 3A and new Schedule 3A.

Hon LEE Cheuk-yan moved amendments to clauses 2, 5, 6, 7, 11, 15, 17, 20 and 21, and spoke on the clauses and the amendments.

Two Members and Hon Ronny TONG spoke on the clauses and the amendments.

While Hon Ronny TONG was speaking, the Chairman left the chair at 5:35 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Seven others Members spoke on the clauses and the amendments.

The Secretary for Labour and Welfare spoke on the clauses and the amendments.

Hon LEE Cheuk-yan spoke again.

At 7:20 pm, while Hon LEE Cheuk-yan was speaking, the Chairman resumed the chair.

With the Chairman's permission, Hon WONG Kwok-hing elucidated a point he had made earlier which he considered to be misunderstood by Hon LEE Cheuk-yan.

Question on the amendments moved by Hon LEE Cheuk-yan put.

Hon Mrs Regina IP claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, one was in favour of the amendments, 18 against them and four abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, eight were in favour of the amendments, eight against them and 13 abstained (voting record in **Appendix 8**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 5 as amended stand part of the Bill proposed, put and agreed to.

Question that clauses 7 and 21 stand part of the Bill put and agreed to.

Council resumed by order of the Chairman. The President then granted leave for the Secretary for Labour and Welfare to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(5) of the Rules of Procedure in order that the committee of the whole Council could consider new clause 2A together with clauses 2, 6 and 17.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New clause 2A read the first time.

The Chairman stated that the Secretary for Labour and Welfare had given notice to move amendments to clause 2 to add the definitions of "work experience student", "non-local education programme" and "exempt student employment" and to amend the definition of "student intern", as well as the addition of subclause (5) to clause 6, the addition of subclause (3) to clause 17 and the addition of new clause 2A. If the Secretary for Labour and Welfare's amendments to clauses 2, 6 and 17 were passed, he might later move the addition of new clause 2A.

The Secretary for Labour and Welfare moved amendments to clauses 2, 6 and 17, and spoke on the clauses and the amendments.

Eleven Members spoke on the clauses and the amendments.

The Secretary for Labour and Welfare spoke again.

Another Member spoke on the clauses and the amendments.

With the Chairman's permission, Hon IP Kwok-him elucidated two points he had made earlier which he considered to be misunderstood by Hon Albert CHAN.

One more Member spoke on the clauses and the amendments and a Member spoke again.

Another Member spoke on the clauses and the amendments and two other Members spoke again.

Two other Members spoke on the clauses and the amendments and a Member spoke for the third time.

Another Member spoke again.

Question on the amendments moved by the Secretary for Labour and Welfare put.

Hon Albert CHAN and Hon WONG Kwok-kin claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that there were 50 Members present, 31 were in favour of the amendments, 14 against them and four abstained (voting record in **Appendix 9**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that clause 17 as amended stand part of the Bill proposed, put and agreed to.

The Secretary for Labour and Welfare moved the Second Reading of new clause 2A.

Question on the Second Reading of new clause 2A proposed, put and agreed to.

New clause 2A read the second time.

The Secretary for Labour and Welfare moved the addition of new clause 2A to the Bill.

Question on the addition of new clause 2A proposed, put and agreed to.

Council resumed by order of the Chairman. The President then granted leave for Hon Mrs Regina IP to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(7) of the Rules of Procedure in order that the committee of the whole Council could consider new Schedule 1A together with clauses 2, 6 and 16.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New Schedule 1A read the first time.

The Chairman stated that Hon Mrs Regina IP had given notice to move an amendment to clause 2 to make a consequential amendment to the definition of "employee", the addition of subclause (6) to clause 6 and a consequential amendment to clause 16, as well as the addition of new Schedule 1A. If Hon Mrs Regina IP's amendments to clauses 2, 6 and 16 were passed, she might later move the addition of new Schedule 1A. Moreover, if Hon Mrs Regina IP's amendment concerning the definition of "employee" was passed, the Secretary for Labour and Welfare would not move an amendment to the definition of "employee" in clause 2 because the Secretary for Labour and Welfare's proposed amendment had already been included in Hon Mrs Regina IP's amendment.

Hon Mrs Regina IP moved amendments to clauses 2, 6 and 16, and spoke on the clauses and the amendments.

A Member spoke on the clauses and the amendments.

The Chairman suspended the meeting at 9:59 pm.

Seven Members spoke on the clauses and the amendments and one of them spoke again.

The Secretary for Labour and Welfare spoke on the clauses and the amendments.

Another Member spoke on the clauses and the amendments.

Hon Mrs Regina IP spoke again.

Question on the amendments moved by Hon Mrs Regina IP put.

Hon Mrs Regina IP claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, five were in favour of the amendments, 12 against them and seven abstained; while among the Members returned by geographical constituencies through direct elections, 22 were present, one was in favour of the amendments, 18 against them and two abstained (voting record in **Appendix 10**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 6 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 8 stand part of the Bill proposed.

The Secretary for Labour and Welfare moved amendments to clause 8, and spoke on the clause and the amendments.

Five Members spoke on the clause and the amendments.

The Secretary for Labour and Welfare spoke again.

Question on the amendments put and agreed to.

Question that clause 8 as amended stand part of the Bill proposed, put and agreed to.

Question that clause 10 stand part of the Bill proposed.

Council resumed by order of the Chairman. The President then granted leave for Hon LEE Cheuk-yan to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(7) of the Rules of Procedure in order that the committee of the whole Council could consider new Schedule 3B together with clause 10.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New Schedule 3B read the first time.

The Chairman stated that the Secretary for Labour and Welfare and Hon IP Wai-ming had separately given notice to move amendments to clause 10(2)(b). Both amendments concerned the composition of the Minimum Wage Commission. If the Secretary for Labour and Welfare's amendment was passed, Hon IP Wai-ming might not move his amendment. Moreover, the Secretary for Labour and Welfare had given notice to move an amendment to clause 10(3), and Hon LEE Cheuk-yan had given notice to move the addition of new subclause (3A) to clause 10 and consequential amendments to clause 16 as well as the addition of new Schedule 3B. Those amendments concerned matters that had to be taken into account or considered in appointing members to the Minimum Wage Commission. If the amendment to clause 10(2)(b) proposed by the Secretary for Labour and Welfare was negatived and the amendment proposed by Hon IP Wai-ming was passed, Hon LEE Cheuk-yan would withdraw his proposed amendments, that were, the addition of subclause (3A) to clause 10 and amendments to clause 16 as well as the addition of new Schedule 3B. Irrespective of whether Hon IP Wai-ming's amendment was passed or not, the Secretary for Labour and Welfare might later move an amendment to clause 10(3).

The Chairman ordered that the original provisions and the amendments of Secretary for Labour and Welfare, Hon IP Wai-ming and Hon LEE Cheuk-yan as well as the proposed new Schedule be debated together in a joint debate.

The Secretary for Labour and Welfare moved an amendment to clause 10(2)(b), and spoke on the clause, the amendments and the new Schedule.

Hon IP Wai-ming and Hon LEE Cheuk-yan spoke on the clause, the amendments and the new Schedule.

Five Members and Hon LEUNG Yiu-chung spoke on the clause, the amendments and the new Schedule.

While Hon LEUNG Yiu-chung was speaking, the Chairman left the chair at 12:33 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Another Member spoke on the clause, the amendments and the new Schedule.

A Member spoke again and Hon WONG Kwok-kin spoke on the clause, the amendments and the new Schedule.

At 1:00 pm, while Hon WONG Kwok-kin was speaking, the Chairman resumed the chair.

The Chairman suspended the meeting at 1:05 pm.

The Committee resumed at 1:25 pm.

Another two Members spoke again and one more Member spoke on the clause, the amendments and the new Schedule.

Hon IP Wai-ming and Hon LEE Cheuk-yan spoke again.

The Secretary for Labour and Welfare spoke again.

Question on the amendment moved by the Secretary for Labour and Welfare put.

Hon IP Wai-ming claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that there were 46 Members present, 40 were in favour of the amendment and five against it (voting record in **Appendix 11**). Since the question was agreed by a majority of the Members present, he declared that the amendment was passed.

The Chairman stated that as the Secretary for Labour and Welfare's amendment had been passed, Hon IP Wai-ming might not move his amendment to clause 10(2)(b).

The Secretary for Labour and Welfare moved an amendment to clause 10(3).

Question on the amendment moved by the Secretary for Labour and Welfare put and agreed to.

Hon LEE Cheuk-yan moved the addition of subclause (3A) to clause 10 and amendments to clause 16.

Question on the amendments moved by Hon LEE Cheuk-yan put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, two were in favour of the amendments, 20 against them and one abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 14 were in favour of the amendments and 10 against them (voting record in **Appendix 12**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

Question that clause 16 stand part of the Bill put and agreed to.

The Chairman stated that Hon LEE Cheuk-yan had given notice to move an amendment to clause 10(2)(c), and Hon IP Wai-ming had given notice to move the addition of subclause (3A) to clause 10. Both amendments concerned the voting rights of members of the Minimum Wage Commission. Irrespective of whether Hon LEE Cheuk-yan's amendment was passed or not, Hon IP Wai-ming might move his amendment.

The Chairman ordered that the original provision and amendments of Hon LEE Cheuk-yan and Hon IP Wai-ming be debated together in a joint debate.

Hon LEE Cheuk-yan moved an amendment to clause 10(2)(c), and spoke on the clause and the amendments.

Hon IP Wai-ming spoke on the clause and the amendments.

Two Members spoke on the clause and the amendments.

The Secretary for Labour and Welfare spoke on the clause and amendments.

Hon IP Wai-ming and Hon LEE Cheuk-yan spoke again.

Another Member spoke on the clause and the amendments. The Secretary for Labour and Welfare spoke again.

One more Member spoke on the clause and the amendments.

Question on the amendment moved by Hon LEE Cheuk-yan put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, seven were in favour of the amendment, 15 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 22 were present, 13 were in favour of the amendment and eight against it (voting record in **Appendix 13**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon IP Wai-ming moved the addition of subclause (3A) to clause 10.

Question on the amendment moved by Hon IP Wai-ming put.

Hon IP Wai-ming claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, seven were in favour of the amendment, 15 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 21 were present, 12 were in favour of the amendment and eight against it (voting record in **Appendix 14**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

The Chairman stated that Hon Emily LAU had given notice to move the addition of subclause (3A) to clause 10, proposing that regard must be given to the participation of each gender in appointing the chairperson and members of the Minimum Wage Commission.

Hon Emily LAU moved the addition of subclause (3A) to clause 10, and spoke on the clause and the amendment.

Hon CHEUNG Man-kwong spoke on the clause and the amendment.

While Hon CHEUNG Man-kwong was speaking, the Chairman left the chair at 2:56 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Seven other Members spoke on the clause and the amendment.

The Secretary for Labour and Welfare spoke on the clause and the amendment.

Hon Emily LAU spoke again.

Question on the amendment moved by Hon Emily LAU put.

Hon Emily LAU claimed a division. The Chairman's Deputy then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

At 3: 51 pm, while the division bell was ringing, the Chairman resumed the chair.

The Chairman announced that among the Members returned by functional constituencies, 20 were present, five were in favour of the amendment, 11 against it and four abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 15 were in favour of the amendment, two against it and six abstained (voting record in **Appendix 15**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

The Chairman announced that among the Members returned by functional constituencies, 21 were present, four were in favour of the amendment, 12 against it and five abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 15 were in favour of the amendment, one against it and seven abstained (voting record in **Appendix 16**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that clause 10 as amended stand part of the Bill proposed, put and agreed to.

The Chairman stated that the Secretary for Labour and Welfare and Hon LEE Cheukyan had separately given notice to move amendments to clause 11(1) and 11(4). As the amendments proposed by the Secretary for Labour and Welfare and Hon LEE Cheuk-yan were substantially the same, he would only invite the Secretary for Labour and Welfare to move his amendments. Irrespective of whether the Secretary for Labour and Welfare's amendments were passed or not, Hon LEE Cheuk-yan might not move his amendments.

The Chairman ordered that the original provisions as well as the amendments of Secretary for Labour and Welfare and Hon LEE Cheuk-yan be debated together in a joint debate.

The Secretary for Labour and Welfare moved amendments to clause 11(1) and 11(4), and spoke on the clause and amendments.

Hon LEE Cheuk-yan spoke on the clause and the amendments.

Two Members spoke on the clause and the amendments.

Hon LEE Cheuk-yan spoke again.

Question on the amendments move by the Secretary for Labour and Welfare put and agreed to.

The Chairman stated that Hon WONG Kwok-hing and Hon LEE Cheuk-yan had separately given notice to move an amendment to clause 11(3). If Hon WONG Kwok-hing's amendment was passed, Hon LEE Cheuk-yan might not move his amendment, as it was inconsistent with the decision already taken by this Committee.

Another Member and Hon Albert HO spoke on the clause and the amendments.

While Hon Albert HO was speaking, the Chairman left the chair at 6:26 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Three more Members spoke on the clause and the amendments.

Three Members spoke again.

One more Member spoke on the clause and the amendments.

The Secretary for Labour and Welfare spoke on the clause and the amendments.

Hon LEE Cheuk-yan spoke again.

At 7:35 pm, while Hon LEE Cheuk-yan was speaking, the Chairman resumed the chair.

Hon WONG Kwok-hing spoke again.

Question on the amendment moved by Hon WONG Kwok-hing put.

Hon Tommy CHEUNG claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, five were in favour of the amendment and 18 against it; while among the Members returned by geographical constituencies through direct elections, 28 were present, 19 were in favour of the amendment and eight against it (voting record in **Appendix 17**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Hon LEE Cheuk-yan moved an amendment to clause 11(3).

Question on the amendment moved by Hon LEE Cheuk-yan put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 23 were present, three were in favour of the amendment, 18 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 28 were present, 17 were in favour of the amendment, eight against it and two abstained (voting record in **Appendix 18**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that clause 13 stand part of the Bill proposed.

The Chairman stated that Hon WONG Kwok-hing and Hon LEE Cheuk-yan had separately given notice to move the addition of subclause (5) to clause 11, while the Secretary for Labour and Welfare and Hon LEE Cheuk-yan had separately given notice to move an amendment to clause 13. These amendments concerned the frequency of making reports under clause 11(1) by the Minimum Wage Commission, as well as matters relating to the publication of such reports. As Hon WONG Kwokhing's and Hon LEE Cheuk-yan's amendments to add subclause (5) to clause 11 were substantially the same, he would only invite Hon WONG Kwok-hing to move his amendment. Irrespective of whether Hon WONG Kwok-hing's amendment was passed or not, Hon LEE Cheuk-yan might not move his amendment. If

Hon WONG Kwok-hing's amendment was passed, he had given leave for the Secretary for Labour and Welfare to revise his amendment to clause 13. If Hon WONG Kwok-hing's amendment was negatived, and the original amendment proposed by the Secretary for Labour and Welfare was also negatived, Hon LEE Cheuk-yan might move his amendment. However, if the Secretary for Labour and Welfare moved his revised amendment to clause 13, Hon LEE Cheuk-yan might not move his amendment to this clause irrespective of whether the Secretary for Labour and Welfare's amendment to this clause irrespective of whether the Secretary for Labour and Welfare's amendment was passed or not.

The Chairman ordered that the original provisions and the amendments of Hon WONG Kwok-hing, Hon LEE Cheuk-yan as well as the Secretary for Labour and Welfare be debated together in a joint debate.

Hon WONG Kwok-hing moved the addition of subclause (5) to clause 11, and spoke on the clause and the amendments.

Hon LEE Cheuk-yan and the Secretary for Labour and Welfare spoke on the clause and the amendments.

Seven Members and Dr Hon Joseph LEE spoke on the clause and the amendments.

While Dr Hon Joseph LEE was speaking, the Chairman left the chair at 10:01 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Another Member spoke on the clause and the amendments, and a Member spoke again.

One more Member spoke on the clause and the amendments.

Hon LEE Cheuk-yan and two Members spoke again.

One more Member spoke on the clause and the amendments, and a Member spoke for the third time.

One more Member spoke on the clause and the amendments, and two Members spoke again.

Two more Members spoke on the clause and the amendments, and a Member spoke for the fourth time.

Hon LEE Cheuk-yan and a Member spoke for the third time.

A Member spoke again and one more Member spoke on the clause and the amendments.

Hon James TO spoke for the third time.

At 11: 57 pm, while Hon James TO was speaking, the Chairman resumed the chair.

A Member spoke for the fifth time, and Hon LEE Cheuk-yan spoke for the fourth time.

A Member and the Secretary for Labour and Welfare spoke again.

Hon LEE Cheuk-yan spoke for the fifth time.

The Secretary for Labour and Welfare spoke for the third time.

Hon WONG Kwok-hing spoke again.

Question on the amendment moved by Hon WONG Kwok-hing put.

Hon Albert CHAN claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, nine were in favour of the amendment, 14 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 26 were present, 24 were in favour of the amendment and one against it (voting record in **Appendix 19**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that clause 11 as amended stand part of the Bill proposed, put and agreed to.

The Secretary for Labour and Welfare moved an amendment to clause 13.

Question on the amendment moved by the Secretary for Labour and Welfare put.

Hon WONG Kwok-kin claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that there were 30 Members present, 23 were in favour of the amendment, two against it and four abstained (voting record in **Appendix 20**). Since the question was agreed by a majority of the Members present, he declared that the amendment was passed.

Question that clause 13 as amended stand part of the Bill proposed, put and agreed to.

Hon Cyd HO moved an amendment to clause 15(4), and spoke on the clause and the amendment.

While Hon Frederick FUNG was speaking, the Chairman left the chair at 2:21 am on 17 July 2010 temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Three other Members spoke on the clause and the amendment.

The Secretary for Labour and Welfare spoke on the clause and the amendment.

Hon Cyd HO spoke again.

Another Member and the Secretary for Labour and Welfare spoke again.

A Member and Hon Cyd HO spoke for the third time.

Another Member spoke again.

Question on the amendment moved by Hon Cyd HO put.

Hon WONG Yung-kan claimed a division. The Chairman's Deputy then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

At 3: 15 am, while the division bell was ringing, the Chairman resumed the chair.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, five were in favour of the amendment, 16 against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 15 were in favour of the amendment, six against it and two abstained (voting record in **Appendix 21**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

Question that clause 15 stand part of the Bill put and agreed to.

Council resumed by order of the Chairman. The President then granted leave for the Secretary for Labour and Welfare to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(5) of the Rules of Procedure in order that the committee of the whole Council could consider new clause 21A together with clause 20.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New clause 21A read the first time.

The Chairman stated that the Secretary for Labour and Welfare had given notice to move amendments to clause 20 and the addition of new clause 21A. If the amendments to clause 20 proposed by the Secretary for Labour and Welfare were passed, he might later move the addition of new clause 21A.

The Secretary for Labour and Welfare moved amendments to clause 20, and spoke on the clause and the amendments.

Four Members spoke on the clause and amendments and one of them spoke again.

Four other Members spoke on the clause and the amendments and a Member spoke again.

Two more Members spoke on the clause and the amendments and a Member spoke for the third time.

Question on the amendments put.

Hon LEE Cheuk-yan claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that there were 49 Members present, 33 were in favour of the amendments, 14 against them and one abstained (voting record in **Appendix 22**). Since the question was agreed by a majority of the Members present, he declared that the amendments were passed.

Question that clause 20 as amended stand part of the Bill proposed, put and agreed to.

The Secretary for Labour and Welfare moved the Second Reading of new clause 21A.

Question on the Second Reading of new clause 21A proposed, put and agreed to.

New clause 21A read the second time.

The Secretary for Labour and Welfare moved the addition of new clause 21A to the Bill.

Question on the addition of new clause 21A proposed, put and agreed to.

Question that clause 23 stand part of the Bill proposed.

The Chairman stated that Hon CHEUNG Kwok-che and the Secretary for Labour and Welfare had separately given notice to move amendments to clause 23. If Hon CHEUNG Kwok-che's amendment was passed, the Secretary for Labour and Welfare might not move his amendments, as they were inconsistent with the decision already taken by this Committee.

The Chairman ordered that the original provision and the amendments of Hon CHEUNG Kwok-che and the Secretary for Labour and Welfare be debated together in a joint debate.

Hon CHEUNG Kwok-che moved an amendment to clause 23, and spoke on the clause and the amendments.

The Secretary for Labour and Welfare spoke on the clause and the amendments.

Eight Members spoke on the clause and the amendments.

The Secretary for Labour and Welfare spoke again.

Two Members spoke again and another Member spoke on the clause and the amendments.

Hon CHEUNG Kwok-che spoke again.

Question on the amendment moved by Hon CHEUNG Kwok-che put.

Hon TAM Yiu-chung claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, seven were in favour of the amendment, 16 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 17 were in favour of the amendment and six against it (voting record in **Appendix 23**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendment was negatived.

The Secretary for Labour and Welfare moved amendments to clause 23.

Question on the amendments moved by the Secretary for Labour and Welfare put and agreed to.

Question that clause 23 as amended stand part of the Bill proposed, put and agreed to.

The Secretary for Labour and Welfare moved amendments to clause 2 to revise the definitions of "employee" and "employee with a disability", as well as to add the definitions of "option form" and "assessment-opting PWD" and amend a punctuation mark. He then spoke on the clause and the amendments.

A Member spoke on the clause and the amendments.

Question on the amendments put and agreed to.

Question that clause 2 as amended stand part of the Bill proposed, put and agreed to.

New clause 19A read the first time.

The Chairman stated that as the amendment to clause 6 moved earlier by Hon LEE Cheuk-yan had been negatived, he had given leave for Hon LEE Cheuk-yan to revise the terms of his proposed new clause 19A.

Hon LEE Cheuk-yan moved the Second Reading of the revised new clause 19A and spoke on the revised new clause.

Question on the Second Reading of the revised new clause 19A proposed.

The Secretary for Labour and Welfare spoke on the new clause.

Hon LEE Cheuk-yan spoke again.

A Member spoke on the new clause.

Question on the Second Reading of new clause 19A put.

Hon TAM Yiu-chung claimed a division. The Chairman then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, eight were in favour of the motion and 16 against it; while among the Members returned by geographical constituencies through direct elections, 24 were present, 17 were in favour of the motion and six against it (voting record in **Appendix 24**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Question that Schedule 3 stand part of the Bill proposed, put and agreed to.

Question that Schedules 1, 2 and 4 stand part of the Bill proposed.

The Secretary for Labour and Welfare moved amendments to Schedules 1, 2 and 4, and spoke on the amendments.

Question on the amendments put and agreed to.

Question that Schedules 1, 2 and 4 as amended stand part of the Bill proposed, put and agreed to.

Question that the long title stand part of the Bill proposed.

The Secretary for Labour and Welfare moved a consequential amendment to the long title, and spoke on the amendment.

A Member spoke on the amendment.

Question on the amendment put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Labour and Welfare reported that

the Minimum Wage Bill

had passed through the Committee with amendments. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed.

A Member and Hon Albert CHAN spoke on the motion.

While Hon Albert CHAN was speaking, the Chairman left the chair at 5:31 am temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Five other Members and Hon TAM Yiu-chung spoke on the motion.

At 6:14 am, while Hon TAM Yiu-chung was speaking, the Chairman resumed the chair.

The Secretary for Labour and Welfare replied.

Question on the Third Reading put.

Hon WONG Kwok-hing claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that there were 47 Members present, 45 were in favour of the motion and one against it (voting record in **Appendix 25**). Since the question was agreed by a majority of the Members present, he declared that the motion was passed.

Bill read the second time and committed to a committee of the whole Council.

Question that clause 1 stand part of the Bill proposed, put and agreed to.

Question that clauses 2, 3 and 4 stand part of the Bill proposed.

Council resumed by order of the Chairman. The President then granted leave for Hon James TO to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 58(5) of the Rules of Procedure in order that the committee of the whole Council could consider new clause 2A together with clauses 2, 3 and 4.

Question on the motion proposed, put and agreed to.

The Council went into Committee again.

New clause 2A read the first time.

The Chairman stated that Hon James TO had given notice to move amendments to clauses 2, 3 and 4 as well as the addition of new clause 2A. If Hon James TO's amendments to clauses 2, 3 and 4 were passed, he might later move the addition of new clause 2A.

Two Members spoke on the clauses and the amendments.

Hon James TO and a Member spoke again.

Hon James TO and a Member spoke for the third time.

Hon James TO spoke for the fourth time.

Another Member and spoke on the clauses and the amendments.

The Secretary for Transport and Housing spoke on the clauses and the amendments.

Question on the amendments put.

Hon James TO claimed a division. The Chairman's Deputy then ordered the Committee to proceed to a division under Rule 47(1) of the Rules of Procedure.

At 8: 12 am, while the division bell was ringing, the Chairman resumed the chair.

The Chairman announced that among the Members returned by functional constituencies, 24 were present, seven were in favour of the amendments, 14 against them and three abstained; while among the Members returned by geographical constituencies through direct elections, 19 were present, 12 were in favour of the amendments and 6 against them (voting record in **Appendix 26**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the amendments were negatived.

The Chairman stated that as Hon James TO's amendments had been negatived, he might not move the addition of new clause 2A to the Bill.

Question that clauses 2, 3 and 4 stand part of the Bill put and agreed to.

The Council then resumed.

Third Reading

The Secretary for Transport and Housing reported that

the Stamp Duty (Amendment) Bill 2010

had passed through the Committee without amendment. She moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.

That the Legislative Council Panel on Housing be authorized under section 9(2) of the Legislative Council (Powers and Privileges) Ordinance (Cap. 382) to exercise the powers conferred by section 9(1) of the Ordinance so as to order the Secretary for Transport and Housing of the Hong Kong Special Administrative Region to attend before the Panel to produce all the correspondences between the Lands Department and the developer of 39 Conduit Road relating to the Lands Department's enquiry into the property transactions of 39 Conduit Road.

Question on Hon LEE Wing-tat's motion proposed.

The Secretary for Transport and Housing spoke on the motion.

Six Members and Hon KAM Nai-wai spoke on the motion.

While Hon KAM Nai-wai was speaking, the President left the chair at 9:40 am temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Seven other Members and Hon CHIM Pui-chung spoke on the motion.

At 10: 45 am, while Hon CHIM Pui-chung was speaking, the President resumed the chair.

The Secretary for Transport and Housing spoke on the motion again.

Hon LEE Wing-tat replied.

Question on the motion put.

Hon LEE Wing-tat claimed a division. The President then ordered the Council to proceed to a division under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 17 were present, two were in favour of the motion, 14 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 18 were present, 12 were in favour of the motion and five against it (voting record in **Appendix 27**). Since the question was not agreed by a majority of each of the two groups of Members present, he declared that the motion was negatived.

Proactively developing social enterprises

Hon Frederick FUNG moved the following motion and spoke on the motion:

That, this Council urges the Government to proactively develop social enterprises, review the various existing support measures, and conduct in-depth consultation with the public and the industry, and at the same time make reference to the relevant overseas experience, so as to map out a development blueprint for social enterprises in the future, formulate support measures on all fronts and offer policy incentives, and provide appropriate arrangements and support in areas such as laws and regulations, financing, management and operation, manpower training, public education and promotion, market opportunity exploration, and procurement of services and products provided by social enterprises, with a view to offering social enterprises extensive and sustainable room for development.

While Hon Frederick FUNG was speaking, the President left the chair at 11:08 am temporarily and the President's Deputy, Hon Fred LI, took the chair.

Question on Hon Frederick FUNG's motion proposed.

The President's Deputy stated that two Members would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the two amendments would be debated together in a joint debate.

Hon WONG Sing-chi and Dr Hon PAN Pey-chyou, who would move amendments, spoke on the motion and the amendments.

The Secretary for Home Affairs spoke on the motion and the amendments.

Four Members spoke on the motion and the amendments.

Hon Frederick FUNG spoke on the amendments.

The Secretary for Home Affairs spoke again.

Hon WONG Sing-chi moved the following amendment to Hon Frederick FUNG's motion:

To add "in order to narrow social inequality," after "That,"; and to add "; in developing social enterprises, the Government may: (a) set up a 'social enterprise seed fund' with an injection of \$500 million, which is to be merged with the funds of the Enhancing Self-Reliance Through District Partnership Programme; and (b) allocate \$1 billion to set up a 'social enterprise development loan fund' and, based on a principle of emphasizing both commercial operations and social objectives, grant loans to organizations which intend to set up social enterprises" immediately before the full stop.

Question on Hon WONG Sing-chi's amendment to Hon Frederick FUNG's motion proposed, put and agreed to.

As Hon WONG Sing-chi's amendment had been passed, the President's Deputy granted leave for Dr Hon PAN Pey-chyou to revise the terms of his amendment.

Dr Hon PAN Pey-chyou moved the following further amendment to Hon Frederick FUNG's motion as amended by Hon WONG Sing-chi, and explained the revised terms of his amendment to the Council:

To add "; (c) comprehensively review the role of the Government in the development of social enterprises, so as to formulate targeted support measures; (d) set up an interdepartmental working group to remove the barriers for social enterprises, so as to provide them with more comprehensive support; (e) clearly define the meaning of social enterprises, establish criteria for them and introduce a licensing system to facilitate regulation; (f) provide social enterprises with more resources, including increasing non-repayable subsidies instead of offering only loan support; (g) explore parcelling out government tender contracts to facilitate bidding by social enterprises; (h) optimize the use of vacant government premises to create a better operating environment for social enterprises; and (i) enhance manpower training for social enterprises to boost community economic activities and job opportunities" immediately before the full stop.

Question on Dr Hon PAN Pey-chyou's amendment to Hon Frederick FUNG's motion as amended by Hon WONG Sing-chi proposed, put and agreed to.

Hon Frederick FUNG replied.

At 12:28 pm, while Hon Frederick FUNG was speaking, the President resumed the chair.

Question on Hon Frederick FUNG's motion as amended by Hon WONG Sing-chi and Dr Hon PAN Pey-chyou put and agreed to.

Comprehensively upgrading the quality of talents in Hong Kong to complement the upgrading and transformation of small and medium enterprises

Hon Miriam LAU moved the following motion and spoke on the motion:

That talents have been an important element contributing to the vigorous development of small and medium enterprises ('SMEs') in Hong Kong over the years, but for many years, the Government has not formulated a comprehensive policy on nurturing talents to complement the upgrading and transformation of SMEs which employ a large number of employees, resulting in their development being hindered and hence their employees' income cannot improve substantially; as such, this Council urges the Government to:

- (a) formulate a comprehensive policy on talents training to upgrade the quality of talents in Hong Kong in the long run, thereby complementing the upgrading and transformation of SMEs;
- (b) consider relaunching and enhancing the 'SME Training Fund', introduce training programmes for the middle-aged, and enhance the relevant talents nurturing programmes such as the 'Continuing Education Fund', etc.;
- (c) increase the opportunities for young people to go overseas for further studies and exchanges and to receive on-the-job training;
- (d) increase efforts to attract overseas talents, including formulating complementary measures such as increasing the number of places available in international schools to attract overseas talents to stay in Hong Kong, thereby strengthening the exchanges between Hong Kong talents and their counterparts from other places; and
- (e) assist SMEs in upgrading their creativity and innovative capabilities, study the establishment of a fund for industrial upgrading and transformation, and formulate a one-stop programme for enterprise incubation, so as to provide support for SMEs intending to upgrade or transform as well as their employees.

Question on Hon Miriam LAU's motion proposed.

The President stated that Dr Hon PAN Pey-chyou would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Dr Hon PAN Pey-chyou moved the following amendment to Hon Miriam LAU's motion and spoke on the motion and the amendment:

To add ", as" after "That"; to add "quality" after "increase efforts to attract overseas"; to add "quality" after "international schools to attract overseas"; to delete "and" after "other places;"; and to add "; and (f) expand various employment services, training and support schemes, and provide employees with 'training leave', so as to enhance the competitiveness of our manpower resources" immediately before the full stop.

Question on Dr Hon PAN Pey-chyou's amendment to Hon Miriam LAU's motion proposed.

The Secretary for Commerce and Economic Development and Secretary for Education spoke on the motion and the amendment.

Three Members spoke on the motion and the amendment.

Hon Miriam LAU spoke on the amendment.

The Secretary for Commerce and Economic Development and Secretary for Education spoke again.

Question on Dr Hon PAN Pey-chyou's amendment to Hon Miriam LAU's motion put and agreed to.

Hon Miriam LAU replied.

Question on Hon Miriam LAU's motion as amended by Dr Hon PAN Pey-chyou put and agreed to.

Motion for the adjournment of the Council

The President said that he had determined under Rule 16(6) and (7) of the Rules of Procedure that if at the expiration of 75 minutes from the moving of this motion, there were Members who still wished to speak, he would extend the period of the debate until all Members who wished to speak had spoken, and the designated public officer had given her reply. As regards the speaking time, each Member might speak for up to five minutes, and the designated public officer making a reply might speak for up to 15 minutes in total.

Hon Mrs Regina IP moved the following motion and spoke on the motion:

That this Council do now adjourn for the purpose of debating the following issue: the repeated occurrence of tree-falling incidents, and how to prevent the recurrence of similar tragedies.

Question on the motion proposed.

Five Members spoke on the motion.

The Secretary for Development replied.

Question on the motion put and agreed to.

End of session

As it was the last meeting in the session, the President wished Members a restful time during the summer recess.
