Dear Sir/ Madam:

I am deeply concerned about the cessation of Digital Broadcast Corporation (DBC)'s radio service since approximately mid October of this year.

As a permanent resident of HK who have spent the earlier part of my career in radio broadcasting in a senior management role and understand the operational model and regulatory licensing regime of radio broadcasting in Canada, I am aggrieved by this situation and shun to think that the fate of DBC was "politically motivated". I am extremely concerned that Hong Kong's freedom of speech and expression has been dampened as exemplified by this incident.

After a meaningful career in broadcasting including management and operations, I started a career in the investment business. As a hedge fund professional who is also a contributing columnist to several print and electronic media with high circulation and penetration, I was invited by the then management of DBC to host a radio program called "Running the Race" (對沖人生路) in December of last year. "Running the Race" has a "soft talk and music format", whose main theme is to invite guests of various professions, background and life experience to share their views on "how to live life to the fullest". The program has no political overtone whatsoever.

When DBC was forced to go off air, obviously, "Running the Race 對沖人生路" also had to come to an end. Although I am not part of the management of DBC, I work very closely with them and my understanding was that disputes between the shareholders of DBC could not come to terms, and that the radio station ran out of cash to operate.

I have no affiliation with any political parties in Hong Kong. I am just saddened by the fact that the service of DBC has to come to an end. While the Secretary for Commerce and Economic Development Mr. Greg So commented that this is just "commercial disputes between the

shareholders", I also believe that the government could "step in" earlier and take action, instead of letting DBC station's service to discontinue.

I would really want the HK SAR Government to explain to me, not as one of the hosts of a DBC radio show, but as an ordinary permanent resident of Hong Kong, the reason why DBC's "halt of service" does not warrant a full scale investigation? Why does the government turn a "blind eye" on the incident?

DBC ultimately is regulated by the HK SAR government, and when a "broadcasting service" came to a halt, "the public" is affected, the government "should have and could have" intervened before the matters became worse. Now that the DBC station is under "administration" from the Deloitte accountants, I believe it is unlikely that services can be resumed, at least in the foreseeable future. It is sad news also to realize that the majority of legislators rejected holding an inquiry into DBC's halting of service. To extrapolate my point further, I am also concerned about the "real reason" was of a political nature. Do people dare to "speak for justice" anymore, or choose to remain silent?

Lastly, I would like to attach an extract of my article that was published on 5 Nov 2012 in the HK Economic Journal together with this submission, thank you.
