### Submission of Kids' Dream to the Panel on Constitutional Affairs on the Hearing of the Second Report of the Hong Kong Special Administrative Region ("HKSAR") under the United Nations Convention on the Rights of the Child ("UNCRC")

#### 18 November 2013

Kids' Dream is the first child-led organization established in Hong Kong. We have the mission to promote the United Nations Convention on the Rights of the Child (UNCRC).

Kids' Dream has submitted shadow report to the Committee on the Rights of the Child and has sent representatives to attend both the Pre-Sessional Working Group meeting of the committee in February 2013 and the 64<sup>th</sup> Session of the Committee in September 2013.

### Hong Kong Government says...

(One of the reasons) Apart from the Family Council, policy bureaux and departments can also **gauge children's views and suggestions** through the Children's Right Forum (CRF)

# But what children think about Children's Right Forum...

#### 1. Low representation

- Only several children's groups are being consulted. Most of HK children are not aware of this forum.
- Low representation of disadvantaged children (e.g. Children with disabilities, children of ethnic minority origins...are rarely being invited.) despite repeated calls from various children's groups.

#### 2. Not meeting regularly

 The total number of meetings held since late-2005 is 23, which is equivalent to less than <u>3 meetings</u> per year. The forum was meant to be held at least quarterly

#### 3. Not consulting in child-friendly way

- Children's views are sought at the Forum with short notice.
- Children's views are sought when the policy is almost come into place with little room for changes and adjustment. It is more little a show than sincere consultation.
- Meeting documents are with LOTS of difficult words (without much explanations)

## What children think about Children's Rights Forum

presenting discussion topics, leaving little discussion time, not aimed to help children understand issues involved before seeking their views.

- Did not provide specific questions to ask for our opinions. Children always get lost.
- Chairman was appointed and not selected by children.
- After the Forum, there is little feedback on what views were adopted and what were not, and why.

#### 4. No authority

- Forum is hosted by Constitutional and Mainland Affairs Bureau, however, it only takes a coordinating role of inviting other bureaux and departments to present their services. It has no power to influence which action is taken or not taken by these bureaux and departments after the Forum.
