林主席：

再次要求召開公聽會討論  
大學教育資助委員會的政策對專上教育發展的影響

本人於5月14日曾致函閣下，並附上理工大學教職員協會的函件，要求委員會召開公聽會，討論近年大學教育資助委員會（下稱教資會）的政策對專上教育發展的影響。教資會於6月1日覆函本委員會，但未確切回覆教職員團體的憂慮和疑問。函件所述的「優配學額」機制得各大院校大致贊同，與本人所接觸的院校團體的意見並不相同。教資會亦未詳細解釋研究評審工作、優配研究金的計算金額與撥款模式的關係。

本人另附上大專及專上院校工會聯盟要求召開公聽會的函件，本人希望閣下促請教資會及教育局認真回應專上教育持份者的疑問，並請盡快安排於九月前召開公聽會，邀請本港專上教育持份者團體代表和關心該議題的團體和人士出席，以趕及教資會將於本年九月向各資助院校的撥款作決定前，向政府當局和教資會表達意見和憂慮。

期盼閣下考慮本人的建議，如有查詢，請隨時與本人聯絡。
