The Clerk to LegCo ("the Clerk") noticed that Dr Hon YIU Chung-yim had not subscribed the affirmation with the words of the oath prescribed by the Oaths and Declarations Ordinance (Cap. 11) ("the Ordinance") and hence he declined jurisdiction to administer the affirmation. As Dr YIU had not completed the oath-taking in accordance with the Ordinance, by virtue of Rule 1 of the Rules of Procedure ("RoP"), he could not attend a meeting or vote therein (including the election of the President to be held at that meeting).

- The Clerk noticed that Hon Sixtus LEUNG had not taken the oath in accordance with the words of the oath prescribed by the Ordinance and had displayed an object (a banner bearing the words "HONG KONG IS NOT CHINA") during his oath-taking. The Clerk thus had reasonable doubts as to whether Mr LEUNG understood the LegCo Oath, and hence he declined jurisdiction to administer the oath. As Mr LEUNG had not completed the oath-taking in accordance with the Ordinance, by virtue of Rule 1 of RoP, he could not attend a meeting or vote therein (including the election of the President to be held at that meeting).
- The Clerk noticed that Hon YAU Wai-ching had not subscribed the affirmation with the words of the oath prescribed by the Ordinance and had displayed an object (a banner bearing the words "HONG KONG IS NOT CHINA") during her oath-taking. The Clerk thus had reasonable doubts as to whether Miss YAU understood the LegCo Oath, and hence he declined jurisdiction to administer the affirmation. As Miss YAU had not completed the oath-taking in accordance with the Ordinance, by virtue of Rule 1 of RoP, she could not attend a meeting or vote therein (including the election of the President to be held at that meeting).

Election of President

(During the election, the meeting was suspended for four times.)

In accordance with paragraphs 6 and 7 of Schedule 1 to RoP, Hon LEUNG Yiu-chung was the presiding Member for the election of the President as he had the longest continuous service in the Council and was not being nominated for the office of President.

With Hon LEUNG Yiu-chung's consent, some Members spoke on matters relating to the election of the President. After Members had spoken, Mr LEUNG decided not to preside at the election. As a result, Hon Abraham SHEK, who was next in the order of precedence of Members and who was not being nominated for the office of President, became the presiding Member for the election of the President.

(As the order of the meeting had been disrupted and could not be restored, Hon Abraham SHEK announced that the meeting venue be changed to Conference Room 1.)

Hon Abraham SHEK announced that two valid nominations for the office of President had been received by the Clerk's office upon the close of the nomination period. Hon James TO was nominated by Hon Dennis KWOK and the nomination was seconded by Hon Alvin YEUNG, Hon WU Chi-wai, Dr Hon YIU Chung-yim, Hon Charles Peter MOK, Hon Claudia MO, Hon LEUNG Kwok-hung, Dr Hon Fernando CHEUNG, Dr Hon LAU Siu-lai and Hon CHU Hoi-dick. Hon Andrew LEUNG was nominated by Hon Starry LEE and the nomination was seconded by Hon Abraham SHEK, Hon MA Fung-kwok, Hon Mrs Regina IP, Hon CHAN Kin-por, Hon Jeffrey LAM, Hon Martin LIAO, Hon POON Siu-ping, Ir Dr Hon LO Wai-kwok and Hon Tommy CHEUNG. In accordance with the procedure set out in the Schedule to RoP, Hon Abraham SHEK ordered a vote by secret ballot.

Members cast their votes and the votes were counted. The result of the vote was that Hon James TO received no vote and Hon Andrew LEUNG received 38 votes. There were three blank votes. Hon Abraham SHEK declared Hon Andrew LEUNG elected as the President of LegCo.

Hon Andrew LEUNG took the chair and addressed the Council.
