First Reading and Second Reading

The President's Deputy proposed the question on the Second Reading of the Bill and referred the Bill to the House Committee in accordance with Rule 54(4) of the Rules of Procedure. The debate on the Bill was adjourned.

Motion under the Legislative Council (Powers and Privileges) Ordinance
