## Government Bills

### First Reading and Second Reading

- Road Traffic (Amendment) Bill 2017 : Secretary for Transport and Housing
- Waterworks (Amendment) Bill 2017 : Secretary for Development

After the above Bills were read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure, the public officers moved the Second Reading of the Bills respectively. The questions on the Second Reading of the Bills were proposed respectively and the debates were adjourned. The Bills were referred to the House Committee in accordance with Rule 54(4) of the Rules of Procedure.

### Resumption of Second Reading debate and Committee stage

- Appropriation Bill 2017 : Financial Secretary

The Second Reading debate on the above Bill, which was moved on 22 February 2017, resumed. After the Financial Secretary and other public officers had spoken, the question on the Second Reading of the Bill was put and agreed to (details of division in the **Appendix**). The Bill was read the second time and committed to a committee of the whole Council.

(During the Committee stage of the Bill, the meeting was suspended at 7:32 pm on 26 April and resumed at 9:00 am on 27 April 2017.)

The Council went into committee and considered the Bill. In accordance with Rule 68 of the Rules of Procedure, the committee first considered the Schedule to the Bill. The question that the sums for the 26 heads as set out in the Official Record of Proceedings, to which no amendments were proposed stand part of the Schedule was proposed. The committee proceeded to the first debate on the 26 heads. After Members and a public officer had spoken, the question that the sums for the 26 heads stand part of the Schedule was put and agreed to.

The committee proceeded to consider a total of 185 amendments to the Bill, which involved 58 heads, proposed by 20 Members as set out on the Agenda.

The committee commenced the second debate under the themes of “Rule of Law, Governance, Elections and District Administration”, covering 85 amendments proposed by 14 Members to 18 heads as set out in the Official Record of Proceedings. After Members and a public officer had spoken on the amendments, the second debate came to a close.

### **Next meeting**

The Council resumed. The President declared that the next Council meeting would be held on 10 May 2017 at 11:00 am.

The Council was adjourned at 7:36 pm on 27 April 2017.
