Committee stage

(During the Committee stage of the Bill, the meeting was suspended at 7:55 pm on 10 May and resumed at 9:00 am on 11 May 2017.)

The Council went into committee to continue the consideration of the Schedule to the Bill. The committee commenced the third debate under the themes of "Poverty Alleviation, Welfare and Medical Services, Elderly Care, Public Health and Population Policy", covering 16 amendments proposed by six Members to six heads as set out in the Official Record of Proceedings. After Members and public officers had spoken on the amendments, the third debate came to a close. The committee commenced the fourth debate under the themes of "Land, Housing, Transportation, Environment and Conservation", covering 38 amendments proposed by eight Members to 16 heads as set out in the Official Record of Proceedings. After Members and a public officer had spoken on the amendments, the fourth debate came to a close.

The committee commenced the fifth debate under the themes of "Economic Development and Innovation and Technology", covering 19 amendments proposed by six Members to 13 heads as set out in the Official Record of Proceedings. After Members and a public officer had spoken on the amendments, the fifth debate came to a close.

The committee commenced the sixth debate under the themes of "Education, Manpower, Youth, Arts and Culture and Sport", covering 27 amendments proposed by 11 Members to five heads as set out in the Official Record of Proceedings. Members and a public officer spoke on the amendments.
