Addresses

The Members presenting the papers as set out on the Agenda addressed the Council respectively.

Questions

Six oral questions as set out on the Agenda (i.e. Questions 1 to 6) were put by the Members and oral replies were given by the public officers.

Written replies to Questions 7 to 22 as set out on the Agenda were supplied to Members.

Requests for moving motions for the adjournment of the Council under Rule 16(2) of the Rules of Procedure

(The meeting was suspended twice for the President to consider the requests.)

Seven Members (Hon HUI Chi-fung, Hon Claudia MO, Hon LEUNG Kwok-hung, Dr Hon Fernando CHEUNG, Hon KWONG Chun-yu, Hon LEUNG Yiu-chung and Hon Andrew WAN) respectively rose to seek the President's permission for them to move a motion for the adjournment of the Council under Rule 16(2) of the Rules of Procedure for the purpose of debating issues in connection with Mr LIU Xiaobo. As the President was not satisfied that the proposed motions met the requirements of Rule 16(1) and (2) of the Rules of Procedure, the moving of such motions was not allowed.

Government Bills

First Reading and Second Reading

 Road Tunnels (Government) : Secretary for Transport and Housing (Amendment) Bill 2017

After the above Bill was read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure, the public officer moved the Second Reading of the Bill. The question on the Second Reading of the Bill was proposed and the debate was adjourned. The Bill was referred to the House Committee in accordance with Rule 54(4) of the Rules of Procedure.

Resumption of Second Reading debate, Committee stage and Third Reading

- Apology Bill : Secretary for Justice

(During the Second Reading debate of the Bill, the meeting was suspended at 7:49 pm on 12 July and resumed at 9:00 am on 13 July. The meeting was also suspended for a while during the Committee stage of the Bill.)

The debate on the Second Reading of the above Bill, which was moved on 8 February 2017, resumed. After Members and the public officer had spoken, the question on the Second Reading of the Bill was put and agreed to (details of division in **Appendix 1**). The Bill was read the second time and committee to a committee of the whole Council.

The Council went into committee and considered the Bill. The provisions of the Bill and amendments thereto as set out on the Agenda were debated and voted in accordance with the relevant debate and voting arrangements and the relevant provisions of the Rules of Procedure. In considering the Bill, the following questions were put:

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage with amendments. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to (details of division in **Appendix 2**). The Bill was read the third time and passed.

Request for moving a motion under Rule 91 of the Rules of Procedure

(The meeting was suspended for a while for the President to consider the request.)

Hon James TO rose to seek the President's permission for him to move a motion under Rule 91 of the Rules of Procedure to suspend Rule 18 of the Rules of Procedure, in order that the Council could deal with the Government motions set out on the Agenda before considering the Stamp Duty (Amendment) Bill 2017. The President stated that the order of transacting business at a Council meeting was stipulated in Rule 18(1) of the Rules of Procedure. Given that such motions and the aforesaid Bill were items proposed by the Government, any request for changing the order of transacting such business should be made by the Government, and not a Member. Against this background, Mr TO's request was not allowed. - Stamp Duty (Amendment) Bill 2017 : Secretary for Transport and Housing

The debate on the Second Reading of the above Bill, which was moved on 8 February 2017, resumed. After Members and the public officer had spoken, the question on the Second Reading of the Bill was put and agreed to (details of division in **Appendix 3**). The Bill was read the second time.
