758CL – Site formation and associated infrastructural works for development of columbarium, crematorium and related facilities at Sandy Ridge Cemetery

At the suggestion of the Chairman of the Public Works Subcommittee, we now provide a written response to the enquiries raised by Hon CHU Hoi-dick in his letter entitled "Re: Infrastructural works for the integrated funeral facilities at Sandy Ridge". ## Re: Infrastructural works for the integrated funeral facilities at Sandy Ridge

#### (I) Scattering of ashes as an alternative to interment of ashes in niches

(1) With regard to the scattering of ashes at sea and in the Gardens of Remembrance (GoRs), please state the numbers of these cases and their respective percentages in the past 5 years. Please also advise on the Government's promotion efforts and the difficulties encountered.

The number of green burial cases (i.e. scattering of ashes in GoRs and at sea) handled by the Food and Environmental Hygiene Department (FEHD) from 2012 to 2016 and the percentages of these cases are provided in the following table –

The Government is committed to promoting green burial as a more sustainable means of handling human ashes. To promote green burial, FEHD has devised new initiatives and deployed additional resources to carry out the publicity work which included arranging exhibitions, public seminars and talks, producing and broadcasting promotional videos, putting up posters and banners as well as collaborating with relevant non-governmental organisations.

It takes time for the community to accept green burial. After all, whether or not to adopt green burial depends not only on the wishes of the deceased person but also the preference of the bereaved family. While securing a paradigm shift in culture and traditions is by no means easy, we recognise the need for proactive and sustained efforts to fortify the necessary mindset changes. With persistent efforts to promote and improve the relevant services, we are confident that green burial will gradually gain public acceptance as the preferred way to dispose of ashes. This can be vindicated by our experience in promoting cremation over land burial. Before the 1980's, the predominant approach was land burial of the deceased, with cremation taking up only a small minority. The merits of cremation gradually dawned upon the community after a few decades of persistent public education. At present, land burial and cremation respectively take up about 7% and 93% of the annual number of deaths.

(2) Please advise whether the Government has considered or will consider opening up some areas in the country parks for the public to scatter ashes. If yes, please elaborate on the current work; if not, please give reason(s).

FEHD currently manages 11 GoRs in 8 columbaria where the public can scatter ashes of the deceased. Based on the usage of the service of scattering ashes in GoRs in recent years, the relevant facilities should be adequate to cater for the future needs of the public for such service. Besides, FEHD will continue to identify suitable sites within its cemeteries, crematoria and columbaria for the construction of more GoRs. The Government has no plans to provide such facilities in country parks.

# (II) Public columbaria in rural areas

Please advise whether there are still public columbaria under FEHD in rural areas which are for the exclusive use of indigenous villagers. If yes, please advise on their utilisation; if not, please elaborate on the situation.

At present, the niches in FEHD's Cheung Chau Columbarium, Peng Chau Columbarium and Lamma Island Columbarium in the Islands District are allocated to indigenous villagers or bona fide residents residing continuously for a long period of time in the Islands District. As at end of February 2017, the utilisation of niches in these columbaria is as follows –

#### Note:

- (1) The Peng Chau Columbarium Extension scheduled for completion in 2017 will provide about 360 new niches.
- (2) The Cheung Chau Columbarium Extension scheduled for completion in 2018 will provide about 1 250 new niches.

# (III) <u>District-based columbarium development scheme</u>

(1) Please advise whether the Government has considered slightly scaling down the size of the project at Sandy Ridge, or at least carrying out the project in phases, depending on future development, instead of constructing all 200 000 niches in one go. In fact, in the North District, there will be 44 000 niches to be provided at the Wo Hop Shek (Phase I) project, as well as possible supply from Fung Ying Seen Koon despite it is not certain if it can be obtain a licence. The North District's commitment to the supply of niches is far greater than that of any other districts. Residents of the North District may find this rather unfair to them.

The present item submitted for deliberation by the Public Works Subcommittee is on the application for funding for site formation, associated road works and ancillary works for the proposed columbarium development at Sandy Ridge Cemetery.

At this stage, the details of the construction works of the columbarium project are yet to be finalised. We anticipate that the columbarium project, which could provide some 200 000 niches, will be carried out in phases, with the niches to be allocated by phases as well. We will closely monitor the situation after the commencement of operation of the columbarium, and will timely review the allocation plan of the niches and the relevant measures

(including the arrangements for crowd control, traffic control and the burning of joss sticks and paper offerings, etc.).

(2) I thank FEHD for providing the supplementary information requested by the Chairman of the Panel on Food Safety and Environmental Hygiene in its written reply (LC Paper No. CB(2)761/16-17(01)). However, I would like to have a more clear and holistic picture. With regard to the 24 sites, please complete the table below:

(3) Please advise on the projected demand for niches in Hong Kong at present and for the next 5, 10, 15 and 20 years.

The information sought is provided as follows –

The prevailing practice after cremation is to store ashes in niches of columbaria. For ease of calculation, the estimated demand for niches is assumed to be similar to the estimated number of cremations.

# (IV) Consideration given to NT North Development

I noted that the concept of "New Territories (NT) North Development" was not available when the planning for the Sandy Ridge project began. According to the map, the Sandy Ridge facilities are just 1 kilometre away from the proposed residential area at Hung Lung Hang, and the planning intention of the nearby Man Kam To area is Logistics Corridor.

Given that the scale of the "NT North Development" is very large, with a population reaching 250 000 to 350 000 and a working population of over 200 000, would the Government update the impacts on environment and traffic, etc. which might residents of NT North due to the Sandy Ridge project after the concept of "NT North Development" has rolled out?

For the Sandy Ridge project, the Government has completed the traffic impact assessment and, in accordance with the Environmental Impact Assessment Ordinance (Cap. 499), the environmental impact assessment. The assessments indicated that the Sandy Ridge project is feasible from traffic and environmental aspects.

The "NT North Study" is a only preliminary feasibility study. The broad land use plans proposed therein are currently preliminary concepts only, and have been included in the "Hong Kong 2030+" study for public consultation. Upon completion of the "Hong Kong 2030+" study, the Government will determine the next steps for the NT North Development taking into account the views collected. Detailed planning and engineering studies would be carried out (including environmental impact assessment, traffic impact assessment and conducting public consultation) at appropriate timing.

Chronologically, the planning of the Sandy Ridge project is earlier than the "NT North Study". In general, when the Government carries out the environmental impact assessment and traffic impact assessment in the planning and engineering studies for the NT North in future, the Sandy Ridge project would be treated as a committed project and would be included in the scope of such studies for comprehensive assessment.

#### (V) NT North East regional environmental impact assessment

Similar to situation at Tsang Tsui, in the NT North East, apart from the existing slaughterhouse, water treatment works and sewage treatment works, there is also the expansion of the North East NT Landfill in recent years, as well as the asphalt plant at Man Kam To Road. Together with the existing Sha Ling Livestock Waste Composting Plant, the future wholesale poultry market, the Liantang Boundary Control Point, and the opening of the Closed Area (which allow more commercial facilities at the boundary), etc., and with a population reaching 420 000 to 520 000 in the NT North East and the NT North Developments, would the

# Government prepare a NT North East regional environmental impact assessment and consult residents in the North District?

The Government has taken into account local conditions of the NT North and its adjoining areas, including the existing/planned/possible transport and infrastructure networks, in formulating the strategic planning framework and broad land use concepts.

As mentioned in the reply to question (4) above, upon completion of the "Hong Kong 2030+" study, the Government will determine the next steps for the NT North Development taking into account the views collected, and carry out relevant studies and assessments.

## (VI) Traffic impact assessment

Please advise the amount of additional traffic flows at Man Kam To Road and relevant roads during special days when the Sandy Ridge facilities are in full operation. Would there be potential conflicts with the planning intention of the proposed Logistics Corridor to be constructed at Man Kam To Road?

When all the 200 000 niches in the Sandy Ridge columbarium have been allocated, it is anticipated that there will be additional traffic flow of about 500 passenger car unit<sup>1</sup> per hour at the northern lane of Man Kam To Road at peak hours during Ching Ming and Chung Yeung festive periods.

Man Kam To Logistics Corridor is one of the potential development areas in the "NT North Study". As mentioned in the reply to question (4) above, the proposed broad land use plans are currently preliminary concepts only, which have been included in the "Hong Kong 2030+" study for public consultation. Upon completion of the "Hong Kong 2030+" study, the Government will determine the next steps for the NT North development taking into account the views collected, and carry out relevant studies and assessments.

Passenger car unit (pcu) is a unit for measuring traffic flow in equivalent number of private cars. For example, a pcu value of 1.0 is assigned to private cars and taxis. Heavy vehicles such as goods vehicles or buses which usually travel at a lower speed are assigned higher pcu values.
