## Re: Proposed Resolution under Section 23(3) of the Road Traffic Ordinance (Cap. 374)

We are scrutinizing the above Proposed Resolution with a view to advising Members and have the following observations in relation to the drafting aspect of the Proposed Resolution -

It is noted that the current version of the Road Traffic (Public Light Buses: Limit on Number) Notice 2016 ("the Notice"), which was published in the Gazette on 21 June 2016 under L.N. 101 of 2016, is now given a chapter number ("Cap. No."), namely Cap. 374 sub. leg. X and published in electronic form on the Hong Kong e-Legislation. A verified copy of Cap. 374 sub. leg. X is attached for your reference (Annex I).

Given that the Notice now has a Cap. No., please explain why it is referred to as "L.N. 101 of 2016" rather than "Cap. 374 sub. leg. X" in the Proposed Resolution. You may wish to consider making reference to the subsidiary legislation by Cap. No. as in the previous resolution under section 23(3) of Cap. 374 passed by the Legislative Council on 24 May 2006 (L.N. 124

of 2006) and amend the reference to the Notice in the Proposed Resolution to "Cap. 374 sub. leg. X". A copy of L.N. 124 of 2006 is attached for your reference (Annex II).

As the Subcommittee on Proposed Resolution under Section 23(3) of the Road Traffic Ordinance (Cap. 374) will discuss the Proposed Resolution at its meeting on 28 March 2017, we should be grateful if you could let us have your reply in both English and Chinese languages as soon as possible.

## RESOLUTION OF THE LEGISLATIVE COUNCIL

Resolution made and passed by the Legislative Council under section 23(3) of the Road Traffic Ordinance (Cap. 374) on 24 May 2006.

RESOLVED that the period for which there remains in force the limit on the number of vehicles which may be registered as public light buses specified in the Public Light Buses (Limitation on Number) Notice (Cap. 374 sub. leg. K) and extended to 20 June 2006 by Legal Notice No. 141 of 2001, be further extended to 20 June 2011.
