**Council meeting of 25 October 2017**

**Amendments to motion on  
taking forward the follow-up tasks of the co-location arrangement  
at the West Kowloon Station of  
the Guangzhou-Shenzhen-Hong Kong Express Rail Link**

Further to LC Paper No. CB(3) 13/17-18 issued on 6 October 2017, nine Members (Hon Claudia MO, Hon Jeremy TAM, Hon Dennis KWOK, Hon Alvin YEUNG, Hon Tanya CHAN, Dr Hon KWOK Ka-ki, Dr Hon Fernando CHEUNG, Hon WU Chi-wai and Hon CHU Hoi-dick) have respectively given notice of their intention to move amendments to the Secretary for Transport and Housing (“STH”)’s motion above at the Council meeting of 25 October 2017. As directed by the President, the respective amendments will be printed in the terms in which they were handed in on the Agenda of the Council.

2. The President will order **a joint debate** on the above motion and the nine amendments. To facilitate Members’ debate, I set out below the relevant proceedings under which the President will:

- (a) call upon STH to speak and move his motion, and then propose the question on STH’s motion;
- (b) call upon the nine Members who wish to move amendments to speak in the following order, but no amendment is to be moved at this stage:
  - (i) Hon Claudia MO;
  - (ii) Hon Tanya CHAN;
  - (iii) Hon Jeremy TAM;

- (iv) Hon Dennis KWOK;
  - (v) Hon Alvin YEUNG;
  - (vi) Dr Hon KWOK Ka-ki;
  - (vii) Dr Hon Fernando CHEUNG;
  - (viii) Hon WU Chi-wai; and
  - (ix) Hon CHU Hoi-dick;
- (c) invite other Members to speak;
  - (d) call upon STH to speak on the amendments;
  - (e) in accordance with Rule 34(5) of the Rules of Procedure, call upon the nine Members to move their amendments in the order set out in paragraph (b) above. The President will first invite Hon Claudia MO to move her amendment to the motion, and forthwith propose and put to vote the question on Hon Claudia MO's amendment;
  - (f) after Hon Claudia MO's amendment has been voted upon, deal with the other eight amendments; and
  - (g) after all amendments have been dealt with, call upon STH to reply. Thereafter, the President will put to vote the question on STH's original motion, or his motion as amended, as the case may be.

3. Members are invited to note that each Member (including amendment mover) can only **speak once and the time limit is 15 minutes. Public officer(s) will not be subject to any speaking time limit.**

4. For Members' reference, the terms of the original motion and the marked-up version of the amendments are set out in the **Appendix**.

**1. Secretary for Transport and Housing’s original motion**

Regarding the arrangement for conducting Hong Kong and Mainland customs, immigration and quarantine procedures (“the co-location arrangement”) at the West Kowloon Station of the Hong Kong Section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link (“XRL”), this Council supports the Government in taking forward the follow-up tasks of the co-location arrangement pursuant to the “Three-step Process” proposal announced on 25 July 2017, including reaching a Co-operation Arrangement with the Mainland, seeking the approval and endorsement of the Co-operation Arrangement by the Standing Committee of the National People’s Congress through a decision to be made by the Standing Committee, as well as commencing the local legislative process thereafter, so as to meet the target of implementing the co-location arrangement at the West Kowloon Station upon the commissioning of the Hong Kong Section of the XRL in the third quarter of 2018, with a view to fully unleashing the transport, social and economic benefits of the Hong Kong Section of the XRL and maximising convenience to passengers.

**2. Motion as amended by Hon Claudia MO**

Regarding *That as* the arrangement for conducting Hong Kong and Mainland customs, immigration and quarantine procedures (“the co-location arrangement”) at the West Kowloon Station of the Hong Kong Section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link (“XRL”) *has aroused great controversies*, this Council ~~supports the Government in taking forward the follow-up tasks of the co-location arrangement pursuant to the “Three step Process” proposal announced on 25 July 2017, including reaching a Co-operation Arrangement with the Mainland, seeking the approval and endorsement of the Co-operation Arrangement by the Standing Committee of the National People’s Congress through a decision to be made by the Standing Committee, as well as commencing the local legislative process thereafter, so as to meet~~ *requests the Special Administrative Region (“SAR”) Government to*

*invite an independent academic institution to conduct a referendum-like, territory-wide and large-scale opinion survey on comparing community organizations' proposal of implementing the co-location arrangement in the Mainland and the scheme announced by the SAR Government on 25 July 2017 for implementing the co-location arrangement at the West Kowloon Station, rather than hastily neglect other feasible options for the sake of meeting the target of implementing the co-location arrangement at the West Kowloon Station upon the commissioning of the Hong Kong Section of the XRL in the third quarter of 2018, with a view to fully sacrificing the full unleashing of the transport, social and economic benefits of the Hong Kong Section of the XRL and maximising convenience to passengers, ruining the Basic Law and 'one country, two systems', and failing to maximise convenience to Hong Kong people.*

### **3. Motion as amended by Hon Tanya CHAN**

Regarding As the arrangement for conducting Hong Kong and Mainland customs, immigration and quarantine procedures ("the co-location arrangement") at the West Kowloon Station of the Hong Kong Section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link ("XRL") ***clearly contravenes the provisions of the Basic Law, including Articles 18 and 22, damages "one country, two systems", and has not gone through any public consultation,*** this Council ~~supports~~ ***opposes*** the Government in taking forward the follow-up tasks of the co-location arrangement pursuant to the "Three-step Process" proposal announced on 25 July 2017, including reaching a Co-operation Arrangement with the Mainland, ***and*** seeking the approval and endorsement of the Co-operation Arrangement by the Standing Committee of the National People's Congress through a decision to be made by the Standing Committee, ~~as well as commencing;~~ ***this Council therefore requests the Special Administrative Region Government to withdraw "the co-location arrangement", implement the "Mainland co-location arrangement" instead in at least one station along the Mainland section of the XRL with reference to the "Shenzhen Bay Port model", immediately conduct a public consultation which is in compliance with the existing internal guidelines of the Government to facilitate discussions on the relevant arrangement with the Mainland as soon as possible, and then commence*** the local legislative process thereafter, ~~so as to meet the target of implementing the co-location arrangement at the West Kowloon Station, so as to implement the "Mainland co-location arrangement" at a Mainland station upon the commissioning of the Hong Kong Section of the XRL in the third quarter of 2018, with a view to fully unleashing~~ ***and, on the premise of not contravening the Basic Law, fully***

*unleash* the transport, social and economic benefits of the Hong Kong Section of the XRL and ~~maximising~~ *maximise* convenience to passengers.

economic benefits of the Hong Kong Section of the XRL and ~~maximising~~ *maximise* convenience to passengers.
