Report No. 4/17-18 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 15 November 2017.

Subsidiary legislation considered

2. The House Committee has considered the following item of subsidiary legislation:

3. The House Committee formed a subcommittee to study the above item of subsidiary legislation in detail at its meeting on 20 October 2017. The Subcommittee made a verbal report at the House Committee meeting on 3 November 2017, and provided Members with a written report vide LC Paper No. CB(2)259/17-18 on 8 November 2017.
