**Report No. 7/17-18 of the House Committee on Consideration of
Subsidiary Legislation and Other Instruments**

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 28 February 2018.

3. A subcommittee was proposed to be formed to study item (1) in detail at the House Committee meeting on 2 February 2018. Since only two Members have signified to join the proposed subcommittee by the deadline for signification of membership, it cannot be formed by virtue of House Rules 21(b) and 26(f).

4. In respect of items (2) to (12), the House Committee considered it not necessary to form any subcommittee to study these 11 items of subsidiary legislation.
