- Inland Revenue (Amendment) (No. 3) : Secretary for Innovation and  
Bill 2018 Technology

The debate on the Second Reading of the Bill, which was moved on 2 May 2018, resumed. After Members and the public officer had spoken, the question on the Second Reading of the Bill was put and agreed to. The Bill was read the second time and committed to a committee of the whole Council.

- Employment (Amendment) Bill 2018 : Secretary for Labour and Welfare

The debate on the Second Reading of the Bill, which was moved on 20 June 2018, resumed. After Members and the public officer had spoken, the question on the Second Reading of the Bill was put and agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. The provisions of the Bill and amendments thereto as set out on the Agenda were debated and voted in accordance with the relevant debate and voting arrangements and the relevant provisions of RoP.
