## **Government Bills**

### First Reading and Second Reading (debate to be adjourned)

- Occupational Retirement Schemes (Amendment) : Secretary for Financial  
Bill 2019 Services and the Treasury

After the Bill was read the first time and ordered to be set down for Second Reading under RoP 53(3), the public officer moved the Second Reading of the Bill. The question on the Second Reading of the Bill was proposed and the debate was adjourned. The Bill was referred to the House Committee in accordance with RoP 54(4).

### Second Reading (debate to resume)

- Appropriation Bill 2019 : Financial Secretary

The debate on the Second Reading of the Bill, which was moved on 27 February 2019, resumed.<sup>1</sup> After Members had spoken, the question on the motion that the debate on the Second Reading of the Bill be adjourned to the meeting of 8 May 2019 was proposed, put and agreed to.

## **Member's Motion on Subsidiary Legislation/Instruments**

### Proposed resolution to extend the period for amending subsidiary legislation

Hon CHUNG Kwok-pan moved the motion as set out on the Agenda. The question on the motion was proposed. After Members had spoken, the question on the motion was put and agreed to.


