**Motion to take note of Report No. 15/18-19 of the House Committee
on Consideration of Subsidiary Legislation and Other Instruments**

Hon Starry LEE, Chairman of the House Committee, has given notice under Rule 49E(2) of the Rules of Procedure to move the attached motion to take note of Report No. 15/18-19 of the House Committee in relation to the Rating (Exemption) Order 2019 (L.N. 28/2019) at the above meeting. The President has directed that the motion be printed in the terms in which it was handed in on the Agenda of the Council.

2. To assist Members in debating the motion, I set out the relevant proceedings under which the President will:

- (a) invite the Chairman of the House Committee to move the take-note motion;
- (b) propose the question on the motion;
- (c) invite the chairman of the subcommittee formed to scrutinize the subsidiary legislation to speak;
- (d) invite other Members to speak;
- (e) invite the public officer to speak after all Members who wish to speak have spoken (no Member may speak after the public officer has spoken); and
- (f) in accordance with Rule 49E(9) of the Rules of Procedure, after Members and the public officer have spoken on the motion, order that the debate will come to a close, and will not put any question.

3. Members are invited to note that each Member (including the mover of the motion) may **only speak once in the debate and the time limit is 15 minutes**. Public officer will not be subject to any speaking time limit.
