# Public Health and Municipal Services (Fees) (Amendment) Regulation 2019 ("the Amendment Regulation")

#### **Debate and voting arrangements**

#### Object of the Amendment Regulation

- To amend the Public Health and Municipal Services (Fees) Regulation (Cap. 132CJ) to:
  - (a) introduce new fees for depositing ashes for a fixed period;
  - (b) reduce the fees for permanent deposit of ashes to a nominal sum of \$1; and
  - (c) prescribe a fee for depositing an additional set of ashes in a niche.

The Amendment Regulation seeks to set out the fees for deposit of ashes in order to effect an extendable arrangement for niche allocation. Currently, the one-off fee levels for permanent deposit of ashes in a standard and large niche are \$2,800 and \$3,600 respectively. The extendable arrangement is to introduce an initial deposit period of 20 years to newly allocated public niches, followed by extension for 10 years recurrently on application and payment of the prevailing prescribed fees. The Amendment Regulation proposes, among others:

- (a) pitching the fees at \$120 per year and \$150 per year for a standard niche and a large niche respectively, i.e. charging a standard niche at \$2,400 and a large niche at \$3,000 for the initial deposit period of 20 years; and
- (b) retaining the fee for permanent deposit of ashes in Schedule 6 to Cap. 132CJ as proposed in section 3(4) of the Amendment Regulation and setting it at a nominal sum of \$1 (irrespective of the type of niche) to cater for exceptional circumstances in which permanent deposit is justified and accepted at the discretion of the Director of Food and Environmental Hygiene ("DFEH").

#### Dr Hon Helena WONG's proposed resolution

Dr Hon Helena WONG's proposed resolution seeks to delete section 3(4) of the Amendment Regulation to repeal the above Administration's proposal in (b) and retain the existing fees for permanent deposit of ashes in standard and large niches.

A comparison among Dr WONG's proposed resolution, the existing arrangement and the major proposals of the Amendment Regulation is as follows:
