## Second Reading (debate to be adjourned)

 Court Proceedings (Electronic : Chief Secretary for Administration Technology) Bill

The public officer moved the Second Reading of the Bill. The question on the Second Reading of the Bill was proposed. In accordance with RoP 54(4), the debate was adjourned and the Bill was referred to the House Committee.

Employment (Amendment) Bill 2019 : Secretary for Labour and Welfare

The public officer moved the Second Reading of the Bill. Immediately after the question on the Second Reading of the Bill was proposed, Hon HO Kai-ming rose to seek the President's permission for him to move a motion under RoP 54(4) that the Second Reading debate on the Bill be not adjourned. The President suspended the meeting to consider his request. After consideration, the President did not accede to Mr HO's request and explained his decision to the Council.

The public officer then rose to seek the President's permission for him to move a motion under RoP 54(4) that the Second Reading debate on the Bill be adjourned and the Bill be referred to the Panel on Manpower instead of the House Committee. The President suspended the meeting to consider his request. After consideration, the President acceded to the public officer's request and explained his decision to the Council.

The public officer moved the motion under RoP 54(4). The question on the motion was proposed. Members spoke on the motion. Hon CHAN Chi-chuen drew the attention of the President to the absence of a quorum. The President then directed Members to be summoned.

# **Adjournment of the Council**

After 15 minutes had expired, a quorum was not present. The President adjourned the Council at 2:56 pm on 9 January 2020 in accordance with RoP 17(2).
