Employment (Amendment) Bill 2019 : Secretary for Labour and Welfare

The Council continued the debate on the motion moved by the Secretary for Labour and Welfare on 9 January 2020 under RoP 54(4) that the Second Reading debate on the Bill be adjourned and the Bill be referred to the Panel on Manpower instead of the House Committee. After Members and the public officer had spoken, the question on the motion was put and agreed to (details of division in **Appendix 2**).
