Government Bill

Second Reading (debate to resume) (response by public officers) and consideration by committee of the whole Council

— Appropriation Bill 2020 : Financial Secretary

The Council continued the Second Reading debate on the Bill. After the public officers had spoken, the question on the Second Reading of the Bill was put and agreed to (details of division in **Appendix 2**). The Bill was read the second time and committed to a committee of the whole Council.

The Council became committee of the whole Council and considered the Bill. In accordance with Rule 68 of the Rules of Procedure, the committee first considered the Schedule to the Bill. The question that the sums for 42 heads with no amendment as set out in the Official Record of Proceedings stand part of the Schedule was proposed. The committee proceeded to the first session in which a joint debate on the 42 heads was held. Members spoke in the debate.

The Council resumed. The President declared that the next Council meeting would be held on 6 May 2020 at 11:00 am.
