## Consideration by committee of the whole Council

Appropriation Bill 2020 : Financial Secretary

The Council became committee of the whole Council to continue the consideration of the Schedule to the Bill. The committee continued the debate under the first session on the sums for the 42 heads with no amendment standing part of the Schedule. After Members and a public officer had spoken, the question that the sums for the 42 heads stand part of the Schedule was put and agreed to (details of division in **Appendix 2**).

The committee proceeded to the second session to deal with the remaining 42 heads with amendments. The question that the sums for 42 heads with amendments stand part of the Schedule was proposed. A joint debate on the 52 amendments to these 42 heads and the sums for such heads standing part of the Schedule was held. The amendments, which were proposed by 16 Members, sought to reduce various sums for these heads. Members spoke in the debate.
