#### **Attendance**

Hon Tanya CHAN, Hon Dennis KWOK and Hon CHAN Chi-chuen respectively rose to seek the President's permission for them to each move an adjournment motion under RoP 16(2). After consideration, the President did not accede to their requests and explained his decision to the Council.

## Government Bill

### Second Reading (debate to resume)

— National Anthem Bill : Secretary for Constitutional and Mainland Affairs

The Second Reading debate on the Bill resumed. Members spoke in the debate.

Hon Kenneth LEUNG spoke in the debate and moved a motion under RoP 40(1) that the debate be now adjourned. The question on the motion was proposed. After Members had spoken, the question on the motion was put and not agreed to (details of division in **Appendix 2**).

As the motion moved under RoP 40(1) was negatived, the Council continued the Second Reading debate on the Bill. After Members and the public officer had spoken, the question on the Second Reading of the Bill was put and agreed to. The Bill was read the second time.

### **Next meeting**

The President declared that the next Council meeting would be held on 3 June 2020 at 11:00 am.

The Council was adjourned at 6:50 pm on 28 May 2020.
