Reply:

As at 31 March 2020, the Hong Kong Economic and Trade Office (ETO) in Wuhan received 2 611 requests for assistance relating to the COVID-19 outbreak. A breakdown by month is set out in the table below:

Month	Number of requests for assistance	
January 2020 (first case received on 23 January)	755	
February 2020	1 532	
March 2020	324	

The above cases mainly involved assistance seekers who were stranded in Hubei Province due to transport condition. Some of them, especially those with chronic illnesses, needed medications provided in Hong Kong while others indicated that they lacked supplies like personal protective equipment and powdered milk. The Wuhan ETO had provided practical assistance and support to the assistance seekers having regard to the actual

circumstances, including making arrangements to deliver medications to the Hong Kong residents in Hubei Province who were in need.

2. The 5 Mainland Offices of the Government of the Hong Kong Special Administrative Region (namely the Beijing Office and ETOs in Guangdong, Shanghai, Chengdu and Wuhan) have stayed committed to their duties, remained vigilant and closely monitored the development of the epidemic situation in their service areas, and maintained close liaison with this Bureau and other relevant departments. They have also uploaded on their websites and WeChat official accounts relevant health information and the latest information on anti-epidemic measures in Hong Kong to provide Hong Kong residents in the Mainland with easy access to all relevant information.
