Reply:

The Independent Checking Unit (ICU) works directly under the Office of the Permanent Secretary for Transport and Housing (Housing). Under the delegated authority from the Building Authority (i.e. the Director of Buildings), ICU exercises statutory building control to properties developed by the Hong Kong Housing Authority that have been sold or divested, in accordance with the Buildings Ordinance and the policies and guidelines of the Building Authority.

1. As at the end of December 2019, the number of buildings with statutory notices issued by ICU under the Mandatory Building Inspection Scheme (MBIS) in the past 5 years (i.e. from 2015 to 2019) and the number of buildings with their statutory notices discharged are tabulated below:

Regarding the number of buildings with statutory notices issued under the scheme for more than 3 years but not yet discharged, ICU does not maintain any yearly statistics. Nevertheless, as at end of December 2019, for the MBIS notices issued in 2016 and before, as the owners / Incorporated Owners of some buildings have been granted with extension of time for discharging the notices according to their individual situations, out of the two districts mentioned above, there are 11 no. of buildings in Kwun Tong district with statutory notices not yet discharged within the specified time. ICU has issued / will issue reminder letters and warnings letters under established procedures to require the building owners to discharge the notices immediately. If the notices are still not discharged, ICU will instigate prosecution actions in due course.

2. As at the end of December 2019, the number of flats with statutory notices issued by ICU under the Mandatory Window Inspection Scheme (MWIS) in the past 5 years (i.e. from 2015 to 2019) and the number of flats with their statutory notices discharged are tabulated below:
