9. Updating of the Standardised Care Need Assessment Mechanism for Elderly Services

Hon SHIU Ka-chun, Dr Hon Fernando To be confirmed CHEUNG and Hon Andrew WAN suggested in the 2018-2019 session that the item should be discussed and deputations should be invited to give their views.

Hon KWONG Chun-yu suggested that the Panel should hold a joint meeting with the ED Panel to discuss the allocation of funding for increasing the number of school social workers to two per secondary school as announced in the 2019-2020 Budget, and representatives from EDB should be invited to attend the meeting.

20. Mental health of children and adolescents and related community support services

Given that mental health of children and To be confirmed adolescents is a key area of discussion of the Committee Advisory on Mental Health. Dr Hon KWOK Ka-ki suggested in the 2017-2018 session that a joint meeting with the Panel on Health Services ("HS Panel") and the ED Panel should be held to discuss issues relating to mental health and related community support services and the work progress of the Advisory Committee. A joint meeting with the HS Panel and the ED Panel was held on 20 December 2017 to discuss "Mental health of adolescents" which covered, inter alia, youth suicides. The Panel and the HS Panel also discussed "Mental health of children and adolescents" at a joint meeting on 23 April 2018.

Hon KWONG Chun-yu and Hon SHIU Ka-chun suggested in the 2018-2019 session that service arrangements for Integrated Community Centres for Mental Wellness arising from extension of the scope of their service to cover all secondary school students should also be discussed under this item.

21. Provision of cyber youth support services for reaching out to at-risk and hidden youths through the Internet

22. Mandatory reporting mechanism for and prevention of child abuse

The Panel discussed Dr Hon Fernando CHEUNG's proposed Member's bill to amend PCJO and the Juvenile Offenders Ordinance (Cap. 226) and the proposal of establishing a statutory reporting mechanism for child abuse at its meeting on 9 December 2019.

Hon Elizabeth QUAT suggested via her letter dated 12 November 2020 (LC Paper No. CB(2)316/20-21(01)) that the Panel should

discuss "Prevention of child abuse".
