I. Information paper(s) issued since the last meeting

[LC Paper Nos. CB(2)1011/2023(01) and CB(2)1019/2023(01)]

Members noted that the following papers had been issued after the last meeting:

- (a) Administration's response to the letter dated 27 September 2023 from Hon MA Fung-kwok [LC Paper No. CB(2)1011/2023(01)]; and
- (b) Joint letter dated 10 November 2023 from Hon Elizabeth QUAT and Hon CHAN Yung [LC Paper No. CB(2)1019/2023(01) (Chinese version only)].
- 2. Regarding the paper referred to in paragraph 1(a) above, Mr MA Fung-kwok noted that the Administration had engaged an independent consultant to assist in reviewing the financial position of the West Kowloon Cultural District Authority ("WKCDA"), and expressed concerns about when the Administration would report to the Panel on this matter. The Chairman advised that he had conveyed to the Administration a number of times members' concerns about the West Kowloon Cultural District ("WKCD").

II. Items for discussion at the next meeting

[LC Paper Nos. CB(2)985/2023(01) and (02)]

3. The Chairman advised that the next regular meeting of the Panel would be held on Monday, 11 December 2023, at 4:30 pm to discuss "Community Care Fund" proposed by the Administration. As for another agenda item of the same meeting, the Chairman proposed to discuss "setting up two museums

about our country and the War of Resistance", and members raised no objection to the proposal.

III. Briefing by the Secretary for Home and Youth Affairs and the Secretary for Culture, Sports and Tourism on the Chief Executive's 2023 Policy Address

[LC Paper Nos. CB(2)985/2023(03) and (04)]

4. At the invitation of the Chairman, the Secretary for Home and Youth Affairs ("SHYA") and the Secretary for Culture, Sports and Tourism ("SCST") briefed members on the salient points of the Administration's papers [LC Paper Nos. CB(2)985/2023(03) and (04)] respectively.

(<u>Post-meeting note</u>: The press releases containing the speaking notes of SHYA and SCST respectively were issued vide LC Paper Nos. CB(2)1027/2023(01) and (02) on 14 November 2023.)

Declaration of interests

5. Mr Rock CHEN declared that he was a Life Honorary Chairman of the United Zhejiang Residents Associations (H.K.).

Development of arts and cultural industries

Setting up two museums about our country and the War of Resistance

- 6. Members generally supported the Administration's proposal to set up two museums about our country and the War of Resistance. However, some members were concerned that the existing exhibitions of coastal defence staged in the Hong Kong Museum of Coastal Defence ("HKMCD") mainly focused on introducing information about how the British Hong Kong Government protected the property and interests of the British people against pirates in the early years which was not in line with the purposes of patriotic education. They suggested that the proposed Hong Kong Museum of the War of Resistance and Coastal Defence should focus on introducing the history of the War of Resistance.
- 7. In response, the Administration said that, after the re-opening of HKMCD in 2022, additional efforts had been made to hold more exhibitions covering the Japanese Invasion of China, the Japanese Invasion of Hong Kong, the Battle of Hong Kong, the Hong Kong and Kowloon Independent Brigade of the East River Column, and so on, to deepen public understanding of the

history of that period. The Administration added that its current plan was to re-position HKMCD with a main focus on the history of the War of Resistance, while retaining the "coastal defence" element with a view to showing the geographical location of HKMCD and the pertaining coastal defence history.

- 8. To instil in members of the public the correct historical perspective, members suggested that the Administration should engage experts to conduct a rigorous review of the historical information to be exhibited by the two proposed museums. They also suggested that the Administration might enlist the assistance of the relevant Mainland authorities in acquiring accurate historical information. In response, the Administration advised that it would consider on a regular basis the recommendations relating to collection acquisition and programme selection of the museums concerned, and the relevant museum expert advisers would be consulted where necessary. Noting members' concerns about the inaccurate historical perspective presented in the "Recreating a Classic: The Best Features of The Hong Kong Story" exhibition organized by the Hong Kong Museum of History earlier, the Administration explained that the exhibition had been concluded although there might be inadequacies resulting from the tight timeframe within which contents of previous exhibitions were extracted and re-presented in the exhibition.
- 9. In response to members' enquiries, the Administration advised that the thematic exhibitions organized in collaboration with the Shenzhen Municipal Cultural Relics Bureau would introduce the joint efforts made by Hong Kong and Shenzhen during the War of Resistance, as well as the stories of the East River Column, with a view to showcasing the history of the War of Resistance in a more comprehensive manner. The Administration also advised that detailed consideration would be given to members' suggestions of collaborating with various places in the Guangdong Province area, such as Humen and Nansha, to organize activities to showcase the history of national coastal defence.

Arts and cultural development in Hong Kong and the related facilities

10. Members pointed out that some members of the arts and cultural sector were concerned about the implementation of the Hong Kong National Security Law which had created an atmosphere affecting the arts and cultural development in Hong Kong as well as retention of the relevant talents, they enquired about how the Administration would allay the sector's concerns. In response, the Administration advised that such concern was unnecessary. The Administration pointed out that it was the responsibility of every citizen to safeguard national security and, on the premise of safeguarding national security, there was still plenty of room for creation. Taking the First Feature

Film Initiative ("FFFI") as an example, the latest edition of FFFI received a record high number of applications.

- 11. Given that construction of the Kai Tak Sports Park ("KTSP") would be completed at the end of next year, members suggested that the Administration should reserve sufficient timeslots in the venues of KTSP to facilitate the organization of large-scale cultural and entertainment events by the industry. In response, the Administration said that, as stipulated in the contract, the contracted party was required to host sports events on a given number of days in a year. If no sports event or competition was scheduled to be held, the Main Stadium could be used for non-sports purposes, such as concerts, exhibitions and religious activities.
- 12. Members were concerned that the existing ancillary transport facilities for WKCD could not meet the needs of the public and tourists, and suggested that the Administration should provide more fare-charging public transport options for travelling to and from WKCD. The Administration advised that it would continue to discuss with WKCDA and the Transport Department to identify an appropriate solution to the issue. In response to members' concerns about the cultural facilities in the Northern Metropolis, the Administration advised that a blue and green recreation, tourism and conservation circle promoting recreation and tourism development would be provided in the Northern Metropolis.

Organizing the Chinese Culture Festival

13. Given that the Administration had plans to organize the Chinese Culture Festival on a regular basis from 2024 onwards, members suggested that the Administration should formulate a specific theme for each Chinese Cultural Festival and assist the industry in the preparation of large-scale performances or exhibitions. The Administration responded that the theme of the Chinese Cultural Festival next year would be announced in due course.

Establishing Sha Tau Kok Cultural Tourism Zone

14. Regarding the initiative proposed in the 2023 Policy Address to establish the Sha Tau Kok Cultural Tourism Zone, members suggested that the Administration should set up an inter-departmental task force to explore with the Shenzhen Municipal Government the feasibility of developing a cultural tourism zone in Sha Tau Kok on the Hong Kong side and Shatoujiao on the Shenzhen side, including exploring arrangements to facilitate access to the cultural tourism zone by visitors of both sides. The Administration advised that, starting from early next year, it would gradually open up the Sha Tau Kok

Frontier Closed Area (excluding Chung Ying Street). In the initial stage, visitors could apply online for Closed Area Permits to enter Sha Tau Kok for sightseeing. This would promote cultural and eco-tourism of Sha Tau Kok and nearby outlying islands. The Culture, Sports and Tourism Bureau would continue to discuss the above matters with the relevant policy bureaux and the Shenzhen authorities.

Sports development

Supporting the development of individual sports

- 15. Members advised that the amount of resources allocated to individual sports was often linked to the performance of athletes in international sports events. In this connection, members asked how the Administration would promote certain sports with development potential and wide popularity which had not yet achieved outstanding performances in international competitions. The Administration responded that the Commissioner for Sports was considering how to provide funding support for sports with development potential. Members also suggested that the Five-Year Development Programme for Team Sports ("the Development Programme"), which was implemented in 2018, should be reviewed in a timely manner to help enhance the performance of team sports gradually, thereby allowing more opportunities for team sports to achieve elite sports status in the future. The Administration advised that the effectiveness of the Development Programme was under review, and announcement would be made in due course.
- 16. Members urged the Administration to expeditiously implement its plan to provide a swimming pool capable of hosting international competitions and a sports centre with fencing training and competition facilities, so as to further promote and raise the standard of swimming and fencing. In response, the Administration advised that it was identifying suitable locations, while exploring the possibility of providing the above facilities by way of conversion of the existing facilities. Members were pleased to note that the Administration had plans to enhance support for elite athletes in sports medicine, and suggested that more training for talents in sports-related industries should be provided through the Hong Kong Sports Institute.

Preparatory work for the National Games

17. As regards the National Games ("NG") to be co-hosted by Hong Kong in 2025, members were concerned about the progress of the related preparatory work and the arrangements for recruiting volunteers. In response, the Administration advised that the sports competitions proposed to be held in

Hong Kong were pending approval from the General Administration of Sport of China. Volunteers would be recruited and trained in the future to facilitate the holding of NG. The Administration added that it had recently arranged for representatives to conduct a visit to Guangxi in relation to the National Student (Youth) Games to understand the arrangements for volunteers and their job specifications.

Major sports events and co-organizing sports competitions with Mainland cities

- 18. Noting that the FIA World Rallycross Championship Hong Kong, China—Season Finale 2023, which was held on 11 and 12 November this year, experienced problems of shortened schedule and racing track, members were concerned about the role played by the Administration in monitoring the event and whether the event organizer would be asked to return part of the funds provided under the "M" Mark System and Support Package as a result of the aforesaid problems. The Administration explained that the decision to change the track and revise the schedule was made after a joint discussion between the international event organizer and its Hong Kong counterpart. Besides, this was the first race held on existing roads, instead of at a specific venue. The Administration added that if similar events were to be hosted again in the future, it would step up communication with the event organizer to avoid recurrence of the above situation.
- 19. It was pointed out that the event organizer of the Shenzhen—Hong Kong youth Muay Thai friendly match, which was held at the end of July this year, had asked for assistance in terms of resources and manpower from the Administration in organizing the friendly match via a member's letter to the Administration. However, the Administration did not reply. The Administration advised that it would look into the matter in detail and give an account of it to the member concerned. The Administration added that, for future cross-boundary competition events, appropriate support in terms of resources and manpower would be provided as far as possible if requests were received.

Admin

Youth development

Youth entrepreneurship

20. Members advised that the epidemic broke out soon after the launch of the Funding Scheme for Youth Entrepreneurship in the Guangdong-Hong Kong-Macao Greater Bay Area ("GBA") ("the Entrepreneurship Scheme") under the Youth Development Fund in 2019. As a result, quite a

number of Hong Kong young people encountered difficulties in returning to GBA to implement their business start-up plans. In this connection, members enquired whether the Administration would consider extending the term of the youth entrepreneurship projects implemented by subsidized organizations, so as to facilitate more young people to start their own businesses in the Mainland cities of GBA through the Entrepreneurship Scheme following the resumption of normalcy. The Administration responded that it had received applications for extension of certain projects, and some applications had been approved upon review.

21. Members suggested that, apart from providing one-stop information for youth entrepreneurs in GBA, the Alliance of Hong Kong Youth Innovation and Entrepreneurial Bases in the GBA ("the Alliance") should also assist them in establishing their businesses in the Mainland cities of GBA. The Administration advised that the Alliance would pool the resources of its members to provide support to young entrepreneurs through various activities, including assisting them in developing their interpersonal and business networks and so on, with a view to enhancing their competitiveness.

Youth Link

- 22. Members expressed concern about the key performance indicators set by the Administration for the newly established Youth Link and how it would attract young people to participate in the Youth Link. The Administration advised that the Youth Link was launched to link up participants of various government youth programmes. The Administration would offer them opportunities to develop diverse talents through participating in seminars, different types of large-scale government activities, exchange visits to the Mainland and overseas, etc., and strengthen their communication, interaction and trust with the Government. The Administration's goal was to organize or provide at least 10 youth development activities for Youth Link members by the end of 2024.
- 23. Members suggested that the Administration should make use of mobile phone SMS messages to disseminate activity information to Youth Link members so as to facilitate their receipt of information. In response, the Administration advised that the Home and Youth Affairs Bureau was developing a youth-based mobile application targeted to be launched in the first quarter of next year. The mobile application would disseminate diversified information on various youth development programmes. The Administration would also maintain communication with young people through various online media and platforms.

Community building

Promotion of clansmen culture

24. Members welcomed the Administration's proposal to launch the "Clansmen Culture Promotion Scheme" in the first quarter of 2024 for three years, and suggested that the Administration should organize briefing sessions on the procedures for making funding applications for officers working for the secretariats of clansmen associations, and deploy staff to answer enquiries from applicants. Also, members suggested that the Administration should impose the requirement for matching funds on the clansmen associations applying for funding support, and encourage various clansmen associations to collaborate in organizing activities, with a view to making more effective use of the funds allocated. In response, the Administration said that it would arrange briefing sessions to assist clansmen associations in understanding the details of the relevant schemes, and clansmen associations were welcome to apply for funding support to organize activities in different formats.

Promoting youth participation in community building

25. Members expressed support for the Administration's initiative to invite each District Youth Community Building Committee to propose a distinctive photo-taking landmark for their district, as they considered that such an initiative would strengthen young people's sense of belonging to their districts. Members suggested that the Administration might consider inviting the tourism industry to participate in the above activities to promote the photo-taking landmarks from the tourism perspective and deepen young people's understanding of the operation of the tourism industry. The Administration advised that it welcomed the active cooperation of the tourism industry in designing the itineraries for visiting the photo-taking landmarks in 18 districts, and promoting and publicizing the results of young people's efforts in setting up the photo-taking landmarks in various districts of Hong Kong to visitors from the Mainland and overseas places through social media, and so on.

District Services and Community Care Teams

26. Given that the District Services and Community Care Teams ("the Care Teams") would assist the Administration in identifying persons in need of assistance (e.g. elderly singletons, families of elderly doubletons and single-parent families) and referring persons with mental health needs to seek appropriate assistance, members suggested that the Administration should provide suitable training for members of the Care Teams and volunteers. The Administration agreed with members' views, and pointed out that the services

of the Care Teams could not replace the services provided by professional departments, but members of the Care Teams, upon receiving the relevant training, might assist colleagues in professional departments, such as outreaching social workers and community nurses, in providing support at the district level, with a view to widening the coverage of the relevant services.

27. In response to members' enquiries, the Administration advised that the Care Teams were being arranged one after another to use the offices vacated following the dissolution of Mutual Aid Committees. Members were also concerned about how the Care Teams would support ethnic minorities ("EMs") to enable them to integrate into the community. In response, the Administration advised that, on top of the existing eight support services centres for EMs ("EM centres"), it had plans to set up one EM centre each in Kowloon Central and New Territories East respectively. It would also invite the 10 EM centres to set up an EM Care Team in each centre to visit EM households to understand their needs, introduce to them the public services they need, and assist in referring their cases to relevant departments or organizations for the arrangement of professional services.

Women's development and facilitating building management

- 28. Members were concerned about how the Administration would promote women's development through the setting up of the Women Affairs Team and the designation of the post of Commissioner for Women Affairs. Members urged the Administration to proactively reach out to grass-roots women and assist "hidden women" in reintegrating into the community. The Administration advised that the establishment of the Women Affairs Team and the designation of the post of Commissioner for Women Affairs demonstrated the Government's determination to promote women's development. Such initiatives might also strengthen cross-bureau collaboration, thereby enabling more effective implementation of the relevant policy initiatives in addressing problems. The Administration added that it would organize the first Family and Women Development Summit to create an atmosphere of concern for women's development and collect views on different issues from those who were engaged in the work of supporting women.
- 29. Members noted that the Administration would introduce an amendment bill to amend the Building Management Ordinance (Cap. 344) within the current legislative session. In response to members' concern about the management of "three-nil buildings", the Administration advised that it would continue to provide a range of free building management support services, including inviting district organizations or non-governmental organizations ("NGOs") to reach out to "three-nil buildings" to encourage and assist them in

forming owners' corporations under the Building Management Professional Advisory Service Scheme. In addition, consideration would be given to entering into contracts of longer terms with local organizations or NGOs to ensure the continuity of the work.

Others

- 30. Members welcomed the Administration's initiatives to restructure the existing Create Hong Kong as the Cultural and Creative Industries Development Agency ("the Development Agency") and expand the establishment of the Development Agency, so as to recruit industry practitioners and promote the arts, culture and creative sectors as industries. Members were concerned about the long-term goal of setting up the Development Agency, and suggested that the Development Agency should draw reference from the Korea Creative Content Agency ("KOCCA") and play a more proactive role in promoting the development of arts, culture and creative sectors as industries. In response, the Administration advised that it was inappropriate to make comparisons between the Development Agency and KOCCA, whether in terms of the scale or amounts of capital injection. However, under the industry-oriented principle, the newly-restructured Development Agency would take the initiative to identify opportunities outside Hong Kong for the relevant sectors, and proactively lead groups of the industries to different parts of the world for exhibitions and showcases, with a view to exporting Hong Kong's cultural and creative industries and exploring business opportunities for them. The Development Agency would also conduct in-depth research and disseminate industry news on topics of cultural and creative industries in and outside Hong Kong.
- Members noted that the Administration proposed to inject around 31. \$1.4 billion into the Film Development Fund ("FDF"), in which \$840 million would be earmarked for enhancing Hong Kong film productions, including launching the Film Financing Scheme for Mainland Market and the Hong Kong-Europe-Asian Film Collaboration Funding Scheme under FDF. Members suggested that the Administration should collaborate with the Mainland enterprises for matching funds through the Film Financing Scheme for Mainland Market, with a view to providing funding support for more The Administration pointed out that the Film sizeable film productions Financing Scheme for Mainland Market aimed to help boost the chance of Hong Kong films for release in the Mainland market and nurture more local directors to enter the Mainland film market; the production budget of the film projects eligible for funding support under the above schemes had to be between \$25 million and \$150 million. The Hong Kong-Europe-Asian Film Collaboration Funding Scheme aimed to help Hong Kong filmmakers broaden

their regional cultural horizons, draw inspiration from film productions of other countries and have a better understanding of the market demands of other countries, thereby enabling Hong Kong films to go global.

IV. Any other business

32. There being no other business, the meeting ended at 6:23 pm.
